New York Technologies Corporation 401(k) Profit Sharing Plan and Trust ("the Plan") is filing a delinquent Form 5500-SF under the DFVCP. New York Technologies Corporation's ("the Sponsor's") prior accounting firm provided third-party administration services. The Sponsor changed accounting firms during 2020. The new accounting firm failed to communicate to the Sponsor that they would not be responsible for third-party administration services. The prior accounting firm failed to properly disengage the Sponsor for their third-party administration services. After becoming aware of the missed filing, the Sponsor immediately engaged a firm providing third-party administration services to assist in the preparation of the delinquent filing (2021 Form 5500-SF).
