INDEPENDENT AUDITORS' REPORT

To the Governing Board, Plan Administrator and Management of
Piedmont Driving Club Profit Sharing Plan

Opinion on the 2023 Financial Statements

We have audited the accompanying financial statements of Piedmont Driving Club Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of February 1, 2023 (Date of Merger), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to February 1, 2023 (Date of Merger), and the related notes to the financial statements.

In our opinion, the financial statement referred to above present fairly, in all material respects, the net assets available for benefits of Piedmont Driving Club Profit Sharing Plan as of February 1, 2023, and the changes in its net assets available for benefits for the period then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the 2023 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2023 Financial Statements section of our report. We are required to be independent of Piedmont Driving Club Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the 2023 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Piedmont Driving Club Profit Sharing Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN

The following description of the Piedmont Driving Club Profit Sharing Plan (the Plan) provides only general information. Refer to the Plan documents for a more complete description of Plan provisions.

General

The Plan was a defined contribution plan covering all full-time employees of the Piedmont Driving Club (the Club) who have completed one year of service. The Plan was subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The members of the governing board were responsible for oversight of the Plan. The Plan's Investment Committee (Investment Committee) determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan's governing board.

Some administrative functions were performed by officers or employees of the Club. No compensation was remitted to the Club for these services. The majority of all of the investment and administrative expenses for the Plan were paid from the Plan assets.

Plan assets were held and managed by Charles Schwab Trust Bank (Schwab), the trustee and qualified institution for the Plan. Schwab invested contributions and Plan earnings, made investment transactions as directed by the Club and Gwynn Management, which provided investment management services for the Plan (Note 7). FuturePlan, acted as the third-party administrator for the Plan, performed certain plan administration and annual ERISA compliance testing and the preparation of the Form 5500.

Effective February 1, 2023, the Plan was amended to officially merge into the Club Management Association of America, Inc. Club Retirement Plan and thereby terminating the Plan. In preparation for this merger, all investments were liquidated to cash prior to the merger.

Eligibility

Employees were able to become participants of the Plan when they reached one year of service, were employed on the last day of the plan year, and were age eighteen or older.

Contributions

The Club could contribute a discretionary amount allocated proportionally to each participant's account. Participants were grouped into allocation groups based on their positions within the Club (currently, Chief Executive Officer, Chief Financial Officer, Management Employees and Staff Employees). The contributions were allocated to eligible participants in their respective allocation group proportionally based on the ratio that an eligible participant's compensation bears to the total of all eligible participants' compensation in each group. Participants were able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions were invested in various mutual funds at the discretion of an investment management company. For the period ended February 1, 2023, the Club did not make a profit sharing contribution to the Plan.

Piedmont Driving Club Profit Sharing Plan Notes to Financial Statements

Note 1: DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account was credited with the participant's rollover contributions and Club's matching contributions, as well as allocations of the Club's contribution and Plan earnings. Participant accounts were charged with an allocation of Plan losses and administrative expenses that were paid by the Plan. Allocations of earnings, losses, and administrative expenses were based on account balances, as defined by the Plan. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Vesting

Vesting in the Club's contributions was based on years of continuous service. Participants in the Plan vested in employer contributions and Plan earnings as follows:

Benefit Payments

On termination of service due to death, disability, retirement or April 1 in the calendar year in which a participant obtained the age of 70½, a participant (or beneficiary of the participant) could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annuity installments over a specified period of time. Vested accounts not exceeding \$1,000 were paid in a mandatory lump-sum distribution, as soon as administratively feasible, if termination of service was due to reasons other than death.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts were divided among the allocation groups in the same proportion of the employer's contribution. The forfeited balances were then allocated to each remaining participant within the allocation group based on the same proportion for contributions. For the period ended February 1, 2023, there were no forfeitures. At February 1, 2023 and December 31, 2022, net assets available for benefits included no unallocated forfeitures.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold, as well as investments held during the year.

Payment of Benefits

Distributions to participants were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to investment management were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, July 24, 2023. See Note 9 for relevant disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: TRANSFER TO CLUB MANAGEMENT ASSOCIATION OF AMERICA

Effective February 1, 2023, the Plan officially merged into the Club Retirement Plan. As a result of the merger, all remaining assets and liabilities were transferred to this Plan.

Note 4: INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by the qualified institution:

- a) Total investments, at fair value, included in the statement of net assets available for benefits at December 31, 2022.
- b) Investment income information included in the statement of changes in net assets available for benefits for the year ended December 31, 2022.
- c) All amounts included in Note 5, *Fair Value Measurements*.

Note 5: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 5: FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at February 1, 2023 and December 31, 2022.

Money market and mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believe its valuation methods are appropriate and consistent with other market participants, the use of different methodologies could result in a different fair value measurement at the reporting date.

There were no investments at fair value as of February 1, 2023.

Note 6: TAX STATUS

The IRS has determined and informed the Club by a letter dated May 16, 2011, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were in shares of a money market fund managed by Charles Schwab Trust Bank, the Trustee; therefore, these transactions qualify as party-in-interest transactions.

The Plan's investment manager at Gwynn Management Company is a member of the Club. There were no fees paid to Gwynn Management Company for the period ended February 1, 2023.

Note 8: PLAN TERMINATION

The Club has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Effective February 1, 2023, the Plan was amended to officially merge into the Club Management Association of America, Inc. Club Retirement Plan.

Note 9: SUBSEQUENT EVENTS

Management of the Plan evaluated all events or transactions that occurred after February 1, 2023 through July 24, 2023, the date the Plan's financial statements were available to be issued. The following items occurred:

All assets of the Plan officially were transferred to the Club Retirement Plan effective February 28, 2023.


