Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Schroer Manufacturing Company 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Responsibilities of Management for the Financial Statements

Note 1 – Description of the Plan

The Associated Benefits Corporation Thrift Plan, Participating Employer-Schroer Manufacturing Company, Group 803 (the "Plan"), is a defined contribution plan administered by Associated Benefits Corporation (the "Plan Administrator"). The following description of the Plan is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's information.

A. General

The Plan is a defined contribution plan available to all full-time employees of the participating employer who have attained age 18 and completed four months of service. Wells Fargo Bank, N.A. serves as trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During the year ended December 31, 2021, Schroer Manufacturing Company was acquired by Midmark Corporation. Prior to the acquisition date, Schroer Manufacturing Company was the Plan sponsor. Effective on the acquisition date, Midmark Corporation became the sponsor of the Plan.

The Plan was frozen on December 31, 2021. On March 28, 2022 (Plan Merger Date), the Plan was merged with and into the Midmark Corporation 401(k) Savings Plan.

B. Contributions

Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company; and (iii) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the plan.

Participants may elect to contribute a percentage of their compensation, excluding bonuses and commissions, to the Plan each year subject to the limitations, as defined in the plan document. Such contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The participating employer matches 40% of the employee contributions not to exceed 5% of the participant's compensation. Additional amounts may be contributed at the discretion of the participating employer's board of directors. For the period ended April 30, 2022, the participating employer made no additional discretionary contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

C. *Participant accounts*

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's and employer contributions and an allocation of Plan earnings and charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. *Investments*

Participants may direct the investment of their and employer contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. As of April 30, 2022, all Plan assets were transferred to the Midmark Corporation 401(k) Savings Plan.

E. *Vesting*

Participants are immediately vested in their contributions, plus earnings (losses) thereon and vested in employer contributions, plus actual earnings (losses) thereon at the rate of 20% after completion of two years of service and 20% for each year of service thereafter. Participants become fully vested after six years of service.

F. *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. The loans are secured by an assignment of a participant's vested interest in the Plan, and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from 1 to 4.5 years; however, terms may extend to 15 years for the purchase of a primary residence. Outstanding loans at the time of merger were transferred to the Midmark Corporation 401(k) Savings Plan in 2022.

G. *Payment of Benefits*

On termination of service (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump sum amount equal to the value of his or her vested account, or installment payments over various periods as elected by the participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

H. *Forfeited accounts*

At December 31, 2021, forfeited nonvested accounts totaled \$4,361. These accounts were used to pay plan administrative expenses. During 2022, there were no forfeitures used for plan expenses. The remaining accumulated forfeitures of \$4,222 were transferred to the Midmark Corporation 401(k) Savings Plan in 2022.

Note 2 – Summary of Significant Accounting Policies

A. *Basis of Accounting*

The accompanying financial statements have been prepared on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Under the modified cash basis of accounting, transactions are recorded in the financial statements on the cash receipts and disbursement basis; however, investments are adjusted to fair value. Accordingly, these statements are not intended to present the Plan's financial position or changes in financial position in conformity with GAAP. The principal differences in the Plan's statements relate to investment income and contributions which are not recorded until received.

B. *Use of Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting, which is a basis of accounting other than GAAP, requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities.

C. *Risks and Uncertainties*

The Plan utilizes various investment securities, including mutual funds and a money market fund. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

D. *Investment Valuation and Income Recognition*

Investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income are recorded as received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

E. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

F. *Administrative Expenses*

Administrative expenses of the Plan are paid by the Plan as provided in the Plan document.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

G. *Payment of Benefits*

Benefit payments to participants are recorded upon distribution. As of April 30, 2022 and December 31, 2021, there were no participants who elected to withdraw from the Plan but had not yet been paid.

H. *Termination*

The plan sponsor may terminate the Plan in accordance with ERISA and the Code. In the event that the Plan is terminated, the Plan Administrator can direct that all accounts be distributed to the participant or continued in trust for his or her benefit.

I. *Subsequent Events*

Subsequent events have been evaluated through August 11, 2023, the date the financial statements were available to be issued.

Note 3 – Information Certified by the Trustee

The following is a summary of the unaudited information regarding the Plan that was prepared by Ascensus Trust Company, the Custodian of the Plan. The Plan Administrator obtained certifications from the Custodian that such information is complete and accurate.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2022 and December 31, 2021.

Mutual Funds-Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively trade.

Money Market Funds-Held primarily in short-term money market commingled funds, which are valued at cost plus accrued interest.

Stable Value Account: A stable value fund is composed primarily of fully benefit responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following table presents the fair value measurements of assets and liabilities recognized in the accompanying statements of net assets available for benefits measured at fair value on a recurring basis and the level within the ASC 820 fair value hierarchy in which the fair value measurements fall at December 31, 2021. Plan investments fair value at April 30, 2022 was zero as a result of the Plan merger.

Note 5 – Related Party and Party In Interest Transactions

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. With respect to the Plan's investment in mutual funds, the mutual fund company is considered to be a service provider to the Plan, and as such, is considered a party-in-interest. Fees incurred by the plan for the investment management, recordkeeping and audit services are charged to the plan participants on a pro rata basis. The Plan Sponsor pays directly any other fees related to the plan's operations. Certain fees of administering the Plan are paid to the Trustee by the Plan. These transactions qualify as exempt party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 6 – Federal Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the participating employer and the Plan Administrator by a letter dated September 28, 2017, that the Plan and related trust are designed in accordance with applicable regulations of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the participating employer and the Plan Administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
