### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2021 Financial Statements**

We have performed an audit of the accompanying financial statements of **Vets United, LLC 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 31, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the year then ended (in liquidation), and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **Vets United, LLC 401(k) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2022 and December 31, 2021, and for the ten months ended October 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Vets United, LLC 401(k) Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter**

As discussed in Note 6 to the financial statements, the governing body of Vets United, LLC 401(k) Plan approved a plan of liquidation on July 31, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **Vets United, LLC 401(k) Plan's** ability to continue as a going concern for one year after the date the financial statements are available to be issued. (See Note 6)

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

**NOTE 1**      **DESCRIPTION OF PLAN**

The following description of ***Vets United, LLC 401(k) Plan*** (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

**General**

Vets United, LLC (the "Company") is the Plan sponsor and Plan administrator. The Plan was adopted in 2017 with an effective date of November 1, 2017. The Plan is a defined contribution, tax-deferred profit sharing plan covering all employees of the Company who are age eighteen or older and have one year of service with the Company. Plan entry dates are twice a year on the January 1 or July 1 coincident with or following the date an employee meets eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees receiving compensation under a prevailing wage contract are immediately eligible to receive employer profit sharing contributions.

**Contributions**

For prevailing wage employees, the Company makes profit sharing contributions to the Plan based on a formula that accounts for the applicable prevailing wage determination for fringe benefits, the number of hours worked and employee fringe benefits provided.

For elective deferral contributions, after meeting age and service requirements, participants may contribute up to 100% of compensation, not to exceed the maximum salary deferral limit and other limitations established by law. Compensation is defined as Wages, Tips and Other Compensation, Box 1 on Form W-2, plus elective deferrals and contributions made to a qualified cafeteria plan.

Participants may elect deferral contributions as pre-tax or Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code (IRC). Participants also may make rollover contributions of distributions from other retirement plans and certain individual retirement accounts, subject to Plan provisions.

The Company has the option to make matching or profit sharing contributions to the Plan, although the Company is not required to do so. Any profit sharing contributions will be allocated to all eligible employees according to the allocation formula specified in the Plan. No matching or profit sharing contributions were made in 2022. Company contributions are invested according to participant investment elections.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and any Company contributions. Investment earnings, losses, and changes in market value are allocated based upon the investment experience of each holding in a participant account. Certain transactional costs and service charges, if any, are allocated to the specific accounts involved in the transaction or receiving the service. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are 100% vested immediately in their own salary deferral contributions, rollover contributions, prevailing wage contributions and earnings thereon. Participants vest in company matching contributions and profit sharing contributions and related earnings over a five year period, 20% for each year of credited service. Participants become 100% vested under certain other circumstances, including attainment of age 65, the Plan's normal retirement age. Non-vested balances are subject to forfeiture upon termination of employment.

**Investment Options**

Participant contributions are invested according to direction of the participants. The Plan offers multiple investment options for participants.

**Participant Loans**

Participant loans are not permitted.

**Payment of Benefits**

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, upon disability and at death. Hardship distributions are allowed under certain conditions. If the vested account balance exceeds \$5,000, terminated or retired participants may elect to take a distribution in the form of a lump-sum payment, rollover, or installments over a period of time to meet minimum distribution requirements, or remain in the Plan. Terminated or retired participants whose vested account balances do not exceed \$5,000 may receive benefits in the form of a single lump sum payment. For accounts that do not exceed \$5,000, the benefit may be automatically distributed at the Plan's discretion.

**NOTE 2**      **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles general accepted in the United States of America.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. The Plan allows certain administrative expenses to be paid from Plan assets. Per-use transaction fees are charged directly to specific participant accounts for certain services, such as processing distributions, and are included in administrative expenses of the Plan. Investment related expenses are included in net appreciation of fair value of investments.

**Federal Income Tax Status**

The Internal Revenue Service has determined and reported in its opinion letter dated March 31, 2014, that the form of adopted prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

**Federal Income Tax Status** (Continued)

Federal tax returns are subject to audit by taxing authorities, generally for three years after filing; hence the Plan's tax returns for the year 2019 and onward remain open to examination.

**NOTE 3**      **FAIR VALUE MEASUREMENTS**

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in changes in net assets available for benefits for the ten months ended December 31, 2022, are reported in net appreciation in fair value of investments.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The three levels of the fair value hierarchy under reporting and accounting standards are described as follows:

*Level 1 Fair Value Measurements:* Fair values are based on unadjusted quoted prices for identical assets or liabilities in active markets. Active markets are defined as a market in which transactions take place with sufficient frequency and volume to provide pricing information on an ongoing basis.

*Level 2 Fair Value Measurements:* Fair values are based on inputs other than quoted price included within level 1 that are observable for valuing the asset or liability, either directly or indirectly (i.e. interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Level 2 inputs include quoted price for similar assets or liabilities in active or non-active markets, inputs other than quoted market prices that are observable and inputs that are derived principally from or corroborated by observable market data through correlation or other means.

*Level 3 Fair Value Measurements:* Fair values are based on price or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These valuations, whether derived internally or obtained from a third party, use critical assumptions that are not widely available to estimate market participant expectations in valuing the asset or liability.

**NOTE 3**      **FAIR VALUE MEASUREMENTS** (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and December 31, 2021.

*Pooled Separate Accounts:* The pooled separate accounts (PSAs) invest mainly in domestic stocks, the majority of which have observable Level 1 inputs. While the underlying asset values are quoted prices, the net asset value (“NAV”) of a separate account is not publicly quoted. Accounting Standard Codification (ASC) 820 allows NAV per share to serve as an estimate of fair value as long as certain requirements are met, and it is the Plan Trustee’s assessment that these conditions have been met. These PSAs can be redeemed at NAV.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the unobservable inputs.

The Plan’s policy is to recognize transfers into and out of level 3 as of the date of the event or change in circumstances that caused the transfer. There were no transfers out of or into level 3 for the year ended December 31, 2021 or the ten months ended October 31, 2022.

Fair Value of Investments in Entities that Use Net Asset Value

There were no plan assets as of October 31, 2022. The following table summarize investments measured at fair value based on net asset value (NAVs) per share as of December 31, 2021. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**NOTE 5**      **RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by John Hancock Life Insurance Company (U.S.A.) (John Hancock) is the insurance company of the plan and receives fees for recordkeeping services and per-use transactions. Certain Plan investments are managed by John Hancock and for which John Hancock receives fees that are paid through revenue sharing and included in net depreciation in fair value of investments. John Hancock also receives fees for distribution and other administrative services that are included in plan expenses which totaled \$8,265 for the ten months ended October 31, 2022. The company provides the Plan with accounting and administrative services, for which no fees are charged to the Plan. The Plan's trustee is a participant in the plan. These transactions qualify as exempt party-in-interest transactions under ERISA rules and regulations. Investments managed and maintained by John Hancock Life Insurance Company totaled \$0.

**NOTE 6**      **PLAN TERMINATION**

In July 2022, the plan management of Vets United, LLC 401(k) Plan initiated a plan to formally terminate the Plan. Accordingly, all plan assets were distributed from the Plan as of October 31, 2022.

**NOTE 7**      **RISKS AND UNCERTAINTIES**

The Plan provides for investments in a variety of investment alternatives offered by the Plan. In general, such investments are exposed to various risks, including interest rate, market volatility, and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the values of Plan investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.
