INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of the Family Trust Federal Credit Union Retirement Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits in liquidation as of October 25, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits in liquidation for the period ended October 25, 2022 and the year ended December 31, 2021, and the statement of accumulated plan benefits (in liquidation) as of December 31, 2021, and the related statement of changes in accumulated plan benefits in liquidation for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended October 24, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Termination and Use of Liquidation Basis of Accounting

As further discussed in Note 7 to the financial statements, the Board of Directors of Family Trust Federal Credit Union, made a decision to terminate the Family Trust Federal Credit Union Retirement Plan and determined that liquidation is imminent. As a result, in accordance with GAAP, Family Trust Federal Credit Union Retirement Plan used in presenting the 2022 and 2021 financial statements the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement

resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

Note 1 - Description of the Plan

General

Family Trust Federal Credit Union Retirement Pension Plan (the Plan) is a non-contributory defined benefit pension plan established January 1, 1966 covering all eligible employees of the Family Trust Federal Credit Union (the Credit Union). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. On June 9, 2020, an amendment was signed to freeze the Plan effective as of the close of business December 31, 2020. Any employee who is an active participant as of December 31, 2020 will no longer earn future benefit accruals under the Plan. No new employees will be eligible to enter the Plan. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan's provisions.

Administration

The Credit Union is the Plan sponsor and Plan Administrator. The Plan Administrator is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, fees and reports to the Plan's Board of Trustees. Massachusetts Mutual Life Insurance Company (MassMutual) is the Investment Custodian. The Plan has also retained Empower Retirement to provide participant recordkeeping, and administrative services. Additionally, the Plan retained Milliman, Inc. for actuary services.

Eligibility

Employees are eligible to participate in the Plan if they have attained age 18 and completed six months of service. Employees may enter the Plan after meeting the eligibility requirements. The Plan is closed to new participants effective December 31, 2020.

Pension Benefits

Normal Retirement Benefits: Normal retirement date is the first day of the calendar month coincident with or next following age 65. An eligible participant's monthly normal retirement benefit shall be equal to 1/12 of the sum (1), (2) and (3) as follows:

- (1) 1.30% of the participant's average compensation (up to the social security covered compensation) multiplied by the number of years of credited service at retirement not in excess of 35 years, and
- (2) 1.85% of the participant's average compensation in excess of the Social Security Covered Compensation multiplied by the number of years of credited service at retirement not in excess of 35 years, and
- (3) 1.30% of the participant's average compensation multiplied by the number of years of credited service in excess of 35.

Pension Benefits (Continued)

A terminated participant who has completed three years of service is entitled to receive a vested monthly benefit starting on their normal retirement date. The amount of the benefit is equal to the retirement income earned based on service to date multiplied by the appropriate vested percentage.

If the participant terminates employment and their vested balance in the Plan is less than \$1,000, then a lump-sum distribution will be made without the participant's consent.

Early Retirement Benefits: The Plan permits early retirement for participants who have attained age 55 and have completed at least three years of credited service. A reduced retirement benefit will result from early retirement. Specifically, the amount of the earned accrued benefit is reduced by 5/10 of 1% for each of the first 60 complete calendar months, and 4/10 of 1% for each complete calendar month in excess of 60 calendar months that the early retirement date precedes normal retirement date. If retirement commences before age 55, the early retirement benefit shall equal the actuarial equivalent of the vested accrued amount.

Late Retirement Benefits: Late retirement benefits are payable to a participant who continues employment with the Credit Union after attaining normal retirement age and shall be the greater of continued accruals or the actuarial equivalent of accrued benefits.

Optional Benefit Form: Optional benefit forms are available and equal to the actuarial equivalent of the normal benefit form and may be in an amount more or less than that provided by the normal benefit form depending on the option selected. Such distributions may be in one of the following forms:

- Lump-sum payment.
- 75% or 50% joint and survivor annuity.
- 15-year certain life annuity.
- 10-year certain life annuity.
- 5-year certain life annuity.

Death and Disability Benefits: If an active vested employee dies, a death benefit payable to the beneficiary is calculated using the survivor portion under the 50% joint and survivor option and calculated as if they had retired on the day before the death. A beneficiary may be eligible for an enhanced 50% joint and survivor annuity on the non-spouse survivor benefits as described in the Plan document.

If a retired employee dies, the benefit payable to the beneficiary is the amount as determined under the annuity option selected at time of retirement if the employee had retired on the day before their death.

Pension Benefits (Continued)

Employees who become permanently and totally disabled while employed prior to reaching normal retirement age, will continue to accrue benefits at the same rate of compensation and hours of service they were accruing at the time of their disability. Benefits are payable upon normal retirement age.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the liquidation basis of accounting. Income from investments is recorded when it is earned. Expenses are recorded in the accounting period in which they are incurred. Effective August 31, 2021, the Credit Union's Board of Directors adopted a resolution to terminate the Plan. As a result, the Plan financial statements as of December 31, 2021, and for the period year ended December 31, 2021, have been prepared on the liquidation basis, in accordance with accounting principles generally accepted in the United States of America (GAAP). The basis of accounting is considered appropriate when, amount other things, liquidation of an entity is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation bases of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of December 31, 2021, would be fair value.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determine the Plan's valuation policies utilizing information provided by the investment advisors and Investment Custodian. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits expected to be paid to: (i) retired or terminated vested participants or their beneficiaries, (ii) beneficiaries of participants eligible to retire who have died, and (iii) present participants or their beneficiaries. Benefits payable under all circumstances (retirement, death, and termination of employment) are included in the computation to the extent they are considered attributable to employee service rendered at the valuation date.

Benefits to be provided via annuity contracts excluded from Plan assets are excluded from accumulated Plan benefits. The actuarial present value of accumulated Plan benefits is determined by an actuary from Milliman, Inc., and it is that amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of January 1, 2022 were (i) investment return of 3.00% per annum, (ii) Mortality; Pri-2012 mortality for annuitants and non-annuitants projected fully generationally using scale MP-2021, (iii) salary increases 0%, and (iv) withdrawal rates based on T-7 less 51 GAT Male Table. The computations of the actuarial present value of accumulated Plan benefits were made as of January 1, 2022. Had the valuation been performed as of December 31, 2021, there would be no material differences.

Payment of Benefits

Benefit payments to participants and beneficiaries are recorded at the time of distribution.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including June 30, 2023, which is the date the financial statements were available to be issued.

Note 3 - Unaudited Information Certified by Investment Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by the Plan's Investment Custodian as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying Statements of Net Assets Available for Benefits as of October 25, 2022 and December 31, 2021.
2. All investment activity in the Statements of Changes in Net Assets Available for Benefits for the period October 25, 2022 and year ended December 31, 2021
3. All investment-related information included in the Supplemental Schedule and the Schedule H, Line 4j – Schedule of Reportable Transactions for the year ended October 25, 2022.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2021.

Pooled separate accounts: Valued at the daily closing price as reported by the fund. Pooled separate accounts held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment account: A general account insurance contract with interest and principal guaranteed by MassMutual and backed by all the general assets of MassMutual. MassMutual provides contractual protection against a change in the participants' account value due to interest rate volatility.

Note 5 - Funding Policy and Administrative Fees

The Plan is funded by contributions made by the Credit Union. The Credit Union's funding policy is to, at a minimum, make contributions to the Plan as recommended by the Plan's actuary. No contributions were required to satisfy the minimum funding requirements of ERISA for the period ended October 25, 2022 and year ended December 31, 2021.

In order for Empower Retirement to provide administrative services to the Plan, it charges an amount necessary to cover certain expenses. The Plan pays these administrative expenses. Certain administrative functions are performed by officers and employees of the Credit Union. These include salaries and overhead, which are paid directly by the Credit Union, and are excluded from the financial statements.

Note 6 - Party-in-Interest Transactions

Certain Plan investments are managed by Empower, who is the Plan's Investment Custodian. Transactions involving these investments are considered party-in-interest transactions. However, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Note 7 - Plan Termination

On August 31, 2021, the Plan was terminated. Benefits were accrued through December 31, 2020 and no additional service was earned after December 31, 2020. Participants are considered to be fully vested for all participants at termination. The total benefit obligation for the Plan termination was \$8,110,860. Employees received a lump-sum payment in the amount of \$7,648,391 and the purchased annuities in the amount of \$462,469 from the Plan in 2022, and such employees may elect to have to have their lump-sum rolled over into an IRA or the Credit Union's 401(k) Plan. The Plan purchased \$658,286 in annuities in May 2022. Additionally, \$3,231,753 was returned to the Plan sponsor.

Note 8 - Tax Status

The Plan has received its latest determination letter on June 9, 2020, in which the IRS stated that the Plan, as designed, is qualified under applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Additionally, the Plan received its termination determination letter on March 23, 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits (in Liquidation).

Plan contributions are made, and the actuarial present value of accumulated Plan benefits in Liquidation are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
