INDEPENDENT AUDITORS' REPORT

To the Trustees of the
Avalex Technologies Corporation Profit Sharing Plan & Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Avalex Technologies Corporation Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of October 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the ten months ended October 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Avalex Technologies Corporation Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2022 and December 31, 2021, and for the ten months ended October 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Avalex Technologies Corporation Profit Sharing Plan & Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Avalex Technologies Corporation Profit Sharing Plan & Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan did not have an ERISA bond to cover the Plan assets for the years ended October 31, 2022 and December 31, 2021. The bond should have been in place at the beginning of the year and maintained throughout the year in order for the Plan to be in compliance with ERISA rules and regulations.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Avalex Technologies Corporation Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan was a defined contribution plan generally covering substantially all employees of Avalex Technologies Corporation (the Company). It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was designed to comply with Section 404 (C) of the Internal Revenue Code. The Plan was administered by Avalex Technologies Corporation. However, various record-keeping, compliance, and financial reporting requirements were performed through the contracted plan administrator and John Hancock Life Insurance Company as of October 31, 2022.

On November 5, 2021, Avalex Technologies Corporation entered into a merger agreement with Mercury Systems, Inc. On October 19, 2022, the Plan was merged with and into the Mercury Plan. The assets and obligations of the Plan totaling \$5,515,933 were transferred into the Mercury Plan on that date. The terms of the merger provide for the preservation of the accrued benefits and protection of certain benefits, rights and features on behalf of former employees of Avalex Technologies Corporation who had an accrued benefit under the Plan as of the merger date. The Plan ceased to exist after this date.

Contributions – Participants were able contribute a percent of their annual compensation to the Plan not to exceed the limits allowable by the Internal Revenue Service. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options. The Company matched up to 4 percent of the contributions.

Participant Accounts – Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled was the benefit that can be provided from the participant's vested account.

Participant Loans – The minimum loan amount was \$1,000. Loans were payable through payroll deductions over terms ranging up to 5 years, except for certain participant home loans which may allow an additional reasonable period of time. Loans accrued interest at rates at 1% over the prime interest rate..

Vesting – A participant was 100 percent vested after six years of credited service.

Payment of Benefits – Benefit payments were made in a lump sum payment in cash upon the participant's death, disability, or retirement. Normal retirement is at age 65.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for plan benefits, the net appreciation in the fair value of its investments which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation on investments held at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits were recorded when properly executed requests for distribution were received.

Administrative Expenses

Certain direct expenses and fees related to the administration of the Plan are paid from Plan assets. All other administrative expenses are paid by the Company.

NOTE 3 UNAUDITED INFORMATION

John Hancock Life Insurance Company held the Plan investment assets and executed transactions as of October 31, 2022 and December 31, 2021. Financial information for 2022 and 2021 relating to these assets is included in the accompanying financial statements and is based on information provided by the trustees. This financial information presented on pages 3 and 4 and Note 4 has not been audited by independent auditors.

NOTE 4 FAIR VALUE MEASUREMENTS – UNAUDITED

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2022.

Mutual Funds – Valued using the net asset values provided by John Hancock Life Insurance Company at year end.

Participant loans – Valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Plan received an advisory opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The income tax returns of the Plan are subject to examination by taxing authorities, generally for three years after they were filed.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.

NOTE 7 COMPLIANCE MATTERS

The Plan did not have an ERISA bond to cover the Plan assets for the years ended October 31, 2022 and December 31, 2021. The bond should have been in place at the beginning of the year and maintained throughout the year in order for the Plan to be in compliance with ERIA rules and regulations.

NOTE 8 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through the date the financial statements were available to be issued.
