We have performed an audit of the financial statements of Rhino Staging Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 10, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Summary of significant accounting policies

The following is a summary of the significant accounting policies followed by Rhino Staging Retirement Plan (the Plan) which is sponsored by Rhino Staging, Inc. (the Company). The policies conform with accounting principles generally accepted in the United States of America, which require management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

a. Investments

Mutual funds are stated at fair value based on the quoted market prices. Purchases and sales of securities are recorded on a trade-date basis and interest income is recorded on an accrual basis. Most investment options have management fees that reduce the overall return on assets. Net appreciation (depreciation) is inclusive of those fees.

b. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

c. Investment and administrative expenses

Investment expenses are paid directly by the Plan, and administrative expenses are paid by the Company. However, the Company retains the right to discontinue paying expenses, in which case the expenses will be paid by the Plan.

d. Income taxes

Effective February 4, 2021, the Plan is utilizing a non-standardized pre-approved document sponsored by FMR, LLC. The document sponsor received a favorable determination letter dated June 30, 2020 from the Internal Revenue Service, which states that the Plan qualifies under the applicable provisions of the Internal Revenue Code. Prior to the above document, the Plan was utilizing a volume submitter document sponsored by Fidelity Management & Research Co. The document sponsor received a favorable determination letter dated March 31, 2014 from the Internal Revenue Service, which states that the Plan qualifies under the applicable provisions of the Internal Revenue Code.

The Plan has been amended since adopting the documents, however the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. However, the Plan is subject to examination; generally for a period of three years from filing its Form 5500.

d. Income taxes, continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

e. Concentrations of risk

The Plan provides for various investment fund options, which in turn invest in any combination of mutual funds and other investments. Investments are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the changes in net assets available for benefits.

2. Description of plan

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan, established December 1, 1999, is a defined contribution 401(k) plan covering employees who are age twenty one or older and have completed 1,000 hours in a Plan year. The Plan excludes employees covered by a collective bargaining agreement, leased employees, and nonresident aliens who do not receive any earned income from the Employer. Employees may become participants on the first day of the first and seventh month of the year. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Each participant may make salary deferral contributions of up to 60% of his/her annual compensation, not to exceed the annual deferral limit set by the Internal Revenue Code. Catch-up contributions are permitted for participants age 50 and older. The Plan also allows participants to make rollover contributions.

The Company may also make a discretionary contribution to all eligible participants. The exact percentage or amount is determined annually by the Company and is allocated based on each participant's proportionate share of the total compensation paid to all participants during the plan year. Participants who have completed at least 501 hours of service during the plan year are eligible to receive an allocation of the discretionary contribution. For the plan periods ended October 10, 2022 and December 31, 2021, the employer did not make any discretionary contributions.

c. Vesting

Each participant is immediately vested in his/her salary deferral, catch-up contributions, and any earnings or losses on those contributions. The remainder of a participant's account balance is vested based on years of service. Participants vest at 100% after three years of service; prior to completing three years of service, the participant is 0% vested. Forfeited non-vested funds may be used to pay Plan expenses and/or reduce the Company's contribution. At October 10, 2022 and December 31, 2021, the Plan did not have a forfeiture balance.

d. Participant accounts

Each participant's account is credited with the participant's salary deferral, catch-up contributions, Company contributions, and Plan earnings/losses. Plan earnings/losses are allocated based on account balances, as defined in the Plan document. Each participant directs the investment of his/her account into various investment options offered by the Plan through Fidelity Management Trust Company.

e. Payment of benefits

Each participant is entitled to Plan benefits equal to 100% of his/her vested account balance. Benefits begin upon the earliest of retirement age, termination of employment, total and permanent disability or death of the participant. Benefits are paid in a lump-sum as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable. The Plan permits hardship and in-service distributions under certain circumstances.

The Coronavirus Aid, Relief, and Economic Security ("CARES") Act was signed into law on March 27, 2020. The CARES Act allows changes to Plan distributions and loans. The Plan is permitted to implement the provisions and retrospectively adopt those provisions. The Plan sponsor elected to adopt the loan and distribution provisions of the CARES Act.

The Plan terminated effective November 16, 2021 and the Plan was not retrospectively amended to include the CARES Act provisions prior to termination.

f. Loans

The Plan permits participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is paid ratably through payroll deductions. The Plan terminated effective November 16, 2021, there were no new loans issued and no loan ending balances for the plan year ended October 10, 2022.

g. Plan termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant will become fully vested in his/her account. The Plan was terminated effective November 16, 2021.

4. Fair value measurements

Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements (FASB ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair value measurements, continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: valued at the net asset value (NAV) of shares held by the Plan at year end.

Cash Equivalents are interest-bearing money market funds are valued at the current dollar value at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets in the Plan on October 10, 2022.

6. Party-in-Interest transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Custodian of the Plan assets, record keeper, investment advisor and other service providers are considered parties-in-interest with respect to the Plan. Certain Plan investments are shares of mutual funds managed by the Custodian. The Plan issues loans to participants, which are secured by the balance in the participant's account. Such transactions are party-in-interest and related party transactions for which a statutory exemption exists.

7. Prohibited transactions and corrective contributions

There were unintentional delays by the Sponsor in submitting participant contributions in the amount of \$4,023 to the custodian for the Plan year ended December 31, 2021. Due to the Plan being terminated and there are no longer assets in the Plan, the Sponsor has elected not to correct these late contributions.

It came to the Plan sponsor's attention that they were improperly excluding part-time employees from the Plan. The sponsor worked with an ERISA attorney to calculate corrective contributions, lost earnings, and interest. The Plan Sponsor deposited the corrective contributions into the Plan in November 2020 and filed a Voluntary Correction Program (VCP) submission with the IRS in September 2020. Subsequent to the filing, the Company found errors in the VCP calculation and revised the VCP submission. The Plan Sponsor received a compliance letter from the IRS dated August 11, 2021.

8. Plan Termination

Effective November 16, 2021, the Plan Sponsor terminated the Rhino Staging Retirement Plan. All funds in the Plan are fully vested and as of October 10, 2022, all assets have been distributed. The Plan holds investments in mutual funds and cash equivalents and distributions due to plan termination are processed at fair value.

9. Subsequent Events

Management reviewed the financial statements for subsequent events through August 7, 2023.
