### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of christopher consultants, ltd. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to October 31, 2022, and the related notes to the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

### **1. Description of the Plan**

The following description of the christopher consultants, ltd. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

#### **General**

The Plan was a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code (IRC) and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan, which became effective on July 1, 1983, was restated most recently effective December 11, 2018, and covered all eligible employees of christopher consultants, ltd., Utility Professionals, Inc. and Paciulli, Simmons and Associates (collectively, the Company). Principal Trust Company (the Trustee) served as the asset custodian and record-keeper of the Plan. The Plan's investment committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and was responsible for oversight of the Plan.

#### **Plan Merger**

Effective November 1, 2022, the Plan merged into IMEG 401(k) Plan as a result of the purchase of the Company by IMEG Corporation. The net assets of the Plan were transferred to IMEG 401(k) Plan on October 31, 2022, resulting in the termination of the Plan on the effective merger date.

#### **Eligibility**

All employees of the Company, except for employees governed by a collective bargaining agreement, nonresident aliens, residents of Puerto Rico, leased employees and temporary and seasonal employees with fewer than 1,000 hours of service during the year, were eligible to participate in the Plan upon completion of three months of service. Participants entered the Plan on the first day of each month after meeting the eligibility requirements.

#### **Contributions**

Each pay period, participants made salary reduction contributions of annual compensation subject to the limitations of the IRC, as defined in the Plan, on a pretax basis or as a Roth contribution. Employees were automatically enrolled into the Plan at 3% of pretax annual compensation, increased by 1% annually to a maximum of 10%, unless the employee affirmatively elected otherwise. Qualified distributions from other qualified retirement plans could also be contributed to the Plan and retained as a rollover contribution. Participants were immediately vested in their salary reduction and rollover contributions plus actual earnings thereon.

The Company had the option to make discretionary matching contributions to the Plan. For the period from January 1, 2022 to October 31, 2022, the Company made matching contributions to the Plan equal to 50% of each dollar the participant contributed up to a maximum of 6% of the participant's eligible compensation. The Company could also make additional contributions to the Plan at its sole discretion. For the year period from January 1, 2022 to October 31, 2022, no such additional contributions were made.

### **Vesting**

Participants were fully vested in their salary reduction and rollover contributions and earnings thereon at all times. Vesting in employer contributions and earnings thereon were based on years of continuous service. Participants became 20% vested in employer contributions after completion of the first two years of service and vested an additional 20% thereafter until fully vested after six years.

### **Participant Accounts**

Each participant's account was credited with the participant's contribution and allocations of the Company's contributions and plan earnings and charged with an allocation of plan expenses. Allocations were based on participant earnings or account balances, as defined in the Plan. Participants selected how to invest salary deferral, employer contributions and rollover accounts. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

### **Investment Options**

Participants were afforded several investment options covering a wide range of investment objectives and risk. The Plan was intended to qualify as a participant-directed plan under Section 404(c) of ERISA. Participants could allocate contributions across these options in any proportion they wished, and could change this allocation at any time.

### **Payment of Benefits**

Participants were eligible for retirement benefits upon attaining the age of 65. On termination of service due to death, disability or retirement, a participant could receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or periodic payments. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or elect a direct rollover distribution. However, if the total value of the vested balance was \$5,000 or less, the entire vested balance would be distributed in a lump sum payment.

### **Notes Receivable From Participants**

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or the greater of 50% of their vested account balance or \$10,000. The number of loans a participant could have outstanding was limited to one, and a participant could be approved for no more than three loans in any 12-month period. All loans were secured by the balance in the borrowers' accounts, must be approved by the plan administrator and would bear interest at a rate commensurate with local prevailing rates. Interest rates on loans outstanding at December 31, 2021 ranged from 4.25% to 6.25%. Principal and interest were paid by the participants primarily through payroll deductions.

### **Forfeited Accounts**

Terminating participants forfeited the nonvested portion of the participants' employer contributions. The Plan used forfeitures to reduce administrative expenses as well as to reduce employer contributions. For the period from January 1, 2022 to October 31, 2022, \$18,580 of forfeitures were used to reduce administrative expenses. At October 31, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$1,262, respectively.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting and Use of Estimates**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The preparation of the financial statements in accordance with U.S. GAAP required the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

#### **Notes Receivable From Participants**

Loans to participants are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2021.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) include the gains and losses on investments bought and sold as well as held during the year.

#### **Administrative Expenses**

The Company may elect to pay the administrative expenses of the Plan. If not paid by the Company, administrative expenses are required to be paid by the Plan. All such costs and expenses are, unless allocable to the accounts of particular participants, charged against the accounts of all participants on a pro rata basis or in such other reasonable manner as directed by the Company. Certain accounting and administrative functions of the Plan were performed by employees of the Company at no cost to the Plan. Investment related expenses were included in net appreciation (depreciation) in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

#### **Payment of Benefits**

Benefit payments are recorded when paid.

#### **Subsequent Events**

The Plan evaluated subsequent events through August 7, 2023, the date these financial statements were available to be issued.

### **3. Information Certified by the Trustee**

The plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan, certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statement of net assets available for benefits as of December 31, 2021, and the related investment activity reported in the statement of changes in net assets available for benefits for the period from January 1, 2022 to October 31, 2022.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2022 and December 31, 2021.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

### 5. Fully Benefit-Responsive Contract

The Plan has a fully benefit-responsive investment contract (the Contract) with Principal Life Insurance Company (Principal). Contributions are maintained in an account with Principal as the asset trustee. The account is credited with earnings on the investment and charged for plan withdrawals and administrative expenses. The Contract's issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the Contract was fully benefit-responsive, contract value was the relevant measurement attributed for that portion of the net assets available for benefits attributable to the Contract. Contract value, as reported to the Plan by Principal, represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses. Participants can ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the Contract's issuer or otherwise.

The Contract did not specify any events which would limit the ability of the Plan to transact at contract value with the issuer. The Contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The Contract provides for a charge to be assessed for surrendering the Contract; however, the Company elected to not incur this charge, resulting in the investment remaining in the Plan's trust as of the effective date of the Plan's merger into the IMEG 401(k) Plan on November 1, 2022, however legal title for the Plan's trust was transferred to IMEG 401(k) Plan as of that date.

### 6. Tax Status

The Plan was organized as a pre-approved plan and was intended to satisfy the tax qualification requirements under Section 401(a) of the IRC; therefore, the funds of the Plan were intended to be exempt from federal income taxes under the applicable sections of the IRC. On August 8, 2014, Principal received a favorable opinion letter from the Internal Revenue Service (IRS) for its volume submitter profit sharing plan with cash or deferred arrangement. The Plan had been amended since the date of this opinion letter; however, the plan administrator and management believe the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Related-Party and Party In Interest Transactions**

Certain plan investments were funds managed by the Trustee. Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualified as exempt party in interest transactions.

Certain administrative functions of the Plan were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

### **8. Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

As of December 31, 2021, 35% of the Plan's net assets available for benefits were concentrated in three individual investments.
