Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of The Fonseca Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 31, 2022 (in liquidation) and December 31, 2021 (ongoing) and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through October 31, 2022 (in liquidation) and the related notes to the financial statements (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Charles Schwab Trust Bank as of October 31, 2022 and December 31, 2021, and for the period from January 1, 2022 through October 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements. Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements. Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

Other Matters

Basis of Accounting

As described in Notes 2 and 6 to the financial statements, the Plan was terminated effective October 31, 2022. As a result, the Plan has changed its basis of accounting from the accrual basis used in presenting the financial statements as of December 31, 2021 to the liquidation basis used in presenting the financial statements as of and for the period ended October 31, 2022. Our opinion is not modified with respect to that matter.

Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H - Line 4i - Schedule of Assets (Held at End of Period) and Schedule H - Line 4a - Schedule of Delinquent Participant Contributions, (referred to as the "supplemental schedules"), are presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. 1. Plan Information

The following description of the Fonseca Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan was established effective March 1, 2021 as a profit sharing 401(k) plan that through October 31, 2022 provided retirement benefits for all eligible employees of The Fonseca Group and its affiliates who have completed one year of service (1,000 hours as defined) prior to the entry dates of the beginning of each plan year quarter, or who satisfied the requirements by March 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Sponsor acts as Plan Administrator and is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Administrator. The recordkeeper of the Plan is Ameritas/Blue Star ("Ameritas"), and the custodian of the Plan's investments is Charles Schwab Trust Bank. The Trustee of the Plan is an executive at the Sponsor.

Contributions – Eligible participants may elect to defer a percentage of their compensation or a fixed dollar amount by contributing to their accounts in the Plan, on a pre-tax basis, or post-tax basis in the form of Roth contributions, subject to the maximum allowable under the Internal Revenue Code (the "Code"). Highly compensated employees are subject to additional limits set forth in the Code. Participants who have attained age 50 before the end of the Plan year are permitted to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified retirement plans and/or Individual Retirement Accounts ("IRAs"). Rollovers are not permitted from a Roth IRA. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various common/collective investment trusts and mutual funds as investment options for participants.

The Plan also has provisions for automatic enrollment for participants, upon completion of the service requirements, following the statutory minimum deferral increase provision schedule. For years 1 to 2, 3% of compensation is deferred; 3 years, 4% is deferred; 4 years, 5% is deferred; 5 or more years, 6% is deferred.

The Employer has elected to make a QACA safe harbor basic matching contribution, which is 100% of contributions not exceeding 1% of compensation and 50% of contributions from 1% to 6% of compensation. For the period ended October 31, 2022 (in liquidation), employer contributions were \$81,503.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution and Plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan does not allow participants to take loans against their account balances.

Vesting of Participants' Accounts – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of participant accounts plus actual earnings thereon is based on years of continuous service, as follows:

2 or More	100%

Payment of Benefits – On termination of service due to death, disability or retirement, participants become 100% vested in their employer contribution accounts. For termination of service prior to retirement, participants will receive the value of their vested account in a lump-sum payment.

Participant Loans – Participants may not borrow from the Plan.

Forfeitures – Forfeitures of unvested Plan matching contributions from terminated participant accounts are used to offset future Employer matching contributions or to pay Plan expenses. There were \$2,135 of forfeitures utilized during the period ended October 31, 2022. Forfeitures available at October 31, 2022 and December 31, 2021 were -0- and \$2,135, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting – As of and for the period ended October 31, 2022, the financial statements of the Plan have been prepared using the liquidation basis of accounting. See Note 6 regarding the Plan's termination.

As of December 31, 2021, the Plan prepared its financial statements on the accrual basis of accounting.

Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

4. Fair Value

FASB ASC 820, Fair Value Measurements, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are summarized as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at net asset value. There have been no changes in the methodologies used at October 31, 2022.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price and are considered to be actively traded.

Collective Investment Trusts - Common collective trusts are stated at fair value and invest primarily in mutual funds. The common collective trusts do not have any unfunded commitments relating to their investments, nor any significant restrictions on redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of October 31, 2022 (in liquidation) and December 31, 2021 (ongoing). Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For the period ended October 31, 2022 (in liquidation), there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

5. Delinquent Contributions

During the period ended October 31, 2022, the Employer failed to make proper deferrals of approximately \$1,062 to the Plan for certain employees, owing the amount at year end. In addition, the Employer is required by DOL regulations to pay the Plan lost income of approximately \$82 to the affected participants, for a total of \$1,144 due to the Plan. The Plan Administrator plans to enter the Department of Labor Voluntary Fiduciary Correction Program ("VFCP"), and remit the contributions to the participants in the plan.

6. Plan Termination

The board of the Employer terminated the Plan on October 31, 2022, after the Employer had implemented a new multiple-employer retirement plan. Upon notification of the Plan's termination, participants were provided the option to have their accounts distributed or rolled over into another retirement plan, including the Employer's newly established multiple-employer retirement plan.

7. Tax Status

The underlying prototype non-standardized plan, on which the Plan is based, has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (“Code”). The Plan’s sponsor has determined that it is eligible to, and has chosen to rely on, the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan’s administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for the years 2021, 2020 and 2019.

8. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by an affiliate of the Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment management and custodial services were \$7,763 for the period ended October 31, 2022 (in liquidation).

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
