INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
the SMITH TRUCKING, INC. 401(K) PLAN & TRUST

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SMITH TRUCKING, INC. 401(K) PLAN & TRUST, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 24, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits as of and for the period ended October 24, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SMITH TRUCKING, INC. 401(K) PLAN & TRUST's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 24, 2022 and December 31, 2021, and for the period ended October 24, 2022, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SMITH TRUCKING, INC. 401(K) PLAN & TRUST and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about SMITH TRUCKING, INC. 401(K) PLAN & TRUST's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE A. DESCRIPTION OF THE PLAN

The following description of the SMITH TRUCKING, INC. 401(K) PLAN & TRUST (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit-sharing plan with 401(k) features. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Entities

The Plan consists of participants from Smith Trucking, Inc., which is part of a commonly controlled group, and from Rose Management, Inc., which is an affiliated corporation (Plan Sponsors).

Plan Amendment

During the Plan period ending October 24, 2022, the Plan was amended to initiate the Safe Harbor matching provision.

Eligibility

Eligible employees of the Plan Sponsors may participate after reaching the age of 21 and completing a minimum of six months of service. Employees will begin participation in the Plan the 1st day of the month following the date the eligibility requirements are met.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

NOTES TO FINANCIAL STATEMENTS

NOTE A. DESCRIPTION OF THE PLAN (Continued)

Contributions (Continued)

During the Plan period ending October 24, 2022, the Plan made safe harbor matching contributions of 100% of the first 3% of compensation and 50% of the next 2% of compensation of participating employees. Safe harbor matching contributions were \$95,137 and \$0 for the Plan period ended October 24, 2022 and the year ended December 31, 2021, respectively.

Discretionary profit sharing contributions are determined and made by the employers. The employers have not made any discretionary profit sharing contributions for the Plan period ended October 24, 2022 and the year ended December 31, 2021.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the employer's discretionary profit sharing contributions, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions and any past employer's matching contributions into any of the different investment funds offered by the Plan or elect to have their investments professionally managed.

Vesting

Participants are vested immediately in their voluntary 401(k) contributions plus actual earnings thereon. Participants are 100% vested in their safe harbor matching contributions that occurred prior to January 1, 2010. The Plan applies a six-year graduated vesting schedule for employer profit sharing contributions. Participants will be 100% vested in any employer profit sharing contributions after six years of vesting service or at the time of death, disability, or retirement, provided the person has reached normal retirement age.

NOTE A. DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest based on inquiry with professional lenders in the same geographic area of the participant and Plan Sponsor to determine the prevailing interest rate for loans under like circumstances.

Loans require repayment within five years from the loan date, unless the loan is for the purchase of the participant's primary residence, in which case the repayment may be for a reasonable period of time that may exceed five years.

Payment of Benefits

If employment terminates for reasons other than death, disability or early or normal retirement, participants are entitled to receive only the vested percentage of their account balance. If the account balance does not exceed \$5,000, a distribution can be made regardless of whether the participant consents to receive it.

Forfeitures

Forfeited nonvested accounts are used to either reduce the Company's discretionary matching contributions or pay Plan expenses in accordance with the provisions of the Plan. The balance of forfeited nonvested accounts was \$0 for both the Plan period ended October 24, 2022 and the year ended December 31, 2021. During the Plan period ended October 24, 2022 and the year ended December 31, 2021, there were no forfeitures used to pay administrative expenses.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements and supplemental schedules of the Plan were prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect amounts reported on the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value was determined using the net asset values of mutual funds, which was determined by the net asset value of the underlying shares.

Participant loans are valued at their outstanding principal balances, which approximates fair value.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as received.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan administration costs were paid through participant accounts.

Excess Contributions Payable

The Plan is required to return contributions received during the Plan year in excess of the Code's limits.

Tax Positions Interest and Penalty

Interest recognized on underpayment of income taxes is recorded to interest expense. Penalties recognized on tax positions are recorded to income tax expense. During the Plan period ended October 24, 2022 and the year ended December 31, 2021, there were no underpayment interest or penalties to recognize.

NOTE C. INCOME TAX STATUS

The Plan Prototype obtained its latest opinion letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

NOTE C. INCOME TAX STATUS (Continued)

The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

As of October 24, 2022, the federal 2021, 2020, and 2019 tax returns remain subject to examination.

NOTE D. CERTIFICATION BY THE TRUSTEE

The Trustees provided the plan administrator with certifications as to the completeness and accuracy of investment assets and notes receivable from participants aggregating \$0 and \$1,729,448 for the Plan period ended October 24, 2022 and the year ended December 31 2021, respectively. The related net investment income, including the net appreciation(depreciation) in fair value of such assets of (\$415,090) and \$193,625 for the Plan period ended October 24, 2022 and the year ended December 31, 2021, respectively, was also included in the certifications. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedules of the Plan based on such certifications from the Trustee as being complete and accurate.

NOTE E. FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value as of December 31, 2021. As required by FASB ASC 820, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

NOTE F. PARTY-IN-INTEREST TRANSACTIONS

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. The Trustee is a party-in-interest as a result of providing custodial services to the Plan and investment of Plan assets in its investment funds. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

NOTE G. PLAN TERMINATION

The Plan Expressed the intent to terminate the Plan and recordkeeping services arrangement with the Trustee and Record Keeper. The plan was merged into a new group 401k Plan effective October 24, 2022.

NOTE H. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 11, 2023, the date in which the financial statements were available to be issued, and has determined that there were no material events requiring recognition or disclosure.
