Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Lynn Agency Inc 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of October 14, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1 through October 14, 2022, and the related notes to the financial statements.

1. **DESCRIPTION OF PLAN:** The following description of the Lynn Agency Inc 401 (K) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established on January 1, 2019 to provide benefits to all eligible employees. The Plan covers all eligible employees of Lynn Agency Inc (the Company) except for employees covered by a collective bargaining agreement and non-resident aliens. To be eligible, an employee must have completed three consecutive months of elapsed time service as defined in the plan document and be twenty-one years of age. The Board of Trustees is responsible for the oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Trustees.

Contributions

Each year, participants may contribute up to 100% of pre-tax or after-tax annual compensation, as defined in the plan document. Participants who have obtained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The employer may decide each plan year whether to make a discretionary matching contribution equal to a uniform percentage or dollar amount of the employees' elective deferrals on behalf of active participants. For the period from January 1, 2022 through October 14, 2022, the Company did not make any discretionary contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses, if and when such expenses are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. During the period there were no administrative expenses paid by the Plan that required allocation to participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum of the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior twelve-month period. Participants are only permitted to have one outstanding loan from the Plan at any time. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence.

On termination of service due to disability or retirement, if the vested account balance exceeds \$5,000, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. If the vested account balance is less than \$5,000, or upon termination of service due to death, the balance may only be distributed as a lump sum. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants may receive an in-service withdrawal upon reaching 59½ years of age.

**2. SUMMARY OF
SIGNIFICANT

POLICIES:**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of October 14, 2022.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

**3. FAIR VALUE
MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 14, 2022 and December 31, 2021.

Registered Investment Companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common Collective Trusts are comprised of investments held in a stable value portfolio, which include GICs, collateralized mortgage obligations, managed bond

RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:** Certain plan investments are managed by Paychex, Inc. and its affiliate, Mid Atlantic Trust Company, who serve as the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Paychex, Inc., and its affiliate provide certain administrative services to the Plan pursuant to a service agreement between the Company and Paychex, Inc. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment. In addition, the Company's payroll is administered by Paychex, Inc.

- 5. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE:** Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Paychex and its affiliate, Mid Atlantic Trust Company, except for comparing such information certified by the trustee with information included in the Plan's financial statements and supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year):

- 7. PLAN TERMINATION:** In August of 2022, the plan administrators instructed the trustee, Mid Atlantic Trust Company, to liquidate all plan assets and return each individual account balance to the respective participants. The Plan was subsequently terminated on October 14, 2022.

- 8. TAX STATUS:** The Plan is structured and follows a non-standardized profit sharing plan, pre-approved by the IRS. The IRS issued an opinion letter dated August 31, 2020, that the plan is acceptable in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believe that the Plan is qualified and related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 9. PROHIBITED TRANSACTIONS:** In a prior year, the Company erroneously failed to remit certain employee deferrals to the Plan aggregating \$2,040. During the period from January 1, 2022 through October 14, 2022, the Company remitted these deposits and made a contribution for lost earnings to the Plan.

10. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
