We have performed an audit of the financial statements of Illuminate Education, Inc. Retirement 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 7, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

Plan Termination

1. Summary of significant accounting policies

The following is a summary of the significant accounting policies followed by Illuminate Education, Inc. Retirement 401(k) Plan (the Plan) which is sponsored by Illuminate Education, Inc. (the Company). The policies conform with accounting principles generally accepted in the United States of America, which require management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

a. Investments

Investments in insurance company pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents approximate fair value determined by quoted market price. The stable value fund, which is a benefit-responsive investment contract, is valued at contract value. Purchases and sales of securities are recorded on a trade-date basis and interest income is recorded on an accrual basis. Most investment options have management fees that reduce the overall return on assets. Net appreciation (depreciation) is inclusive of those fees.

b. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

c. Payment of benefits

Benefits are recorded when paid.

d. Administrative expenses

Most administrative expenses are paid directly by the Plan. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses.

e. Income taxes

Effective January 1, 2022, the Plan is utilizing a pre-approved document sponsored by CCH Incorporated DBA FtWilliam COM. The document sponsor received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service, which states that the Plan qualifies under the applicable provisions of the Internal Revenue Code. Prior to January 1, 2022, the Plan was utilizing a volume submitter document sponsored by Vaccaro & Prisco LLP. The document sponsor received a favorable opinion letter dated March 31, 2014 from the Internal Revenue Service, which states that the document qualifies under the applicable provisions of the Internal Revenue Code.

e. Income taxes, continued

Although the Plan has been amended since receiving the favorable opinion letters, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. However, the Plan is subject to examination; generally for a period of three years from filing its Form 5500.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

f. Concentrations of risk

The Plan provides for various investment fund options, which in turn invest in any combination of mutual funds and other investments. Investments are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the changes in net assets available for benefits.

2. Description of plan

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan, established January 1, 2012, is a defined contribution 401(k) plan. There are no age or service requirements for an employee to be eligible for participant contributions and employer match. Employees may become participants coinciding with or next following completion of the eligibility requirements. For purposes of non-elective employer contributions employees may become participants on the first day of the plan year or the seventh month of the plan year, coinciding with or next following completion of eligibility requirements. Eligibility requirements for non-elective contributions are age 21 and completion of one year of service. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Each participant may make salary deferral contributions of up to 100% of his/her annual compensation, not to exceed the annual deferral limit set by the Internal Revenue Code. Catch-up contributions are permitted for participants age 50 and older. The Plan also allows participants to make rollover contributions.

b. Contributions

The Company may also make a discretionary contribution to all eligible participants. The exact percentage or amount is determined annually by the Company and allocated based on the plan document. For the periods ended October 7, 2022 and December 31, 2021, the Company made discretionary matching contributions in the amount of \$396,034, net of forfeitures and \$1,195,894. Employees who are employed on the last day of the plan year are eligible to receive a portion of the matching contribution. The last day of the Plan year for the period ended October 7, 2022 was March 31, 2022, the date the Plan was terminated.

c. Vesting

Each participant is immediately vested in his/her salary deferral, catch-up, and rollover contributions, and any earnings or losses on those contributions. The remainder of a participant's account balance is vested based on years of service. Participants hired on or after April 15, 2015 vest at 100% after three years of service, participants hired before April 15, 2015 vest at 20% after one year of service, 40% after two years of service, and participants are fully vested after three years of service. As of January 1, 2019, the employee vests at 33% after one year, 67% after two years, and 100% after 3 years.

Forfeited non-vested matching and discretionary profit sharing contributions may be used to pay plan expenses or to reduce the Company's matching and discretionary profit sharing contributions. At December 31, 2021, forfeited, non-vested accounts totaled \$60,336. For the Plan year ended October 7, 2022, forfeitures of \$71,004 were used to reduce employer contributions and \$30,091 of forfeitures were used to pay plan expenses.

d. Participant accounts

Each participant's account is credited with the participant's salary deferral, catch-up, and rollover contributions, Company matching and discretionary contributions, if applicable, and Plan earnings/losses. Plan earnings/losses are allocated based on account balances, as defined in the Plan document.

Each participant directs the investment of his/her account into various investment options offered by the Plan through Ameritas Life Insurance Corporation.

e. Payment of benefits

Each participant is entitled to Plan benefits equal to 100% of his/her vested account balance. Benefits begin upon the earliest of retirement age, termination of employment, total and permanent disability or death of the participant. Benefits can be paid in a lump-sum. Benefits are paid soon as administratively feasible following the participant's date of termination. The Plan permits hardship distributions and in-service distributions under certain circumstances.

e. Payment of benefits, continued

The Coronavirus Aid, Relief, and Economic Security ("CARES") Act was signed into law on March 27, 2020. The CARES Act allows changes to Plan distributions and loans. The Plan is permitted to implement the provision now and retrospectively adopt those provisions. The Plan sponsor elected to adopt the loan and distribution provisions of the CARES Act and effective January 1, 2022, retrospectively adopted the provisions.

f. Loans

The Plan permits participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through payroll deductions, generally over five years. The loans bear interest rates of 3.25% to 6.00%.

g. Plan termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant will become fully vested in his/her account. Effective March 31, 2022, the Plan has been formally terminated and all participants were fully vested as of that date.

h. Corrective distributions

Corrective distributions represent refunds due to participants for contributions made in excess of amounts allowed by Plan provisions.

i. Participant distributions payable

Participant distributions payable represent distributions owed to participants due to incorrect vesting applied.

4. Fully benefit-responsive investment contract

The Plan entered into a benefit-responsive investment contract with Ameritas Life Insurance Corporation (Ameritas). Ameritas maintains the contributions in a general fixed rate account. The SVF issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the fixed rate option is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Ameritas, represents contributions made under the contract, plus earnings, less participant withdrawals and applicable expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events that are not in the ordinary course of fund operations may limit the ability of the Plan to transact at contract value with the issuer. During the Plan year ended October 7, 2022, the value of the fixed account was reduced by \$108,000 due to the market value adjustment from the Plan termination.

5. Fair value measurements

Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements (FASB ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 07, 2022 and December 31, 2021, respectively.

Pooled separate accounts: valued based on the NAV of the mutual fund(s) held by the pooled separate account (PSA), but the value of the PSA is not publicly quoted.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Party-in-interest transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan Sponsor, Custodian of the Plan assets, record keeper, investment advisor and other service providers are considered parties-in-interest with respect to the Plan. Certain Plan investments are shares of pooled separate accounts managed by the Custodian. The Plan issues loans to participants, which are secured by the balance in the participant's account. Such transactions are party-in-interest and related party transactions for which a statutory exemption exists.

7. Subsequent Events

Management reviewed the financial statements for subsequent events through August 14, 2023, the date the financial statements were available to be issued.
