Independent Auditor's Report

Report on the Financial Statements

We were engaged to audit the accompanying financial statements of Holman Professional Counseling 401k Plan (the Plan), which comprise the Statements of Net Assets Available for Benefits as the December 31, 2019 and 2018, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2019, and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on conducting the audit in accordance with auditing standards generally accepted in the United States of America. Because of the matter described in the Basis for Disclaimer of Opinion paragraph, however, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion.

Basis for Disclaimer of Opinion

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 5, which was certified by Reliance Trust Company and John Hancock Life Insurance Company, the Trustee and Insurer, respectively, of the Plan, except for comparing the information with the related information included in the financial statements. We have been informed by the plan administrator that the Trustee held the Plan's investment assets and executed investment transactions as of December 31, 2019, and for the period from April 23 to December 31, 2019, and that the Insurer held the Plan's investment assets and executed investment transactions as of December 31, 2018, and for the period from January 1 to April 22, 2019. The plan administrator has obtained a certification from the Trustee and Insurer as of and for the years ended December 31, 2019 and 2018, that the information provided to the plan administrator by the Trustee and Insurer is complete and accurate.

Disclaimer of Opinion

Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we have not been able to obtain sufficient audit evidence to provide a basis for an audit opinion. Accordingly, we do not express an opinion on these financial statements.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) is required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and is presented for the purpose of additional analysis and is not a required part of the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we do not express an opinion on the supplemental schedule referred to above.

Other Matter – Reaudit of the 2019 Financial Statements

The 2019 financial statements of the Plan were previously audited by predecessor auditors. In their report dated February 17, 2022, they did not express an opinion on the presentation of the 2019 financial statements and their presentation in accordance with accounting principles generally accepted in the United States of America. They did not express an opinion because of two departures from such principles: (1) as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed them to not perform, and they did not perform, any auditing procedures with respect to the information certified by a qualified institution, and (2) because of inadequacies in the Plan's prior year records, they were unable to obtain sufficient appropriate audit evidence with respect to the individual participant account balances accumulated from inception of the Plan. As described in Note 10, the employer was able to provide records to obtain sufficient appropriate audit evidence with respect to the individual participant account balances accumulated from inception of the Plan. Accordingly, our basis for disclaimer of opinion on the restated 2019 financial statements, as presented herein, is different from that expressed in the predecessor auditors' report.

Report on Form and Content in Compliance with the Department of Labor's Rules and Regulations

The form and content of the information included in the financial statements and supplemental schedules, other than that derived from the information certified by the Trustee and Insurer, have been audited by us in accordance with auditing standards generally accepted in the United States of America and, in our opinion, are presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Holman Professional Counseling 401k Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Holman Professional Counseling Centers (the Employer), who have three months of service and are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Reliance Trust Company and John Hancock Life Insurance Company are the Plan's Trustee and Insurer, respectively.

Effective April 2019, ADP became the Plan's new recordkeeper and Reliance Trust Company was appointed as the new Trustee. Accordingly, plan assets transferred to the Trustee were allocated into funds comparable to those offered by the previous Insurer. The conversion initiated a blackout period beginning April 11, 2019, and continued through to May 31, 2019. During this period, funds could not be applied to the employee-selected funds with the Trustee or withdrawn from the Plan until the conversion was completed. During this period, employee contributions continued to be withheld through payroll deductions and were deposited into the Plan and allocated into the employee-selected funds at the conclusion of the blackout period. Additionally, during 2019, the plan document was restated and the Plan's name changed from Holman Professional Counseling Employee Retirement Plan to Holman Professional Counseling 401k Plan.

Contributions

Each year, participants may contribute up to 90 percent of annual compensation as pretax or Roth deferrals, as defined in the Plan and subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer has adopted a safe harbor matching contribution provision. The Employer matches 100 percent, up to 4 percent, of eligible participant compensation. The Employer may make additional discretionary contributions. During the year ended December 31, 2019, the Employer made total contributions of \$66,971, net of forfeitures.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employer's contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Employer's discretionary contribution portion of their accounts is based on years of continuous service. A participant vests 20 percent each year until they become 100 percent vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate on all outstanding loans ranged from 5.25 to 7.50 percent. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, death, disability, or termination of employment, a participant may elect to receive the vested balance in the participant's account in a lump sum, cash installments, or a partial distribution, or it may be rolled into a different individual retirement account.

Forfeited and Unallocated Accounts

At December 31, 2019 and 2018, forfeited nonvested and unallocated accounts totaled \$6,596 and \$1,255, respectively. These accounts will be used to reduce future employer contributions or pay for plan expenses. For the 2019 year ended, forfeited nonvested and unallocated accounts were used to pay plan expenses of \$9,436 and reduce employer contributions by \$3,709.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the Trustee and Insurer. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded for the plan year ended.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through March 2, 2023, the date the financial statements were available to be issued.

3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2019 and 2018.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at NAV as a practical expedient and reported by the issuer. The NAV practical expedient is based on the fair value of a variety of underlying assets owned by the common/collective trust, minus its liabilities, and then divided by the number of units outstanding. The investment objectives and underlying investments of the common/collective trusts can vary with some geared towards capital preservation, target retirement dates, bond indices, international equity, and domestic equity. Common/collective trusts held by the Plan may be redeemed at NAV daily without restriction.

Pooled separate accounts: Valued at NAV of units held by the Plan as a practical expedient and reported by the Insurer. The NAV is based on the fair value of the underlying investments held by the pooled separate account, which are typically mutual funds or other marketable securities, less its liabilities, and then divided by the number of units outstanding. The NAV of pooled separate accounts are not publicly quoted in an active market. Pooled separate accounts held by the Plan may be redeemed at NAV daily without restriction.

All the Plan's investments have been valued at NAV as of December 31, 2018, and therefore have not been classified and reported within the fair value hierarchy.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

5. Certified Information

Certain information related to investments and notes receivable from participants presented in the financial statements, accompanying notes to the financial statements, and supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) was certified as complete and accurate by the Trustee and Insurer of the Plan. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has instructed the Plan's independent auditors not to perform auditing procedures with respect to the certified information, except for comparing such information included in the financial statements and supplemental schedule.

The information certified by the Trustee and Insurer includes the balances of investments held and notes receivable from participants as of December 31, 2019 and 2018, and related investment earnings and interest income on notes receivable from participants for the year ended December 31, 2019.

6. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated July 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100 percent vested in their accounts.

8. Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee and Insurer of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

10. Reaudit of the 2019 Financial Statements

The 2019 financial statements were previously audited by a predecessor auditor. In their report dated February 17, 2022, they did not express an opinion on the Plan’s financial statements due to not being able to obtain sufficient appropriate audit evidence relating to individual participant account balances accumulated from inception of the Plan. Management of the Employer has since been able to recover prior year records believed by management to be sufficient for a successor auditor when provided with this information to obtain sufficient appropriate audit evidence with respect to the individual participant account balances accumulated from inception of the Plan. Accordingly, the Employer engaged a successor auditor to reaudit and complete a Department of Labor limited-scope audit for 2019 as permissible by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

11. Subsequent Event – CARES Act

In March 2020, the Coronavirus Aid, Relief and Economic Security (CARES) Act was passed by the Federal Government of the United States which contained several temporary provisions available to the Plan and its participants. These provisions allowed participants that have been affected by the COVID-19 pandemic to request for new loans with expanded limits, defer loan repayments, suspend required minimum distributions, and withdraw up to \$100,000 without the 10% early withdrawal penalty and can be repaid over three years. These temporary provisions expired during 2021. Employers that adopted the temporary provisions must formally amend their plans prior to the end of the 2025 plan year.

12. Subsequent Event – Partial Plan Termination

During 2021, the Employer experienced operational challenges caused by the COVID-19 pandemic. As a result, employees were terminated in a significant employee layoff event. In total, the participants terminated amounted to more than 20% of plan participants and, accordingly, the plan sponsor determined that a partial plan termination had occurred. All participants who were affected by the terminations were fully vested in their account balances.
