Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Valley Truck and Tractor Co. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2022, and December 31, 2021; the related statement of changes in net assets available for benefits for the ten months ended October 31, 2022, and the year ended December 31, 2021; and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the ten months ended October 31, 2022, and year ended December 31, 2021, stating that the certified investment information, as described in note 4 to the financial statements, is complete and accurate.

As further discussed in note 1 to the financial statements, the Board of Directors of the Valley Truck and Tractor Co., the Plan's sponsor, voted on October 31, 2022, to terminate the Plan and management determined liquidation is imminent. As a result, the Plan is using the liquidation basis of accounting used in presenting the 2022 and 2021 financial statements. As of October 31, 2022, all of the assets of Plan have been distributed and the Plan has ceased operations as of that date. Our opinion is not modified with respect to this matter.

NOTES TO THE FINANCIAL STATEMENTS

1. PLAN TERMINATION

In December 2021, the Board of Directors of Valley Truck and Tractor Co. (the Company), unanimously approved the liquidation of all of the investments currently held by Valley Truck and Tractor Co. 401(k) Profit Sharing Plan (the Plan). The Company is the Plan's sponsor and a party in interest of the Plan. Effective December 2021, the Plan began contacting participants to request distribution information. As of the date of termination, all participation in the Plan was frozen, the Company ceased to provide contributions, and all participants became fully vested in their account balances. As of October 31, 2022, all of the assets of Plan have been distributed and the Plan has ceased operations as of that date.

2. DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General The Plan is a defined contribution plan covering substantially all employees of the Company. Prior to termination, there was no service requirement for employee 401(k) salary deferrals and Company discretionary nonelective profit sharing contributions; however, there was a six-month service requirement for Company discretionary matching contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan was originally established as of January 1, 1994, and has been subsequently amended and restated. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

Contributions Prior to termination, participants elected to contribute to the Plan, in the form of employee 401(k) salary deferral contributions (pre-tax 401(k) deferrals and Roth 401(k) deferrals), up to the lesser of 90% of their eligible compensation or the maximum amount allowable by law. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also allowed to contribute amounts representing distributions from other qualified retirement plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Company was allowed to make discretionary matching contributions and discretionary nonelective profit sharing contributions to the Plan prior to termination. There were no Company contributions made to the Plan for the ten months ended October 31, 2022. The Company made discretionary matching contributions of \$219,628 for the year ended December 31, 2021. The Company did not make discretionary nonelective profit sharing contributions for the year ended December 31, 2021.

Automatic Enrollment Prior to termination, employees eligible to participate in the Plan were automatically enrolled upon meeting the eligibility requirements noted above. Unless otherwise directed, the rate of deferral upon enrollment was 3% of eligible compensation on a pre-tax basis, to be invested in specific pre-selected investment offerings.

The Company's discretionary nonelective profit sharing contribution allocations are based on a participant's eligible compensation, relative to total eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Participants became fully vested in their accounts upon termination of the Plan.

Notes Receivable From Participants Prior to termination, participants could borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note receivable repayment terms generally could not exceed five years, except in the case of the purchase of a primary residence. The notes receivable are secured by the balances in the participants' accounts. The notes receivable interest rate, determined monthly, is set at 1% above the prime rate, as defined. Prior to termination, principal and interest were paid ratably through semimonthly payroll deductions.

Payment of Benefits Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59½. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the *Internal Revenue Code* (IRC). Payments are made in the form of a lump-sum distribution or annual installments over a period of time of not more than the participant's life expectancy.

As of October 31, 2022, and December 31, 2021, there were no amounts allocated to participants who elected to withdraw from the Plan but have not yet been paid.

Forfeitures Participants became fully vested in their accounts upon termination of the Plan. Forfeitures attributable to discretionary matching contributions and discretionary nonelective profit sharing contributions made prior to August 1, 2016, may first be used to pay any administrative expenses. Any remaining forfeitures will be allocated in the same proportion that each participant's compensation bears to the total of all participants. Forfeited nonvested account balances of \$5,715 and \$-0- were used to reduce administrative expenses for the ten months ended October 31, 2022, and the year ended December 31, 2021, respectively. At October 31, 2022, and December 31, 2021, the remaining forfeited nonvested accounts totaled \$-0- and \$1,303, respectively.

3. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The financial statements were prepared under the liquidation basis of accounting, which is consistent with the Company's Board of Directors' decision to terminate the Plan. Under the liquidation basis of accounting, the Plan is required to accrue, and separately present, the costs that it expects to incur and the income that it expects to earn through the liquidation date. This method is in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2021.

Mutual Funds: Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

See note 5 for the classification of these assets within the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable From Participants Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. No allowance for credit losses was recorded as of December 31, 2021. Delinquent participant notes receivable are recorded as distributions in accordance with the terms of the Plan agreement.

Payment of Benefits Benefits are recorded when paid.

Expenses Certain operating expenses of the Plan are deducted from participant accounts and the remaining expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through August 15, 2023, the date the financial statements were available to be issued.

4. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments and notes receivable from participants included in the statements of net assets available for benefits, and the investment income (loss) and interest income on notes receivable from participants included in the statements of changes in net assets available for benefits as of and for the ten months ended October 31, 2022, and as of and for the year ended December 31, 2021, were not subject to auditing procedures and have been certified as complete and accurate by Reliance Trust Company.

6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Automatic Data Processing, Inc. (ADP), and Morgan Stanley, LLC (MS) provide certain administrative and investment advisory services to the Plan pursuant to an agreement between the Company and ADP and MS. ADP and MS receive revenue from mutual funds and other service providers for services provided to the funds. This revenue is used to offset certain amounts owed to ADP and MS for administrative and investment advisory services to the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by ADP or MS from investment providers exceeds the amount owed under the agreement, ADP or MS remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Company may make a payment to ADP or MS for administrative services not covered by revenue sharing.

7. TAX STATUS

The Plan has adopted a prototype non-standardized profit sharing plan established by ADP. The prototype plan obtained an opinion letter on July 16, 2014, in which the Internal Revenue Service stated that the form of the prototype plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since adopting the prototype plan, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
