## INDEPENDENT AUDITOR'S REPORT

To the Administrators of  
Town & Country Credit Union 401(k) Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Town & Country Credit Union 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Town & Country Credit Union 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America

- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Town & Country Credit Union 401(k) Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Town & Country Credit Union 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions. Effective December 31, 2022, the Plan assets were transferred to a multiple employer plan. See Note 9 for further information.

**General**

The Plan is a defined contribution safe harbor plan covering all employees of the Company and the participating employer, Town and Country Insurance Agency, who have worked for the Company for more than three months and who have attained eighteen years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. The provider, CMFG Life Insurance Company, maintains the records of the participant data and certifies participant loan activity. The trustee, Matrix Trust Company, serves as trustee for the Plan assets and certifies the investment activity.

**Contributions**

Employees may have a percent or dollar amount of their compensation withheld by the employer to contribute to the Plan. These elective deferrals may not exceed 100% of their compensation or IRS limits. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. The Company provides a safe harbor matching contribution equivalent to 100% of the participant's elective deferrals that do not exceed 4%. The Plan also provides a discretionary profit sharing feature. The profit sharing contribution provided by the Company during the years ended December 31, 2022 and 2021 was equivalent to 3% of each eligible employee's taxable compensation.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contribution and profit sharing contribution, if any. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

For the profit sharing feature, the employer contributions are discretionary and thus are only made each year the employer decides to do so. These decisions to contribute are made separately by the Company. When contributions are made, they are allocated among employees of the Company based on a level of compensation.

**Participant's Investment Options**

Participants must direct their salary deferral contributions and Company matching and profit sharing contributions to selected investments as offered by the Plan. Participants may change their investment options throughout the year.

**Note Receivable from Participants**

Participants may borrow from their fund accounts in any amount greater than \$1,000 up to a maximum of \$50,000 or 50 percent of the participant's vested account balance, for a term not to exceed five years (fifteen years in cases where the loan proceeds are used to purchase the participant's principal residence). Notes receivable from participants will bear an interest rate of 1 percentage point over the prime interest rate. Principal and interest are paid ratably during the year through payroll deductions and credited to the participant's account. All outstanding balances are due in their entirety upon the occurrence of a distributable event.

**Vesting**

Participants are immediately vested in their voluntary contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

**Payment of Benefits**

If a participant is married on the date his or her benefits are to begin, he or she will automatically receive a joint and 50% survivor annuity unless an alternative form of payment is selected. This means that the participant will receive payments for life, and after the participant's death, the surviving spouse will receive a monthly benefit for the remainder of his or her life equal to 50% of the benefit the participant was receiving at the time of his or her death.

If a participant is unmarried on the date his or her benefits are to begin, he or she will automatically receive a life annuity, unless an alternative form of payment is selected. This means that the participant will receive payments for as long as he or she lives. If a vested account balance does not exceed \$5,000, then the vested account balance may only be distributed in a single lump-sum payment.

Alternative forms of payment may be selected such as a single lump-sum payment, installments over a period of not more than your assumed life expectancy, partial withdrawals, or the purchase of a different form of annuity.

Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 ½ to qualify for in-service retirement distributions.

In addition, distributions are required to begin no later than the April 1<sup>st</sup> following the later of the end of the year in which a participant reaches age 72 or retires.

**Forfeitures**

The nonvested portion of a paid participant's balance can be used to reduce the Company's discretionary profit sharing and safe harbor matching contributions or pay plan expenses. At December 31, 2022 and 2021, there were no forfeitures outstanding. Employer contributions were reduced by \$87,794 and \$46,909 of forfeited account assets for the years ended December 31, 2022 and 2021, respectively. In addition, plan expenses of \$1,400 were paid from the forfeited account assets for the year ended December 31, 2022.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the guaranteed investment account, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the Plan provider and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statement of changes in net assets available for benefits.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Administrative Fees**

The investment funds in the Plan are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Recordkeeping expenses are paid from Plan assets and are disclosed on the face of the financial statements. Other administrative expenses that are paid by the Company are not reflected in the accompanying financial statements.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit loss has been recorded at December 31, 2022 and 2021.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2022 and 2021.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the net asset value of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan had no assets measured at fair value as of December 31, 2022, as all assets were transferred out of the Plan. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan investments include the CUNA Mutual Stable Value Account, which is a deposit administration group annuity contract guaranteed investment account product. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract is a fixed, deferred group annuity. It provides guaranteed protection of principal with a set rate of return, which was 1.65% and 1.25%, as of December 31, 2022 and 2021, respectively. The funds seek a high level of current income consistent with preservation of capital by investing primarily in corporate bonds, mortgage-backed securities, collateralized mortgage obligations, high quality commercial mortgage loans, municipal bonds and other high-grade fixed income securities. The Stable Value Account is guaranteed by CMFG Life Insurance Company. In addition to the events that limits the Plan's ability to transact at contract value, CMFG Life Insurance Company reserves the right to defer any withdrawal from the guaranteed investment account for a period not exceeding six months if they reasonably determine that investment conditions are such that an orderly sale of the assets held as part of its general assets is not possible.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401 (a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501 (a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

**NOTE 6 INCOME TAX STATUS**

The Plan is a Non-Standardized Defined Contribution Pre-Approved Plan sponsored by the provider (CMFG Life Insurance Company) and adopted by the Company. The Internal Revenue Service informed the provider by an advisory letter dated June 30, 2020, that the Non-Standardized Defined Contribution Pre-Approved Plan is acceptable under Section 401 of the Internal Revenue Code. The Company and plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Fees paid to and disclosed on the Statement of Changes in Net Assets to CMFG Life Insurance Company for recordkeeping, distribution processing and loan servicing amounted to \$71,499 and \$72,942 for the years ended December 31, 2022 and 2021, respectively.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 TRANSFER TO THE CREDIT UNION RETIREMENT PLAN ASSOCIATION 401(K) PLAN**

Effective December 31, 2022, the Plan merged and transferred all assets to a multiple employer plan, Credit Union Retirement Association 401(k) Plan.

**NOTE 10 SUBSEQUENT EVENTS**

No significant events have occurred subsequent to the Plan's year end. Subsequent events have been evaluated through July 9, 2023, which is the date these financial statements were available to be issued.
