### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Triton Diving Service 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 28, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period ended October 28, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Triton Diving Service 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 28, 2022 and December 31, 2021, and for the period ended October 28, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Triton Diving Service 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note 5 to the financial statements, the plan sponsor of Triton Diving Service 401(k) Plan voted on August 12, 2022, to terminate the plan and management determined liquidation is imminent. As a result, the Triton Diving Service 401(k) Plan changed its basis of accounting from the accrual basis of accounting used in the presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Triton Diving Service 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

1) Description of plan

The following description of the Triton Diving Service 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

Prior to termination, the Plan was a defined contribution plan covering substantially all employees of Triton Diving Services, LLC (the Company or Employer) who were twenty-one years of age and who had three months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Prior to termination of the Plan, participants could make elective contributions to the Plan up to the statutory maximum dollar amount for the year. In addition, a participant who had attained age 50 before the close of the Plan year was eligible to make catch-up contributions in accordance with limitations under the Internal Revenue Code. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan allowed an Employer matching contribution for all employees actively employed at the end of the Plan year. The Plan elected to not make an Employer match in 2022 and 2021. Additional profit-sharing amounts could be contributed at the option of the Company's management. No profit-sharing contributions were made by the Company for the period ended October 28, 2022, and year ended December 31, 2021. Contributions are subject to certain IRS limitations.

(c) Participant accounts

Prior to termination of the Plan, each participant's account was credited with the participant's contribution and allocation of the Company contributions and Plan earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Prior to termination of the Plan, participants were immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions of their accounts were based on the following vesting schedule:

(e) Payment of benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or installments, equal to the value of the vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants may also receive in-service withdrawals for their vested account balance upon reaching 59 ½ years of age. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

(f) Investment options

Prior to termination of the Plan, upon enrollment in the Plan, a participant could direct employee and Employer contributions in a variety of investment options. Participants could change their investment allocations any time via telephone, internet, or written instructions.

(g) Forfeitures

Prior to termination of the Plan, when termination of participation in the Plan occurred, the non-vested portion of the participant's account, as defined by the Plan, represented forfeitures. Forfeitures of Employer matching contributions were used to reduce administrative expenses and Employer contributions. In 2022, \$515 in forfeitures were used to pay administrative expenses. Forfeitures available to offset future Employer contributions and administrative expenses at October 28, 2022 and December 31, 2021 were \$-0- and \$515, respectively.

(h) Note receivable - participant loans

Prior to termination of the Plan, participants could borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the excess of the highest outstanding balance of the participant's loan during the last one-year period. Loans were restricted to vested dollars only. The loans were secured by the balance in the participant's account. Interest rates were determined by the plan administrator. Interest rates on loans ranged from 6.00% to 6.50%. Loans must be repaid through payroll deductions with a maximum loan term of five years, unless the loan is for the purchase of a participant's primary residence. A loan origination fee and annual loan processing fees were charged to participants who borrowed from their account.

2) Summary of accounting policies

(a) Basis of accounting

The accompanying financial statements of the Plan are presented on the liquidation basis of account for the period ended October 28, 2022, and the accrual basis for the year ended December 31, 2021.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Notes receivable – participant loans

Participant loans are classified as notes receivable – participant loans and are measured at the unpaid balance plus unpaid accrued interest. The Plan classifies all participant loans in default when any scheduled payment remains unpaid beyond the last date of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statements of changes in net assets available for benefits. During 2022 and 2021, no deemed distributions were recorded.

(e) Use of estimates

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Administrative expenses

The Plan sponsor absorbs significant administrative costs of the Plan. Administration expenses paid by the Plan arise from processing fees for loans and distributions that are charges to their respected participants' accounts.

3) Investments

During the period ended October 28, 2022 and year ended December 31, 2021, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) (depreciated) appreciated in value by \$(430,137) and \$264,267, respectively.

4) Federal income tax status

The Plan has adopted a prototype plan document that was amended and restated effective January 1, 2015. The prototype plan received a favorable opinion letter from the Internal Revenue Service dated March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the letter, including amendments made to comply with recent law changes. The Plan itself has not separately applied for a determination letter; however, the plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is not subject to United States federal and state income tax examinations by tax authorities beyond three years from the filing of those returns.

5) Plan termination

On August 12, 2022, the Plan sponsor approved the termination of the Plan. Subsequent to August 12, 2022, no contributions, loan payments, or new loans were allowed into the Plan, and no distributions or rollovers were allowed subsequent to August 12, 2022 to October 28, 2022. All plan assets were distributed as of October 28, 2022.

6) Information certified by the trustee (unaudited)

The following is a summary of the investment information regarding the Plan as of October 28, 2022 and 2021, and for the years ended October 28, 2022 and 2021, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Ascensus Trust Company, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the custodian that such information is complete and accurate.

7) Related party transactions

Certain Plan investments are units of mutual funds managed by Ascensus Trust Company, the trustee of the Plan; therefore, these transactions qualified as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

8) Risk/uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9) Fair value measurement

Accounting Standards Codification 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 28, 2022 or December 31, 2021.

*Mutual funds:* Valued at the net asset value of shares held by the Plan at year end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different measurement at the reporting date.
