Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MarketLab, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). NOTE 1 – DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for more of a complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of MarketLab, Inc. and its subsidiaries who had attained 90 days of service as defined by the Plan and were at least 18 years of age. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 23, 2021, the merger of this Plan into the Windquest Group 401(k) Retirement Savings Plan (Windquest Plan) was approved, effective December 31, 2021. All assets were subsequently transferred from the Plan in the Windquest Plan on January 21, 2022.

Participant and Employer Contributions

Contributions to the Plan were made as follows:

Participants

Each year, participants could contribute up to 100% of base compensation up to the statutory limit. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants could direct the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds as investment options for participants.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan, unless they affirmatively elected not to participate, with a default deferral rate set at 6% of eligible compensation. Contributions were automatically invested in a designated balanced fund until changed by the participant.

Employer Matching Contributions

The Company could make a discretionary matching contribution to the Plan on behalf of each participant that contributed to the Plan. There were no employer matching contributions to the plan for the short year ended January 21, 2022. For 2021, the contributions were equal to 50% of the first 6% of base compensation that a participant contributed to the Plan.

Employer Discretionary Profit Sharing Contributions

The Company could make a discretionary profit sharing contribution to the Plan in an amount determined by management. Discretionary contributions were allocated on a ratio of each participant's compensation to total compensation. There was no such contribution for 2022 and 2021.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's matching contributions, discretionary profit sharing contributions, as well as allocations of Plan earnings, and was charged with an allocation of any administrative expenses paid by the Plan. Allocations were based on investment earnings on account balances, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Vesting

Participants were 100% vested in compensation deferrals plus earnings thereon at all times.

Participants were vested in employer matching and discretionary contributions according to the following schedule:

0%	Less than 1 year
20%	after 1 years of service
40%	after 2 years of service
60%	after 3 years of service
80%	after 4 years of service
100%	after 5 years of service

Participants were 100% vested if they die, become disabled, or attain retirement age prior to termination of employment.

Payment of Benefits

Upon termination of services, a participant could elect to receive their vested interest as a lump sum payment. In-service and hardship distributions were permitted pursuant to the terms of the Plan.

Forfeited Accounts

At January 21, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$-0- and \$7,535, respectively. These accounts were to be used to reduce future employer contributions or pay certain administrative expenses. As of January 21, 2022 forfeitures totaling \$7,491 were transferred to the Windquest Plan. For 2021, the Company applied forfeitures of \$23,218 to administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year. All Plan assets were transferred to the Windquest Plan on January 21, 2022.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review

Management has evaluated subsequent transactions and events through August 15, 2023, the date these financial statements were available to be issued, and has determined that no items require additional disclosure, except for the merger as described in Note 1.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company was the trustee as defined by the Plan and, therefore, qualified as a party-in-interest. Fees paid by the Plan for their services were included in administrative expenses.

Administrative expenses also included payments made to SA Advisory, LLC for investment advisory services. SA Advisory, LLC was the Plan’s investment advisor and therefore, these transactions qualified as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 5 – TAX STATUS

The Internal Revenue Service (IRS) had determined and informed the Company by a letter dated March 16, 2017, that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the determination letter, the Plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC and therefore believed that the Plan was qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to December 31, 2019.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
