The estimate of the fair value of the investments held in mutual funds is based on the NAV, as provided by the administrator of the fund, and calculated daily at the close of business.

We evaluated they key factors and assumptions used to develop the fair value in determining that it is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements.
