Dear Sir or Madam:

Please accept this letter along with the filing of the Federal Form 5500. I would like to abate any penalties or interest that may be assessed for the filing of the Federal Form 5500 for the period ending December 31, 2022. I believe, I have reasonable cause to abate any assessed penalties that may be imposed.

I am respectfully requesting an abatement of the penalties associated with the filing of the information return based on reasonable cause. There was a miscommunication between me and the provider (ADP) of the 401(k) as to the correct procedures in the filing and preparation of the Federal Form 5500. I was made aware that ADP did not file the Federal Form 5500 in a timely manner for the plan. Once I became aware of this, I immediately took the necessary steps to file a complete and file an accurate return. I also believe that this return is an information return only and there is no tax due. I did rely on a third party who is in this profession and prepares and files these returns as part of their business. I have now implemented steps necessary to prevent this from occurring in the future.

Based on the above facts, I am respectfully requesting that any penalties associated with the filing of this return be abated, on the grounds of reasonable cause.
