## Independent Auditor's Report

### To the Trustees of the Liquidnet Holdings, Inc. 401(k) Retirement Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Liquidnet Holdings, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Liquidnet Holdings, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## Notes to Financial Statements December 31, 2022 and 2021

### 1. Plan Description

The following brief description of the Liquidnet Holdings, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description and plan document for a complete description of the Plan’s provisions.

#### General

The Plan was established on January 1, 2001 and is a defined contribution plan covering all employees, excluding interns and leased employees, of the Liquidnet Holdings, Inc. (the “Company”) who are age 18 or older and who have satisfied the Plan’s eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 30 2022, the sponsor adopted the provisions of the TP ICAP 401(k) Plan, which is sponsored by Liquidnet Holdings, Inc’s parent company. As a result, effective December 30, 2022 the plan was merged with the TP ICAP 401(k) Plan and the assets were transferred.

#### Contributions

Each year, participants may contribute the maximum amount allowed by the Internal Revenue Service (“IRS”). Employees become eligible to make elective deferrals of their own funds to the Plan as soon as administratively possible following their first day of employment. Eligible employees are automatically enrolled at a rate of 6%. Employer matching contributions commence on the first of the month following 6 months of service. Participants who will have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans or eligible IRAs in the form of rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. A participant may irrevocably designate all or any part of his or her elective deferrals to the Plan as Roth 401(k) deferrals. IRS limitations for 2022 are \$20,500 for employee elective deferrals and \$6,500 for catch-up contributions for those age 50 and over.

The Company makes a safe harbor matching contribution in the amount of 100%, up to the first 6% of the participant’s eligible compensation that a participant contributes for each Plan year. Company safe harbor matching contributions are invested according to the same investment elections that the participant has set for their own contributions. The Company may also make a discretionary profit sharing contribution. Through December 31, 2022, the Company has elected not to make a discretionary profit sharing contribution.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s safe harbor matching contribution and (b) net investment earnings or losses of the investments in which the participant’s account is invested. The benefit to which a participant is entitled is the participant’s vested account balance.

#### Vesting

Participants are vested immediately in their contributions plus actual investment income or loss thereon. A participant is also immediately 100% vested in the Company’s safe harbor matching contribution. Vesting in discretionary profit sharing contributions is based on years of continuous service in accordance with Plan provisions.

### **Forfeitures**

Balances in forfeited accounts will be used to reduce future employer contributions and Plan expenses in accordance with the Plan document. There were forfeitures of approximately \$0 and \$1,000 for the years ended December 31, 2022 and 2021, respectively. The Company utilized approximately \$0 and \$21,000 of forfeitures were used for employer contributions and fees, respectively. The balances in the forfeiture account as of December 31, 2022 and 2021 were \$0.

### **Notes Receivable from Participants**

Participants may borrow from their investment account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans are to be repaid within five years, unless participants are using the loan to purchase their principal residence or are on authorized leave for military service for a period which extends the maturity date of the loan beyond five years. If the participant is using the loan to purchase their principal residence, the repayment period may be set for a loan term that will extend up to thirty years. Loans are collateralized by the balance in a participant's account and bear interest at a rate of prime plus 1% as determined on the origination date of the loan. Principal and interest is amortized and repaid through semi-monthly payroll deductions and the paid interest is credited to the participant's account. Participants are responsible for loan set-up fees. A participant may have a maximum of one outstanding loan at one time. All outstanding loans were transferred to the TP ICAP 401(k) Plan effective December 30, 2022.

### **Payment of Benefits**

Eligible participants may elect to receive a lump-sum payment equal to the value of the participant's vested balance in their account. Participants are eligible for payment of benefits upon termination of employment before normal retirement age, disability, attaining normal retirement age but continuing to work, attaining age 59-½ but continuing to work, or retirement.

### **Administrative Costs**

Administrative costs of the Plan are paid by the Plan at the discretion of the Plan administrator. All remaining administrative costs are paid by the Company. Fees related to the administration of participant loans are paid by the participants from their account balances. Management charges a quarterly fixed administrative fee of \$28.75 per participant account to help fund expenses of the Plan. Additionally, there are a number of investment options that have a revenue sharing component that provide for partial reimbursement of Plan expenses. It is management's goal to eliminate all revenue sharing funds when administratively possible. Until such time, all revenues generated by those funds charging a revenue sharing fee were refunded to participant.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of investment income and expenses during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Shares of mutual funds are valued at unadjusted quoted market prices, which represent the net asset value of the shares held by the Plan at yearend. Listed equities in the Personal Choice Retirement Account are valued using closing year-end prices.

The net depreciation in the fair value of Plan investments consists of the realized gains or losses and the net unrealized depreciation of those investments.

## Liquidnet Holdings, Inc. 401(k) Retirement Plan

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

### Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid balances plus accrued interest.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Management evaluated subsequent events for the Plan through July 28, 2023, the date the financial statements were available to be issued.

## 3. Risks and Uncertainties

The Plan invests in various mutual funds and common collective trusts which in turn invest in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could have a material adverse effect on participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 4. Information Certified by the Custodian

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the following information for December 31, 2022 and 2021 was derived from the information certified as to completeness and accuracy by Charles Schwab Trust Bank, the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodians that such information is complete and accurate.

## 5. Fair Value Measurements

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Quoted prices in active markets for identical assets or liabilities
- Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities;
- Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the asset or liability. In measuring fair value, the Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

- Mutual funds: Valued at unadjusted quoted market prices in an active market.
- Brokerage options: cash is valued at cost plus accrued interest, which approximates fair value. Mutual funds, common stock, and corporate bonds are valued at the quoted market prices in active markets of the underlying investments held by the Plan at year-end.

This method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodology used at December 31, 2022 and 2021.

### 6. Party-In-Interest Transactions

Schwab is the plan administrator and fees paid to Schwab and notes receivables from participants are considered party-in-interest transactions. Fees of \$52,198 were paid to Schwab during the year ended December 31, 2022.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its discretionary contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would remain fully vested in their account.

### 8. Income Tax Status

The Plan has adopted Charles Schwab volume submitter profit sharing plan. Charles Schwab received a favorable opinion letter dated June 19, 2014, which stated that the volume submitter profit sharing plan was designed in accordance with the application sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is designed and being operated in compliance with the applicable provisions of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by Federal, state and/or local taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2019.

### 9. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2022 for items that should potentially be recognized or disclosed herein. The evaluation was conducted through the date these financial statements were issued.
