Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gateway Plastics, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gateway Plastics, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Gateway Plastics, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan sponsored by Gateway Plastics, Inc. (the Sponsor). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. J.P. Morgan was the Plan's third party administrator and recordkeeper and Reliance Trust Company was the Plan's trustee.

On September 20, 2021, Gateway Plastics, Inc. was acquired by Silgan Holdings Inc. Effective January 1, 2023, the Plan was merged into the Silgan Retirement Savings Plan and Silgan Retirement Savings Plan for Hourly Employees. As a result, Plan assets of \$9,108,125 were transferred out of the Plan on December 31, 2022.

Eligibility

Effective September 19, 2021, employees not included under a collective bargaining agreement became eligible for employee deferrals and Sponsor discretionary matching contributions after completing six months of service and attaining age 20. Employees were eligible to receive the discretionary nonelective profit sharing contribution after attaining age 20, completing six months of service with 1,000 hours worked, and were employed at the end of the Plan year. Employees were eligible to participate in the Plan on the first day of the month subsequent to meeting eligibility requirements.

Prior to September 19, 2021, employees not included under a collective bargaining agreement became eligible for employee deferrals and Sponsor discretionary matching contributions after completing six months of service and attaining age 21. Employees were eligible to receive the discretionary nonelective profit sharing contribution after attaining age 20, completing six months of service with 1,000 hours worked, and were employed at the end of the Plan year. The Plan entry date was the first day of the quarter subsequent to meeting eligibility requirements.

Contributions

Each year, participants may have contributed up to the maximum allowed by the Internal Revenue Service (IRS). Effective September 19, 2021, participants were automatically enrolled at a 4% contribution rate unless specified otherwise. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their and the Sponsor's contributions into various investment options offered by the Plan.

Discretionary nonelective Sponsor profit sharing and discretionary Sponsor matching contributions may be contributed at the option of the Sponsor. The Sponsor did not make any discretionary nonelective contributions in 2022. During 2022, the Sponsor contributed a discretionary matching contribution equal to 50% of the first 6% of eligible compensation that a participant contributed to the Plan.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account was credited with the participant's contributions, Sponsor contributions, and allocations of related Plan earnings (losses) thereon. Participant accounts were charged when they have a withdrawal or distribution from their account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Sponsor's discretionary profit sharing and matching contributions vested according to the following schedule:

Participants were considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months.

Participants were automatically vested upon attainment of age 65 or upon retirement due to disability, death, or termination of the Plan.

Payment of Benefits

Benefits under the Plan were paid to a participant upon death, disability, retirement or termination of employment, as defined in the Plan agreement. The participant may elect to receive a single lump sum payment or installment payments. Participants with a vested account balance of less than \$1,000 were paid in a lump sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account were permitted if certain criteria are met. The Plan also allowed for in-service distributions upon attaining age 59 1/2.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's contributions. These forfeitures may have been used to reduce Sponsor contributions or may have been used to pay Plan administrative expenses in accordance with the Plan document. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0 and \$22,190, respectively. During the year ended December 31, 2022, the Sponsor contributions were reduced by \$33,752 from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Sponsor. Expenses that were paid by the Sponsor were excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through August 21, 2023, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Collective trust fund: Invests in Reliance MetLife Stable Value Series Fund, which is a common collective trust with underlying investments in fully benefit responsive contracts, and in units of an S&P 500 index fund for tax exempt retirement plans were valued at the NAV of units of the collective trust. The NAV was used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The fund does not require a redemption notice period for participants and allows participants to immediately redeem all or a portion of their investment.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation method was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

There were no assets held by the Plan as of December 31, 2022. The following table set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2021:

Note 4: Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest, and dividends for the year ended December 31, 2022, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company.

Note 5: Party-in-Interest Transactions

Transactions involving funds administered by J.P. Morgan were considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29CFR 408(b) of the ERISA regulations.

Note 6: Tax Status

The IRS has determined by a letter dated June 30, 2020, that the prototype document on which the Plan was based was designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the determination letter, the Plan Administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. The Plan Administrator was not aware of any significant uncertain tax positions taken by the Plan.

Note 7: Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities would have occurred in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits.
