## **INDEPENDENT AUDITORS' REPORT**

To the Choptank Transport, Inc. and Affiliates Retirement Savings Plan and its Participants:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Choptank Transport, Inc. and Affiliates Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – liquidation basis as of January 13, 2022 and December 31, 2021, the related statement of changes in net assets available for benefits – liquidation basis for the period ended January 13, 2022, and the related notes to the financial statements – liquidation basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Ascensus as authorized agent of Ascensus Trust Company as of January 13, 2022 and December 31, 2021 and for the period ended January 13, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Choptank Transport, Inc. and Affiliates Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Basis of Accounting**

As discussed in Notes 1 and 2 to the financial statements, effective October 18, 2021, the Plan Sponsor made the decision to terminate the Plan. All assets were removed from the Plan by January 13, 2022. The Plan presented the financial statements as of January 13, 2022 and December 31, 2021 and for the period ended January 13, 2022 on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Choptank Transport, Inc. and Affiliates Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

### 1. DESCRIPTION OF THE PLAN

The following description of the Choptank Transport, Inc. and Affiliates Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. Prior to January 1, 2013, the name of the Plan was Albert W. Sisk & Son, Inc. & Affiliates Retirement Savings Plan.

#### **General**

The Plan was a defined contribution plan established by Choptank Transport, Inc. (the Company or Plan Sponsor) effective February 1, 1992. The Plan was subject to the provisions of the Employee Retirement Income and Security Act of 1974 (ERISA). The Plan was most recently amended effective October 18, 2021 to effectuate the termination of the Plan.

#### **Plan Termination**

The Board of Directors of the Company voted to terminate the Plan effective October 18, 2021 (Plan Termination Date) and Hub Group, Inc. (Acquiring Company) completed its acquisition of the Company on October 19, 2021. Subsequent to the Plan Termination Date, the Plan began the process to distribute all assets to respective participants. All assets were distributed from the Plan as of January 13, 2022.

#### **Eligibility**

Prior to the Plan Termination Date, the Plan covered substantially all employees of the Company and its affiliates adopting the Plan who had met the Plan's eligibility requirements. Employees became eligible to participate in the salary deferral feature of the Plan on the first day of the month following the date they completed two months of service if they were eighteen years of age. Additional eligibility requirements applied to Company non-safe harbor matching and discretionary non-elective profit-sharing contributions.

#### **Participant Contributions**

Prior to the Plan Termination Date, participants could contribute up to 100% of their eligible compensation, as defined by the Plan, or a flat dollar amount, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code). The Plan allowed for Roth deferrals. The participants' Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make additional catch-up contributions, subject to limitations imposed by the Code. Participants were also permitted to make rollover contributions from other qualified plans into the Plan.

#### Company Contributions

Prior to the Plan Termination Date, the Company made non-safe harbor matching contributions equal to 50% of participant salary deferrals not to exceed 6% of eligible compensation. Such contributions were contributed and calculated on a per payroll basis, however year end true up contributions could be made at the discretion of management. Additional discretionary non-elective profit-sharing contributions could be made at the option of the Company's management. Such contributions were allocated based on relative compensation for each participant. To be eligible to receive a non-safe harbor matching and discretionary non-elective profit-sharing contributions, an employee must have completed one year of service and be at least eighteen years of age. Contributions were subject to certain limitations. The Company did not make any non-safe harbor matching contributions or discretionary non-elective profit-sharing contributions to the Plan for the period ended January 13, 2022.

#### Participant Accounts

Each participant's account was participant-directed and credited with the participant's contributions, withdrawals and allocations of a) the Company's contributions, b) Plan earnings and c) administrative expenses. Allocations of earnings and losses were based on the proportion of each participant's account balance to the total of all account balances within the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### Vesting

Participants were immediately vested in their contributions and in all Company contributions made prior to July 1, 2015, plus actual earnings thereon. Effective July 1, 2015, participants vested in Company matching and profit-sharing contributions plus earnings thereon based on years of service, as defined by the Plan agreement, according to the following schedule:

As of the Plan Termination Date, participants became 100% vested in their account balances.

#### Notes Receivable from Participants

Prior to the Plan Termination Date, the Plan did not allow for participant notes receivable.

#### Payment of Benefits

Upon termination of service, death, disability, normal retirement at age 65, early retirement age (age 60 and 20 years of service), or attainment of age 59 ½, a participant or their beneficiary, in the event of death, could elect to receive a lump sum amount equal to the value of the participant's vested balance in their account, or periodic installments, as defined by the Plan. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant could be withdrawn for hardship purposes. If a participant's account balance upon termination was less than \$5,000 and no distribution election was made by the participant, the balance could be distributed at any time without participant consent. Distributions are subject to the applicable provisions of the Plan. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. As of January 13, 2022 and December 31, 2021, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to period-end and year-end, respectively.

#### Forfeitures

Forfeitures of non-vested portions of Company contributions were to be used first, if and as directed by the Plan administrator, to reduce administrative expenses or to reduce future Company contributions. As of January 13, 2022 and December 31, 2021, there were no forfeitures available to be applied.

#### Plan Expenses

All expenses were paid with assets of the Plan, unless paid by the Company, at its discretion. During the period ended January 13, 2022, the Company paid a portion of the direct expenses related to the Plan. Plan expenses paid by the Company are excluded from the Plan's financial statements. Distribution fees were paid by the Plan and its participants. Investment related expenses are included in net depreciation in fair value of investments.

### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

As described in Note 1, the Plan terminated effective October 18, 2021. The Plan's financial statements are presented using the liquidation basis of accounting as of January 13, 2022 and December 31, 2021 and for the period ended January 13, 2022, in accordance with accounting principles generally accepted in the United States of America.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted within the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits in liquidation and deductions from net assets available for benefits in liquidation during the reporting period. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan provides for investments in assets that are exposed to risks, such as interest rate risk, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect participant account balances and the amounts reported in the statements of net assets available for benefits – liquidation basis.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

*Interests in common/collective trust funds:* Valued at the net asset value (NAV) using practical expedient determined by the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of January 13, 2022 and December 31, 2021.

The Plan held no investments as of January 13, 2022.

### 4. INCOME TAX STATUS

The Plan adopted a standardized prototype plan with a deferral arrangement which received an opinion letter for the prototype plan from the Internal Revenue Service dated January 1, 2018, stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since receiving the favorable opinion letter. However, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of January 13, 2022 and December 31, 2021.

As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements.

The Plan is subject to routine audits by the Internal Revenue Service and the Department of Labor; however, there are currently no audits, for any periods, in progress.
