Notes to Financial Statements

Note 1: Description of Plan

The following description of the Daily Racing Form Services, LLC 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Merger

Effective December 30, 2020, the Plan merged into Affinity Gaming Retirement Savings Plan ("Affinity Gaming"). Assets transferred into Affinity Gaming consisted of investments and note receivables from participants. Upon effective date of the plan merger, all participants became 100% vested in their account balances. Plan assets remained in the Plan until December 30, 2022, at which date the Plan transferred all assets to Affinity Gaming.

General

The Plan is a defined contribution plan covering substantially all employees of Daily Racing Form Services, LLC (the "Plan Sponsor" or "Company") who have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Eligible employees include substantially all employees of the Company over the age of 21. Nonresident aliens with no U.S. source income, leased employees, and any employee employed in a Canada office location who is not a U.S. citizen or resident alien are not eligible for the Plan.

Contributions

Each plan year, participants may contribute up to 100% of annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan maintains an automatic enrollment provision whereby, unless they affirmatively elect not to participate, newly eligible employees are automatically enrolled in the Plan 30 days after hire. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, increasing annually by 1% until a deferral rate of 12% is reached.

The Company may make a discretionary matching contribution on behalf of eligible participants. For the period January 1, 2022 to December 30, 2022, the Company contributed 50% of the first 6% of base compensation that a participant contributed to the Plan. Matching contributions for 2022 amounted to \$164,063. Additional profit sharing amounts may also be contributed at the discretion of the Company. For 2022, the Company did not declare a profit sharing contribution.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of Company profit sharing contributions, plan earnings (losses), and administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings (losses) thereon is based on years of continuous service. Participants become fully vested based on a graduated schedule of five years of service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Participants are limited to two outstanding loan balances at a time.

Payment of Benefits

Participants' benefits under the Plan are payable to participants, their beneficiaries or their estates upon termination of employment, retirement, disability, death, hardship, or upon the attainment of age 59-1/2. Benefits are payable in the form of lump-sum distributions, equal installments, or partial withdrawals from fully vested accounts. Account balances under \$5,000 for terminated participants may be automatically distributed. Hardship distributions may only be made from fully vested employee pre-tax deferral accounts and participants may receive a pre-retirement distribution of their rollover accounts at any time.

Forfeitures

At December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$22,094, respectively. These accounts may be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. Forfeited nonvested accounts totaling \$34,883 were used to reduce Company contributions during the period January 1, 2022 to December 30, 2022. Forfeited nonvested accounts totaling \$9,022 were used to pay administrative expenses of the Plan during the period January 1, 2022 to December 30, 2022.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 30, 2022 and December 31, 2021. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through August 21, 2023, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no investment assets as of December 30, 2022. There were no changes in the methodologies used as of December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3: Fair Value Measurements (Continued)

Common collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV, as determined by the Trustee, is based on the fair values of the underlying investments held by the fund less liabilities. Participant transactions (purchases and sales) may occur daily.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 30, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends for the period January 1, 2022 to December 30, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company ("Fidelity"). Fidelity is the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fidelity also provides recordkeeping services to the Plan. Direct fees incurred and paid by the Plan for these services were \$21,031 for the period January 1, 2022 to December 30, 2022. Wealth Plan Advisors and Global Retirement Partners provide outside investment advisory services to the Plan. Direct fees incurred and paid by the Plan for these services were \$36,212 for the period January 1, 2022 to December 30, 2022.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Plan Sponsor adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

There were no investment assets as of December 30, 2022. At December 31, 2021, three investment securities represented 38% of plan assets.
