## **Independent Auditors' Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### Note 1 - Description of Plan

The following description of Angelina Forest Products, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan was a defined contribution 401(k) retirement plan available to substantially all employees of Angelina Forest Products, LLC (the "Company") who were eighteen (18) years of age or older and had completed six months of service, except for employees covered by a collective bargaining agreement, leased employees, or non-resident aliens. Upon attaining eligibility, employees could enroll in the plan on the first day of the month following becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective May 2, 2022, the Plan merged into the West Fraser, Inc. 401(k) Plan, a related plan of the plan sponsor. Accordingly, net assets totaling \$2,046,789 were transferred to West Fraser Inc. 401(k) Plan on April 29, 2022.

#### Contributions

Participants could elect to defer either pre-tax or roth contributions up to ninety percent (90%) of annual eligible compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Additionally, participants age 50 or older who were making contributions to the Plan were allowed to make catch-up contributions as defined in the Plan. The Company made safe harbor matching contributions equal to one hundred percent (100%) of eligible employees' elective deferrals up to four percent (4%) of such eligible employees' compensation. The Company also could make discretionary matching contributions and profit sharing contributions. There were no discretionary matching or profit sharing contributions made for 2022 or 2021.

#### Participant investment account options

The Plan allowed participants to direct their contributions and account balances among the different investment options offered by Transamerica Financial Life Insurance Company (Transamerica).

#### Participant accounts

Each participant's account was credited with the participant's contribution and the Company's safe harbor matching contribution, an allocation of discretionary and profit sharing contributions, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the

contribution were invested. Participant accounts were charged with an allocation of certain administrative expenses that were based upon the participant earnings, account balances, or specific participant transactions, as defined by the plan document. All other administrative expenses were paid by the Plan sponsor. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### Vesting

Participants were immediately vested in their contributions and safe harbor matching contributions, plus earnings and losses thereon. Participants vested in the Company's discretionary matching and profit sharing contributions and related earnings and losses based upon years of service. A participant was 100% vested after six (6) years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan was discontinued, participants became 100% vested in all account balances.

#### Notes receivable from participants

Participants could borrow up to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. The minimum amount that could be borrowed was \$1,000. The loans were secured by the balance in the participant's account and bore interest at the prime interest rate plus two percent (2%). Principal and interest was repaid ratably through payroll deductions. A participant could have no more than one (1) loan outstanding at any time.

#### Payment of benefits

Upon termination of service for any reason, a participant could request to receive the value of the vested interest in his or her account as a distribution in the form of a lump-sum payment or substantially equal installments. Withdrawals by a participant while still employed were limited to those requested due to events of financial hardship as defined by the plan document, withdrawals of voluntary after-tax contributions and rollover contributions, or upon attainment of age 59½. All vested balances less than \$5,000 could be automatically distributed as a lump sum at the discretion of the Company.

#### Forfeited accounts

If an employee terminated before his or her Company matching and discretionary matching and profit sharing contributions had become fully vested, such unvested portion of the account was forfeited. Participant forfeitures were used to reduce future Company contributions.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee determined the Plan's valuation policies utilizing information provided by the custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses when they were incurred. No allowance for credit losses was recorded as of May 2, 2022 and December 31, 2021.

#### Payment of benefits

Benefits were recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the respective participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### Note 3 - Information prepared and certified by the custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica, the custodian of the Plan, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments at fair value
- Investments at contract value
- Net appreciation (depreciation) in fair value of investments
- Notes receivable from participants
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Note 4 - Fair value measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

*Pooled separate accounts:* Valued at the NAV of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Investments Measured Using the Net Asset Value per Share Practical Expedient

The following tables summarize investments for which fair value is based on NAV per share practical expedient as of December 31, 2021. There are no participant redemption restrictions for these investments; the redemption notice period is applicable to the Plan.

### Note 5 - Fully benefit-responsive investment contract

The Plan had a fully benefit-responsive guaranteed investment contract with Transamerica Financial Life Insurance Company (Transamerica). Transamerica maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than zero percent (0%). The crediting interest rate was reviewed periodically for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### Note 5 - Fully benefit-responsive investment contract (continued)

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if there were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan.), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

### Note 6 - Related party transactions and party-in-interest transactions

The Plan's investments as of December 31, 2021 included pooled separate accounts and a stable value fund held by Transamerica. Transamerica was the custodian as defined by the Plan, and therefore, these transactions qualified as party-in-interest transactions. The Plan also paid administrative service fees and investment management fees to Transamerica, the recordkeeper of the Plan. Fees paid directly by the Plan for administrative expenses totaled \$1,503 in 2022 and \$3,934 in 2021. The plan sponsor paid directly any other fees related to the Plan's operations.

### Note 7 - Plan termination

During 2021, the Pension and Savings Plan Committee voted to merge the Plan effective May 2, 2022 into their parent company's plan, West Fraser Inc. 401(k) Plan, which is the successor plan. In connection with the merger and immediately prior to the transfer of plan assets to the successor plan, all participants' account balances became 100% vested.

### Note 8 - Tax status

The IRS has determined that the Prototype Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed the trustee of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the plan administrative committee believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Subsequent events

Plan management has evaluated subsequent events through August 15, 2023, which is the date that the financial statements were available to be issued and noted no items requiring disclosure.
