Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended August 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Paragon Development Systems, Inc. ### Note 1: Description of Plan

#### General

The following description of the Paragon Development Systems, Inc. Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Eligibility

The Plan was a defined contribution plan covering substantially all employees of Paragon Development Systems, Inc. (the "Company") who had 30 days of service. Voya Institutional Trust Company ("Voya") was the Plan's third party administrator, recordkeeper, and trustee.

#### Plan Termination

The Company entered into an acquisition agreement with Converge Technology Solutions, Inc. effective January 8, 2022. As of September 1, 2022, the Plan was merged and all funds held in the Plan were transferred to the Converge Technology Solutions US 401(k) Plan. After the funds were transferred, the Plan was terminated.

#### Contributions

Each year, participants could contribute up to 100% of annual compensation, as defined in the Plan, not to exceed the limits of the Internal Revenue Service ("IRS"). Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers").

The Plan also included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation. All auto-enrolled employees were subject to an annual 1% auto increase until the participant reached a 10% deferral rate, unless the employee opted out of the auto increase or if they electively changed their deferral percentage.

The Company could, but was not required to, make discretionary matching and profit sharing contributions to the Plan. No discretionary contributions were made for the period ended August 31, 2022.

#### Investment Options

Contributions were allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, it was intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account was credited with the participant's contributions, Company discretionary contributions, if any, and allocations of plan earnings (losses), and charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

#### Vesting

Participants were immediately vested in their contributions and Company profit sharing contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary matching contributions vested according to the following schedule:

#### Forfeitures

At August 31, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$1,241, respectively. These accounts were used to pay administrative expenses or to reduce Company contributions in accordance with the plan document. In 2022, forfeitures of \$2,150 were used to pay administrative expenses. No amounts were used to reduce Company contributions in 2022.

#### Notes Receivable From Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes were secured by the balance in the participant's account and bore interest at rates ranging from 4.25% to 6.50%, which were commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were paid ratably through payroll deductions.

#### Payment of Benefits

Benefits could be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined by the Plan. A participant could receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account were permitted if certain criteria were met. The Plan provided for normal retirement at age 65 and did not allow for early retirement.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

The Plan merged into Converge Technology Solutions US 401(k) Plan effective September 1, 2022.

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses has been recorded as of August 31, 2022 and December 31, 2021. Delinquent participant notes receivable were recorded as benefit payments on the basis of the terms of the plan document.

#### Excess Contributions Payable

During 2022, amounts payable to participants totaling \$62,077 for contributions in excess of amounts allowed by the IRS were recorded as a reduction to contributions and netted against the transfer to Converge Technology Solutions US 401(k) Plan. This amount was distributed to participants through the Converge Technology Solutions US 401(k) Plan in 2023. There was \$26,478 in excess contributions for the year ended December 31, 2021, that were distributed in 2022.

#### Payment of Benefits

Benefits were recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were allocated proportionately to plan participants based on their respective account balances and were included in total investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through August 8, 2023, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that were either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques maximized the use of observable inputs and minimized the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of August 31, 2022 and December 31, 2021.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

**Money market fund:** Value obtained from a quoted price in an active market.

**Common collective trust:** Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities.

### Note 3: Fair Value Measurements (Continued)

The methods described above could produce a fair value calculation that was not indicative of the net realizable value or reflective of future fair values. Furthermore, although the plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### Note 4: Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments held at August 31, 2022 and December 31, 2021, and net depreciation in fair value of investments; and interest and dividends for the period then ended August 31, 2022, was obtained or derived from information certified as complete and accurate by Voya Institutional Trust Company, the Plan's trustee.

### Note 5: Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments were managed by Voya Institutional Trust Company, the Plan trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions were not, however, considered prohibited transactions under ERISA regulations. Notes receivable from participants also qualify as party-in-interest transactions, which were exempt from the prohibited transaction rules of ERISA.

### Note 6: Tax Status

The Plan adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan had been amended since receiving the determination letter; however, the plan administrator believes the Plan was designed and operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 7: Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in values of investment securities could have occurred in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
