1. DESCRIPTION OF THE PLAN

The following description of the S.D.S. Lumber Co. (“Company”) Profit Sharing Plan (“Plan”) provides only general information. Reference should be made to the Plan document for a more complete description of its provisions.

GENERAL. The Plan was established February 26, 1960 and is a defined contribution Plan covering all employees of S.D.S. Lumber Co. who are not members of a collective bargaining agreement, non-resident aliens or leased employees and who have completed one hour of service in their first six months of employment, or complete one full year of service, and have attained eighteen years of age. The Plan’s third party administrator and sponsor manage the operation and administration of the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

PLAN AMENDMENT. Effective December 13, 2022, the Plan was frozen and on December 14, 2022, the Plan was merged in the W.K. & O./High Cascade 401(k) Plan.

CONTRIBUTIONS. Participants may contribute to the Plan in the form of pretax salary reductions not to exceed \$20,500 for the calendar year ended December 31, 2022 and \$19,500 for the calendar year ended December 31, 2021. Participants age 50 and over may also contribute an additional \$6,500 of catch-up contributions for calendar years 2022 and 2021. The Plan has an automatic enrollment feature which automatically withholds 4% of eligible compensation from new participants who have not entered into a salary deferral election. Participants can elect not to defer if they choose. The Company may contribute a discretionary match and a discretionary profit sharing contribution to be determined annually by the Board of Directors. Employees are eligible for the discretionary match and profit sharing contribution after six months of employment with at least one hour of service. The employer matching contribution was \$162,633 and \$451,587 for the years ended December 13, 2022 and December 31, 2021, respectively. There was no employer profit sharing contribution for the years ended December 13, 2022 and December 31, 2021.

PARTICIPANT ACCOUNTS. Each participant’s account is credited with the participant’s contribution, allocation of employer’s matching and profit sharing contributions and Plan earnings. Allocations for the employer’s matching and profit sharing contributions are based on participant’s earnings or account balances, as defined in the Plan document. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s account.

VESTING. Participants are fully vested in their rollover and elective contributions as well as employer qualified nonelective contributions (QNEC) plus earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service, and also upon death, disability or upon reaching normal retirement age.

EXPENSES. There may be fees or expenses related to the administration of the Plan or associated with the investment of Plan assets that will affect the amount of Plan benefits. Any fees related to the administration of the Plan or associated with the investment of Plan assets may be paid by the Plan or by the Employer. If the employer does not pay Plan-related expenses, such fees or expenses will generally be allocated to the accounts of participants either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. If a participant directs the investment of their benefits under the Plan, said participant will be responsible for any investment-related fees incurred as a result of the investment decisions.

1. DESCRIPTION OF THE PLAN - Continued

In addition to general administration and investment fees that are charged to the Plan, a participant may be assessed fees directly associated with the administration of their account such as; for termination of employment, fees related to processing distributions, loan origination and annual maintenance fees, and charges related to processing of a Qualified Domestic Relation Order where a court requires that a portion of the benefits be payable to an ex-spouse or children as a result of a divorce decree.

PAYMENT OF BENEFITS. Upon attaining normal retirement age of 60, death or termination of employment; a participant, or his or her beneficiary, may elect to receive a lump-sum amount equal to the participant's vested account balance, roll their account balance to another company's qualified plan or IRA or defer distribution until administratively feasible. In the event the separated participant's vested account balance exceeds \$5,000, the participant, or his or her beneficiary, may also elect to receive a distribution in the form of a series of installment payments over the participant's life expectancy. If the installment period is ten years or greater, the participant, or his or her beneficiary, may not rollover any of the installment payments into an IRA or another qualified plan.

HARDSHIP WITHDRAWALS. Pre-retirement distributions of elective deferrals are available on a hardship basis. These distributions are limited to the specific financial need. They must be approved by the custodian on a nondiscriminatory basis. Additionally, in 2020, the Coronavirus Aid, Relief and Economic Security Act (CARES Act) was enacted which expanded withdrawals to include virus-related distributions of elective deferrals. These distributions are limited to specific COVID-19 needs and must be verified and approved by the custodian.

INVESTMENT OPTIONS. Upon enrollment, a participant may direct contributions to certain investment accounts selected by the trustee and these investment allocations may be changed daily by participants. Participants may change their investment deferral percentages at any time with an effective date of the first day of the subsequent calendar quarter (January 1, April 1, July 1, and October 1).

FORFEITURE. Forfeitures of unvested benefits are available to use at the Company's discretion such as for Plan expenses. Forfeitures not used for Plan expenses may be allocated as additional employer contributions or be used to reduce other employer contributions to the Plan. The non-vested forfeiture account balance as of December 13, 2022 and December 31, 2021 was, \$0 and \$82,358, respectively. Forfeitures used to reduce administrative fees were \$11,820 and \$8,761 for the years ended December 13, 2022 and December 31, 2021, respectively. Forfeitures used to reduce employer contributions were \$143,656 and \$0 for the years ended December 13, 2022 and December 31, 2021, respectively.

NOTES RECEIVABLE FROM PARTICIPANTS. Participants may borrow from their fund accounts a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance (\$1,000 minimum) and are treated as notes receivable from participants measured at unpaid principal balance plus accrued but unpaid interest. Note terms range from one to five years (ten if used for the purchase of a primary residence), are secured by the balance in the participant's account, and bear interest at a rate commensurate with the prime interest rate plus two percentage points determined at the time the loan is initiated. Principal and interest are paid ratably through regular payroll deductions.

MERGER. On October 11, 2022, members of SDS Lumber, LLC approved the merger of the Plan into the W.K. & O./High Cascade 401(k) Plan, effective December 13, 2022. As a result, all investments were transferred from the Plan to the W.K. & O./High Cascade 401(k) Plan effective December 14, 2022.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan employs accounting policies generally accepted in the United States of America. The Financial Accounting Standards Board ("FASB") has issued guidance which establishes the FASB Accounting Standards Codification (the "Codification" or "FASB ASC") as the source of authoritative accounting principles recognized by the FASB to be applied to nongovernmental entities in the preparation of financial statements in conformity with accounting principles generally accepted in the United States of America.

BASIS OF ACCOUNTING. The accompanying financial statements have been prepared on the accrual basis of accounting.

USE OF ESTIMATES. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION. Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. See Note 4 for a discussion of contract value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

RISKS AND UNCERTAINTIES. The Plan provides for investment options primarily in mutual funds, self-directed brokerage accounts and a guaranteed investment contract which invest in portfolios of investment securities through Voya Retirement Insurance and Annuity Company, the custodian of the Plan. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

From time to time, investments may include securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions including real estate value, delinquencies or defaults or both, and they may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan has implemented the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC 740, *Income Taxes*. Using that guidance, the Plan does not believe it has any uncertain tax positions that qualify for either recognition or disclosure in the financial statements as of December 13, 2022 and December 31, 2021. The Plan's tax filings are subject to audit by U.S. Federal taxing authorities and open audit years are 2019 – 2022.

SUBSEQUENT EVENTS. The Company has evaluated subsequent events through August 17, 2023, the date that the financial statements were available for issue.

3. FAIR VALUE MEASUREMENTS AND DISCLOSURES

FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 for financial assets and financial liabilities are described below:

Level 1	Values are based on quoted prices in active markets for identical securities.
Level 2	Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.
Level 3	Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These inputs may reflect the Plan's estimates of the assumptions that market participants would use in valuing the financial asset or financial liability.

Pursuant to FASB ASC 820, fair value is a market-based measure, considered from the perspective of a market participant who owns an asset or owes a liability. Accordingly, when market observable data is not readily available, assumptions are set to reflect those that market participants would be presumed to use in pricing the asset or liability at the measurement date. Prices and inputs are used that are current as of the measurement date, including during periods of market disruption. In periods of market disruption, the ability to observe prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

The following is a summary of the inputs used, as of December 31, 2021 involving the Plan's financial assets carried at fair value. The inputs or methodologies used for valuing investments may not be an indication of the risk associated with investing in those securities.

VALUATION OF INVESTMENTS - MUTUAL FUNDS. Investments in mutual funds are carried at fair value, which is the net asset value per unit of each mutual fund multiplied by the number of units owned. The value of each unit is computed by the mutual fund company on the last business day of the Plan year, based on quoted market prices of the underlying securities, bonds and other financial instruments owned by each fund.

VALUATION OF INVESTMENTS - SELF-DIRECTED BROKERAGE ACCOUNT. Account primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

4. GUARANTEED INVESTMENT CONTRACT

At December 31, 2021, the Plan maintained one guaranteed investment contract (GIC) related investment option, the Voya Fixed Account issued by Voya Retirement and Insurance and Annuity Company (VRIAC). The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. At December 31, 2021, the contract value of the investment in the Voya Fixed Account was \$4,680,276. The contract was no longer maintained at December 31, 2022.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statement of net assets available for benefits. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations; (4) the failure of the Plan to qualify under 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax exempt under Section 501(a) of the IRC; or (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

5. INCOME TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan has been amended to meet the requirements of certain changes to the law, therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

6. PLAN TERMINATION

The Company and its shareholders entered into a purchase agreement providing for the purchase of the Company's stock by Mt Adams Forest Products LLC effective November 2021. In accordance with the terms of the purchase agreement and by action of its board of directors, the Company merged the Plan in December 2022. See Note 1 regarding the merger.

7. INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN

The following summary of unaudited information regarding the Plan and included in the Plan's financial statements was certified by the custodian of the Plan, Voya Retirement Insurance and Annuity Company, of and for the year ended December 13, 2022 and December 31, 2021.
