We have performed an audit of the financial statements of the 403(b) Thrift Plan of Anuvia Prevention and Recovery Center, Inc. (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 7, 2022 and December 31, 2021 (in liquidation), and the related statement of changes in net assets available for benefits for the period January 1, 2022 through October 7, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Other Matters

Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan approved a planned liquidation effective July 1, 2022, and management determined liquidation to be imminent. As a result, the Plan has changed its basis of accounting from the accrual basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Notes to Financial Statements

1. Description of Plan

The following description of the 403(b) Thrift Plan of Anuvia Prevention and Recovery Center, Inc. (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

Anuvia Prevention and Recovery Center, Inc. ("Anuvia") established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of Anuvia, as defined in accordance with the summary plan description, are eligible to enroll on their date of hire. Deferrals begin on the first day of the payroll period subsequent to enrollment. With respect to non-salary reduction contributions, such as employer nonelective contributions, eligibility occurs when the employee has attained age 21 and completed one year of service. The Plan is a 403(b) defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective October 18, 2019, the Plan was amended such that participants will not be required to stop all employee contributions and elective deferrals after receipt of a hardship withdrawal.

Transfers and termination of Plan

Anuvia elected to terminate the Plan effective July 1, 2022. As a result of the termination, all active employees at the date of the resolution were considered fully vested. On October 7, 2022, the remaining assets in the plan were converted to individual annuity contracts and the Plan was considered terminated.

Contributions

Each year, participants may contribute the maximum amount allowed by the Internal Revenue Code ("IRC"), as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. For the period January 1, 2022 through October 7, 2022, Anuvia made a nonelective contribution equal to 7% of base compensation for all employees regardless of participation in the Plan. Contributions are subject to certain limitations.

Investment options

Participants direct the investments of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds as options for participants.

Participant accounts

Each participant's account is credited with the participant's contributions, employer's contributions, and allocation of Plan earnings. Accounts are charged with benefit payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants hired prior to September 1, 2015 are immediately vested in Anuvia's contributions. Vesting in Anuvia's contributions plus actual earnings thereon for participants hired on or after September 1, 2015 is based on years of service in accordance with the following schedule:

Notes receivable from participants

Participants may borrow from their fund accounts a maximum equal to 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

On termination of service due to death, disability or retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum as provided by the Plan. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participants reach age 59.5 years. Participants may petition for hardship withdrawals prior to termination of employment and, if approved, an amount not exceeding the vested portion of their individual accounts may be withdrawn.

2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP") for the year ended December 31, 2021. The Plan approved a planned liquidation effective July 1, 2022, and management determined liquidation to be imminent. As a result, the Plan has changed its basis of accounting from the accrual basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits

Benefits are recorded upon distribution.

Administrative expenses

The Plan's administrative expenses are paid by either the Plan or Anuvia, as provided by the plan document. Certain administrative functions are performed by employees of Anuvia. No such employee receives compensation from the Plan. Expenses related to specific participant transactions (distributions) are charged directly to the participant's account.

Subsequent events

The Plan has evaluated subsequent events through August 22, 2023, the date the financial statements were available to be issued.

3. Fair Value Measurements

Fair value is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

Level 1: Observable inputs such as quoted prices in active markets.

Level 2: Inputs other than quoted prices in active markets that are either directly or indirectly observable.

Level 3: Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Mutual funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

5. Exempt Party-In-Interest Transactions

Certain plan investments are shares of mutual funds managed by the trustee or its affiliates. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan to the trustee and its affiliates for administrative services were \$1,161 for the period January 1, 2022 through October 7, 2022.

6. Plan Termination

See Note 1 regarding the plan termination effective July 1, 2022. Anuvia has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 7, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
