INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of
Tahari Ltd. Employee Savings Plan and Trust:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tahari Ltd. Employee Savings Plan and Trust Tahari LTD. Employee Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tahari Ltd. Employee Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Tahari Ltd. Employee Savings Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, established effective January 1, 1992, is a defined contribution plan with salary reduction features covering employees of Tahari LLC, and its affiliate, Tahari ASL, LLC (collectively the “Sponsor”) who have completed 60 days of eligible service and are age 21 or older. The entry date to join the Plan is the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employee Contributions

Employees are eligible for the Plan following completion of 2 months of service. The Plan excludes part time, seasonal and temporary employees; however, if an employee in this category is at least 21 years of age and has completed 1,000 hours of service, the employee may participate in the Plan. All newly eligible employees are automatically enrolled in the Plan at a deferral rate of 4% of eligible compensation, unless they affirmatively elect an alternate rate or elect not to participate in the Plan. The automatic elective deferral contribution shall be automatically increased as soon as administratively feasible on or after each November 1 of each year by 1% up to a maximum automatic elective deferral contribution of 8%. Each year, participants may contribute up to 90% of pretax or post tax annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer Contributions

The Sponsor may annually elect to make discretionary matching contributions and/or a discretionary nonelective employer contribution. For the year ended December 31, 2022, there were no discretionary matching or discretionary nonelective employer contributions.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant’s account is credited with the participant’s contributions and the Sponsor’s contribution (as applicable) and Plan earnings. Participant accounts are charged with an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer’s contribution portion on their accounts is based on years of credited service as follows:

Distributions and Withdrawals

Upon termination of service due to death, disability or retirement, participants or beneficiaries may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account greater than \$5,000. For termination of service for other reasons, participants may receive the value of the vested interest in his or her account greater than \$5,000 as a lump sum distribution or a direct rollover to another qualified plan.

If the participant's account is less than \$1,000, the participant's distribution may automatically be made in the form of a lump sum as soon as practical. Vested participant accounts between \$1,000 and \$5,000, where the participant has not attained age 65 and no election has been made for a rollover or lump sum, are automatically rolled to an IRA in direct rollover in accordance with federal law. Under certain circumstances (hardship), a participant may withdraw at any time a portion of his or her account balance, subject to approval and the provisions of the Plan. In-service withdrawals are permitted once a participant has attained age 59 1/2.

Forfeitures

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$804 and \$13, respectively. Forfeitures may be used to pay administrative expenses or applied against the employer contribution in the subsequent period. In 2022, \$2,770 of forfeitures were used to pay administrative fees.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loan terms may not exceed five years unless the proceeds of the loan are used to acquire a primary dwelling unit in which case the term of the loan may be repaid over a period of time that may exceed five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined at the time of the loan application. Outstanding loans bear interest between 4.25% and 8.00% per annum. Principal and interest are paid ratably through payroll deductions. Fees related to the administration of notes receivable from participants are charged directly to the participant's account.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting.

Valuation of Investments and Income Recognition

Investments are reported at fair value except for the fully-benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses

The expenses necessary to administer the Plan, including but not limited to retaining necessary professional assistance from an attorney, an accountant, an actuary, or an investment advisor are paid by the Sponsor. All expenses except for account maintenance fees, transaction fees and investment fund management fees have been paid by the Sponsor. Participants are charged services fees for any loan and distribution transactions they request. Investment-related expenses are included in net depreciation in fair value of investments and are not readily determinable.

Payment of Benefits

Benefits are recorded when paid.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs are supported by little or no market activity and are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value.

Registered Investment Companies: Valued at quoted market prices which represent the net asset value ("NAV") of shares held by the Plan at year end. Since NAV is a quoted price in an active market, they are classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

No auditing procedures were performed by the independent public accountants as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by Fidelity Management Trust Company ("the trustee"), except for comparing such information with the information reported in the financial statements. Based on information provided, the following information as of and for the years ended December 31 was prepared from reports certified by the trustee.

5. INCOME TAX STATUS

The Plan adopted a Fidelity prototype volume submitter profit sharing 401(k) plan. By letter dated June 30, 2020, the Internal Revenue Service has stated that the prototype plan was acceptable under the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the letter was received. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. In addition, there have been no tax related interest or penalties for the periods presented in these financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. INSURANCE CONTRACT WITH INSURANCE COMPANY

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company ("Principal"). Principal maintains the contributions in a single group annuity contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The account is credited with earnings on the single group annuity contract and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal to the Plan at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a semi-annual basis for resetting.

As described in Note 2, because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. The Plan's investment contract does not specify certain conditions under which distributions from the contract would be payable below contract value. The terms and methods under which the contract may transact are defined in Article II (Deposits and Funds), Article III (Fees), Article IV (Benefits and Other Payments) and Article V (Termination) in the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

7. TERMINATION

The employer intends to continue the Plan indefinitely; however, the employer reserves the right to modify, amend or terminate the Plan at any time by resolution of its board of directors. If a termination takes place, the participant will have a 100% vested and non-forfeitable interest in all of the amounts in his/her account. These amounts may be distributed to the participant at that time or may be distributed in accordance with the benefit distribution rules.

8. RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and an insurance contract managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services and participant transaction fees amounted to \$84,583 for the year ended December 31, 2022, and are included in administrative expenses. Notes receivable from participants also qualify as exempt party-in-interest transactions.

9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events occurring after the statement of net assets available for benefits date through the date of August 21, 2023, the date for which the financial statements were available to be released. Based upon this evaluation, the Plan has determined that no subsequent events have occurred which require adjustment to or disclosure in the financial statements.
