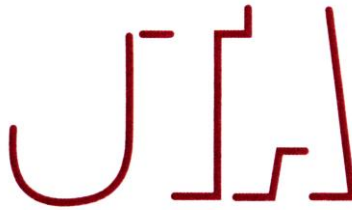

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements**

We have performed an audit of the financial statements of The Bukaty Agency, Inc. Employees 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits (liquidation basis) as of September 16, 2022, and the related statement of changes in net assets available for benefits (liquidation basis) for the period then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended September 16, 2022, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

#### **Opinion on the 2022 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section:

- the amounts and disclosures in the accompanying 2022 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion on the 2022 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section of our report. We are required to be independent of The Bukaty Agency, Inc. Employees 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter – Basis of Accounting**

As discussed in Note 1 to the financial statements, the governing body of The Bukaty Agency, Inc. Employees 401(k) Plan approved a plan of liquidation effective June 8, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

**Responsibilities of Management for the 2022 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Bukaty Agency, Inc. Employees 401(k) Plan's ability to continue as a going concern for within one year of the date of the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the 2022 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

**NOTE 1    DESCRIPTION OF THE PLAN**

---

The following description of The Bukaty Agency, Inc. Employees 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**Plan Termination**

On June 8, 2022 the Company elected to terminate the Plan effective July 15, 2022 and to distribute plan assets as administratively practicable, which ultimately was September 16, 2022.

**General**

The Plan was established by The Bukaty Agency, Inc. (the Company) effective April 11, 1997. The Plan was set up for the purpose of allowing employees of the Company to defer a portion of their annual base compensation for federal income tax purposes in accordance with Section 401(k) of the Internal Revenue Code. The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administrator and Trustees**

The Company is the Plan Sponsor and named Plan Administrator as defined by the Plan. The Plan Administrator is responsible for oversight of the Plan. The Plan Trustees are Michael Bukaty and Carol Jones which the Plan has assigned the day-to-day fiduciary duties. Empower is the Plan's Custodian (TPA) and Great-West Trust Company is the Plan's Trustee.

**Eligibility**

Company employees must be 21 years of age and become eligible to participate in the Plan after 2 months of service and may enter the Plan on the first day of the month coinciding with, or next following, the date they satisfy the eligibility requirements.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of the Company's matching and profit-sharing contributions, (if any), and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are valued daily.

**Notes Receivable from Participants**

Participants may not borrow from their vested account balance.

**Employee Contributions**

Participants are permitted to contribute up to the maximum allowed by the IRS, as defined in the Plan document, to the Plan on a tax-deferred basis. The Plan allows for automatic enrollment and a 5% contribution unless elected otherwise. Rollovers from qualified plans are allowed under the provisions of the Plan.

**Employer Contributions**

Each year, the Company will make matching contributions to the Plan. Salary reductions are matched in an amount equal to 100% of the first 3% of compensation plus 50% of the next 2% of compensation for Safe Harbor.

The Company may, but is not required to, make a discretionary profit-sharing contribution to be allocated to participants based on allocations defined in the Summary Plan Document.

**Payment of Benefits and Distributions**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-service distributions may be taken from certain accounts that participants are 100% vested in and have attained the age of 59 ½. The Plan also contains provisions by which participants may withdraw a portion of their account in the case of defined hardship.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company's safe harbor contribution portion of their accounts is based on years of continuous service and is 100% vested after two years of credited service. A participant vests 0% in the first year and then 20% per year after that on other company matches. Regardless of the vesting schedule, employees are 100% vested upon attainment of normal retirement age while an employee, death while an employee, or suffering a disability while an employee.

**Forfeited Accounts**

Forfeited non-vested accounts will be used first to reduce future employer matching contributions. Forfeited accounts totaled \$0 and \$11,161 at September 16, 2022 and December 31, 2021, respectively. During 2022 and 2021 no funds were used to reduce employer contributions.

**Investment Options**

Upon enrollment in the Plan, participants may direct their participant accounts to be invested in various mutual funds, general insurance accounts, or a fixed deferred group annuity. These funds include a variety of investment options with various objectives and degrees of financial risk.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

**Basis of Accounting**

The accounting records and the accompanying financial statements are reported on the liquidation basis of accounting in accordance with U.S. GAAP.

Employee contributions are recorded when withheld from pay. Employer contributions are recorded in the period to which they pertain. Expenses are recorded in the accounting period in which they are incurred.

**Use of Estimates**

The preparation of the financial statements, in conformity with accounting principles generally accepted in the United States of America, requires plan management to make estimates and assumptions that affect the reported amounts of the Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The Plan's custodians, Great-West Trust Company, LLC, and Great-West Life & Annuity Insurance Company, certify the value of all investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for a discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of investments valued at contract value.

Purchases and sales are recorded on a trade-date basis. Income on investments is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciations) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits payments to participants are recorded when paid.

**Administrative Expenses**

All reasonable expenses related to plan administration are paid from plan assets, except to the extent the expenses are paid (or reimbursed) by the employer. If the employer does not pay plan related expense, such fees or expenses will generally be allocated to the accounts of the participants either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Reclassification**

Certain prior year amounts have been reclassified to conform to the current year's presentation.

**Subsequent Events**

The Plan has evaluated subsequent events through March 3, 2023, the date which the financial statements were available to be issued, except for Note 2, as to which the date is August 22, 2023

**NOTE 3 FAIR VALUE MEASUREMENTS**

---

Fair value as defined under U.S. GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. The three levels of the fair value hierarchy are as follows.

**Level 1** – Observable inputs such as quoted prices in active markets.

**Level 2** – Inputs other than quoted prices in active markets that are either directly or indirectly observable.

**Level 3** – Unobservable inputs about which little or no market data exists; therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. When, as a practical expedient, an investment is measured at fair value on the basis of net asset value, its classification as Level 2 or 3 will be impacted by the ability to redeem the investment at net asset value at the measurement date. If there is uncertainty, or the inability to redeem an investment at net asset value in the near term subsequent to the measurement date, the investment is categorized as Level 3.

The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

**Mutual Funds**

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the plan are deemed to be actively traded.

**Common/Collective Trusts**

The common/collective trust funds are not publicly traded and are measured at fair value based on the fair value of underlying assets of the common/collective trust accounts, using NAV as the practical expedient. The NAV's share price is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market. The Plan includes the fair value estimates of these securities in Level 2.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

---

The Guaranteed Interest Account is a group annuity contract issued by Great-West Life and Annuity Insurance Company and is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of Great-West and not on the value of the securities within the insurer's general account. The credit rating of the issuer at December 31, 2021 was considered investment grade, and there are no reserves against contract value for credit risk of the contract issuer or otherwise. Only an event causing liquidity constraints at Great-West could limit the ability of the Plan to transact at the contract value to be paid within 90 days or, in rare circumstances, the contract value to be paid overtime. There are not any events that allow the issuer to terminate the contract, and which require the Plan sponsor to settle at an amount different than contract value to be paid within 90 days or over time. The Plan considers this contract to be benefit responsive.

The Guaranteed Interest account does not operate like a mutual fund, variable annuity product, or conventional fixed rate individual annuity product. Under the group annuity contract that supports this product, participants may ordinarily direct a permitted withdrawal or transfer of all or a portion of their account balance at contract value, within reasonable timeframes.

Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals, and fees. Interest is credited on Contract balances using the "portfolio rate" approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of these contributions. Interest crediting rates are reviewed on a quarterly basis for resetting by the trustee. When establishing interest crediting rates for this product, the trustee considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio with the general account. These rates are established without the use of a specific formula. The minimum crediting rate under the contract issue by Great-West is 0.00% and is reset quarterly. The average yield for 2021 was 1.04%

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**NOTE 5 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

---

The custodians manage certain mutual funds and the guaranteed interest account investments held within the Plan. Transactions related to these investments thereby qualify as party-in-interest transactions. However, the Department of Labor has issued prohibited transaction exemptions indicating that these types of transactions are to be considered exempt party-in-interest transactions.

---

Net assets available for benefits from the Form 5500, "Annual Return/Report of Employee Benefit Plan" ("Form 5500"), agree with the Plan's financial statements.

---

**NOTE 7 TAX STATUS OF THE PLAN**

---

The Plan has obtained its latest determination letter dated March 30, 2012, in which the Internal Revenue Service stated that the Plan, as then designed, complied with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code; and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

**NOTE 8 CERTIFIED INVESTMENTS**

---

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian, Great-West Trust Company, LLC, and Great-West Life & Annuity Insurance Company (Great-West), have certified that information included in the accompanying financial statements and supplemental schedules is complete and accurate. This includes the investment information reflected in the accompanying statements of net assets available for benefits, the statement of changes in net assets available for benefits and the schedule of assets (held at end of year).

**NOTE 9 SIGNIFICANT CONCENTRATIONS**

---

Investments representing 10% or more of the Plan's net assets available for benefits are considered to be significant concentrations. There were no plan assets at September 16, 2022 that were considered significant.

---

**NOTE 10 RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participant' account balances and the amounts reported in the statements of net assets available for benefits.
