## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of KPC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets as of November 18, 2022 (in liquidation) and December 31, 2021 (ongoing) and the related statement of changes in net assets in liquidation for the period ended November 18, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of KPC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Plan Description

The following description of KPC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan was approved for termination effective July 29, 2022. Accordingly, the descriptions below are provisions of the Plan prior to termination. See Note 6 for additional information.

#### **General**

The Plan is a defined contribution and voluntary savings plan covering all eligible employees of Kentwood Packaging Corporation (the "Company"). All employees who have attained the age of 18 and have completed at least 60 days of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees become participants in the Plan following completion of the eligibility requirements, as described in the Plan, and are fully vested for normal retirement benefits after six years of service.

Eligible participants can receive employer matching and profit-sharing contributions following the first entry date after the attainment of age 18 and 60 days of employment, as defined by the Plan. In addition, participants must be employed on the last day of the plan year to be eligible to receive profit-sharing contributions.

For employer matching contributions, the entry date will be the first day of the month coinciding with the date on which eligibility requirements are satisfied.

#### **Administration**

The Company is the plan administrator and the sponsor of the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

#### **Benefit Payments**

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company is required to make matching contributions of 50 percent of the first 5 percent of eligible compensation deferred by the participant.

The Plan provides for discretionary profit-sharing contributions and additional discretionary employer matching contributions, which are made annually in an amount determined by the plan sponsor's board of directors.

All contributions ceased as of July 29, 2022 when the Plan was terminated.

**Note 1 - Plan Description (Continued)*****Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Participant Notes Receivable***

Participants may borrow from their accounts up to a maximum of 50 percent of their account balances. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. New loan borrowings ceased as of July 29, 2022 when the Plan was terminated.

***Termination***

During 2022, the plan sponsor elected to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants became 100 percent vested in their account balances. The Plan was approved for termination effective July 29, 2022. See Note 6 for additional information.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon.

The Company's matching, profit-sharing, and discretionary contributions, if any, vest according to the following schedule:

Participants became fully vested on July 29, 2022 when the Plan was terminated.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions of the Plan.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company or its affiliates. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies*****Basis of Accounting***

As discussed in Note 6 to the financial statements, the plan sponsor terminated the Plan effective July 29, 2022. As a result, the Plan changed its basis of accounting for periods subsequent to December 31, 2021 from the going concern basis to the liquidation basis.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process, and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

***Investment Valuation***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including June 12, 2023, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements are based solely on information certified by the Trustee.

### Note 4 - Tax Status

The Plan, as adopted effective August 1, 2018, is a volume submitter plan, which does not require an application for a determination letter from the IRS. The volume submitter plan has received a favorable notification letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### **Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### **Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### **Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### **Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

#### **Common Collective Trust Accounts**

The common collective trust accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' net underlying assets.

### Note 6 - Plan Termination

Effective July 29, 2022, the plan sponsor elected to terminate the Plan. The Plan adopted the liquidation basis of accounting in fiscal year 2022. Under the liquidation basis of accounting, assets are recorded at the amount expected to be collected, and liabilities are recorded at amounts expected to be paid during the course of liquidation.

All participants became 100 percent vested as a result of the termination. Contributions to the Plan were not permissible following July 29, 2022.

Liquidation of assets through distributions to participants with account balances occurred during 2022, with full liquidation completed by November 18, 2022.
