We have performed audits of the financial statements of Symphony MediaAI 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of January 1, 2023 and December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the one-day period ended January 1, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

1. Description of the Plan

The following description of the Symphony MediaAI 401(k) Plan (the Plan) provides only general information. Participants and all others should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 1989 and was most recently restated as of January 1, 2022. The Plan was a contributory defined contribution 401(k) plan available to qualifying employees of Cable Audit Associates, LLC d/b/a Symphony MediaAI. Effective March 1, 2022, Wadhvani Operating Foundation became a participating employer in the Plan (collectively, the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Merger

Effective January 1, 2023, the Plan was merged into the SymphonyAI 401(k) Plan (AI Plan) and all eligible participants of the Company became eligible participants of the AI Plan on that date. Plan assets and receivables were liquidated and transferred into the AI Plan on January 31, 2023.

Issuer and Administration of the Plan

The issuer of the insurance products held in the Plan was Standard Insurance Company (Standard or Issuer). StanCorp Financial Group provided the recordkeeping and other administrative services. The administrator of the Plan was the Company. The Issuer held all assets of the Plan in accordance with the provisions of the group annuity contract with the Company. The Company and the Retirement Plan Committee determined the appropriateness of the Plan's investment offerings and monitored investment performance.

Eligibility

Employees were eligible after completing a month of service, as defined, and could participate in the Plan on the first day of the month after meeting the eligibility requirements above. Union employees; non-resident aliens; leased employees; residents of Puerto Rico; interns; and employees of Symphony Innovation, Ayasdi AI, Summit AI, and Azima were not eligible to participate in the Plan.

Contributions

Once an employee met the eligibility requirements to participate in the Plan, the employee would be automatically enrolled in the Plan at 2%, unless the employee affirmatively elected not to participate in the Plan or elected to have another deferral percentage withheld. Eligible participants could elect to contribute, on a pre-tax or after-tax Roth basis, up to 100% of their eligible compensation as defined by the Plan Document, subject to certain Internal Revenue Code (IRC) limitations. Participants who had attained or would attain age 50 by the last day of the Plan year could make catch-up contributions, as defined by the Plan, subject to IRC limitations. A participant could cease making elective deferral contributions at any time.

The Company made a Safe Harbor matching contribution each pay period of 100% of the first 3% of compensation deferred by participating employees, plus 50% of the participant's elective contributions between 3% and 5% of participating employees' compensation.

Rollover Contributions

Rollover contributions transferred from other qualified retirement plans or from Individual Retirement Accounts (IRA) were accepted as permitted by the Plan Document.

Participant Accounts and Investment Options

Each participant's account was credited with the participant elective deferral (pre-tax and after-tax Roth) and rollover contributions, Safe Harbor matching contributions, and prior discretionary matching contributions (if any), and an allocation of net plan earnings (losses). Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. The investment earnings or losses were allocated to each participant's account in the proportion that the balance of each participant's account bore to the total balance of all participants in each investment option. Participants could direct the investment of their account balances into various investment options offered by the Plan. Participants could make changes to their investment elections at any time. The benefit to which participants were entitled was the vested portion of their accounts.

Vesting and Forfeitures

Participants were 100% vested in their pre-tax, after-tax Roth, catch-up, and rollover contributions and Safe Harbor matching contributions.

A participant had a non-forfeitable right to a percentage of the balance in their prior discretionary matching contribution accounts based on the participant's years of service, as follows:

Participants also became fully vested in their account balance upon death, disability, reaching normal retirement age (age 65), or termination of the Plan.

All participants became fully vested in their account balance upon transfer to the AI Plan.

Forfeited non-vested amounts could be used to reduce employer contributions or pay plan expenses. As of January 1, 2023 and December 31, 2022 and 2021, the forfeited account was \$0. No forfeitures were used during 2022 or 2023 to pay plan expenses or reduce employer contributions.

Payment of Benefits

A participant's entire vested interest in the Plan was payable upon death; attainment of normal retirement age (65); becoming disabled, as defined; or termination of services. Actively employed participants could begin withdrawing their vested interest without penalty at age 59½. A participant's benefits were payable in a lump-sum payment, installment payments, or a direct rollover to another qualified plan. Immediate lump-sum distributions were to be made to terminated participants if the participant's vested balance was \$1,000 or less. Balances between \$1,001 and \$5,000 were rolled over to an IRA for the benefit of the participant. These mandatory distributions were only applicable if the participant did not elect another form of distribution. In addition, hardship distributions were permitted if specified criteria were met.

Notes Receivable from Participants

A participant could borrow from his/her account the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. Loans were secured by the participant's vested account and bore interest at a fixed rate as of the date of loan origination. The loans were to be repaid over a five-year period unless they were for the purchase of a principal residence, which allowed for up to a ten-year period. Principal and interest were collected ratably through payroll deductions. A participant could have no more than one loan outstanding at any time.

Plan Termination

The Company had the right to discontinue the Plan at any time subject to the provisions of ERISA.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments (except for the fully benefit-responsive investment contract), were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. The Company determined the Plan's valuation policies utilizing information provided by the investment advisor and Issuer.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments included the

Plan's gains and losses on investments bought and sold, as well as held during the year and reinvested capital gains.

Accounting for Fully Benefit-Responsive Investment Contracts with Insurance Companies

The Plan entered into a fully benefit-responsive investment contract with Standard. Plan management evaluated the Stable Asset Fund II and determined that this contract met the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to pay the principal and specified interest rates guaranteed. There are no reserves against the contract value for credit risk of the contract issuer as of December 31, 2022 and 2021. The crediting interest rate is based on a formula agreed upon with Standard and could never be less than 1%. Interest rates were reset monthly. The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events could limit the ability of the Plan to transact at contract value with Standard. Such events included termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions could apply. The Plan liquidated this investment at contract value, although a withdrawal fee was applied to participant accounts upon liquidation.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance. Any accrued, but unpaid, interest was de minimus. If a participant ceased to make loan repayments and the plan administrator deemed the loan to be in default, the participant loan balance was reduced, and a benefit payment recorded.

Contributions

Participant contributions and any related Safe Harbor matching contributions were recognized in the period during which the Company made the respective payroll deduction from the participant's compensation.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Administrative expenses of the Plan were paid by the Company and the Plan. Fees, primarily loan origination, distribution fees, and asset-based fees, were charged directly to the participant's account and are included in administrative expenses or net with investment earnings. All other expenses of the Plan incurred during 2022 were paid by the Company and are excluded from these financial statements.

3. Certified Investment Information

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard Insurance Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments (except for \$66,266 held in the self-directed brokerage account as of December 31, 2021), and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2022 and 2021.
- Net depreciation in the fair value of investments, interest income, and interest earned on participant notes receivable as reported on the statement of changes in net assets available for benefits for the year ended December 31, 2022.
- Investment amounts included in the notes to financial statements.
- All investment information included in the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2022.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Insurance Company Pooled Separate Accounts - These are valued based on the redemption price of units held by the Plan, which is based on the fair value of the separate account's underlying assets. Unit values are determined daily by Standard by applying the net asset value (NAV) of the underlying fund less a management fee.

Self-Directed Brokerage Account (Cash and Stock) - Stocks are valued at the daily closing price as reported by the active market on which the individual securities are traded. Cash and insured deposit account balances are valued at closing of each day.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan sponsored by Standard Retirement Services, Inc. The Internal Revenue Service (IRS) determined and informed Standard, by

an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit-Sharing Plan qualifies under IRC Section 401. The Plan has since been amended; however, the plan administrator and Company management believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date, and no provision for income taxes has been provided for in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Concentrations, Risks, and Uncertainties

The Plan provided for various investments in pooled separate accounts, a self-directed brokerage account, and a guaranteed annuity contract. Additionally, the value, liquidity, and related income of the investment securities were sensitive to changes in economic conditions and could be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. All assets were liquidated and transferred to the AI Plan as further discussed in Note 1.

As of December 31, 2022 and 2021, there were two investments held that individually accounted for more than 10% of net assets available for Plan benefits, respectively. See the supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2022.

7. Related Parties and Party-in-Interest Transactions

The Plan invested in a group annuity contract issued by Standard. Certain fees were paid from plan assets to Standard and its affiliates. Other administrative and investment advisory fees were also paid from the Plan during the year ended December 31, 2022. Standard could also receive certain eligible indirect compensation. The Plan also issued loans to participants that were secured by the vested balance of the participants' accounts. The above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

8. Delinquent Participant Contributions

During 2022, Wadhvani Operating Foundation (Wadhvani) erroneously failed to timely remit certain employee contributions to the Plan in the amount of \$11,251. Wadhvani is in the process of calculating lost earnings and will remit them to the AI Plan as soon as administratively possible.


