1. Part I. 3(a): As of December 31, 2022, approximately .28% (\$46,427) of Plan assets were invested in a limited liability company, S-P Venture, LLC, the purpose of which is to purchase real estate contracts and notes and deeds of trust. The Plan holds approximately a 15.6% interest in S-P Venture, LLC. This LLC is in the process of liquidating.
2. 4(g). The Plan's assets that were not independently valued by an independent third-party appraiser are as follows:

Approximately 25% of the limited liability company assets referred to in Section 1 above and 3 below consist of cash. Approximately 70% consisted of real estate which was sold for cash in March of 2023. Approximately 5% represents the balance owing on a Note secured by a Deed of Trust. The original sales price was \$90,000. It is anticipated that the obligation will be paid in full prior to 12/31/23.
3. 4(i). Approximately .28% of Plan assets as of December 31, 2022, were invested through a limited liability company, the purpose of which is to purchase real estate contracts, notes and deeds of trust. Such entity has been in the process of informal liquidation.
