Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We have performed an audit of the 2022 financial statements of **Planet Fitness 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of August 31, 2022 (date of liquidation), and the related statement of changes in net assets available for benefits for the period ended August 31, 2022 (date of liquidation), and the related notes to the financial statements ("2022 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the period ended August 31, 2022 (date of liquidation), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2022 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the *Independent Auditors' Responsibilities for the Audit of the 2022 Financial Statements* section:

- The amounts and disclosures in the accompanying 2022 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- The information in the accompanying 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Board of Directors of Sunshine Fitness Growth Holdings, LLC, the Plan Sponsor, approved the decision to terminate the Plan in January 2022 with liquidation as of August 31, 2022. Accordingly, the financial statements of the Plan are presented on the liquidation basis of accounting. Our opinion is not modified with respect to this manner.

Basis for Opinion on the 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Independent Auditors' Responsibilities for the Audit of the 2022 Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2022 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Independent Auditors' Responsibilities for the Audit of the 2022 Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an independent auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Independent Auditors' Report on the 2021 Financial Statements

The 2021 financial statements of the Plan as of and for the year ended December 31, 2021 were audited by Vestal & Wiler, CPAs, P.A. ("V&W"), who combined with Rehmann Robson LLC effective November 1, 2022. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed V&W not to perform, and they did not perform, any auditing procedures with respect to the information certified by a qualified institution. Their report dated October 10, 2022, indicated that (a) because of the significance of the information that they did not audit, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the financial statements and supplemental schedules, and (b) the form and content of the information included in the financial statements and supplemental schedules other than that derived from the certified information, were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. PLAN TERMINATION AND BASIS OF ACCOUNTING

Effective August 31, 2022, the *Planet Fitness 401k Plan* (the "Plan") was terminated as a result of the sale of *Sunshine Fitness Growth Holdings, LLC* (the "Company" or "Plan Sponsor") in February 2022. All of the Plan assets were disbursed to individual participants. In accordance with accounting principles generally accepted to the United States of America, the accompanying financial statements are presented on the liquidation basis of accounting for the period January 1, 2022 through August 31, 2022 (date of liquidation) and the accrual basis of accounting as of December 31, 2021.

2. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Description of the Plan

General

The Plan was a defined contribution plan covering all employees of the Plan Sponsor who had at least one year of service (defined as 1,000 hours) and were age 18 years or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year participants were able contribute up to 90% of annual compensation as defined in the Plan agreement, up to maximum allowed by the Internal Revenue Code (the "Code"). Participants who had attained age 50 before the end of the Plan year were eligible to make catch up contributions. Participants were also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to contribute to the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation, and their contributions invested in a designated balanced fund until changed by the participant. This percentage increased 1% each year until a maximum of 6% was reached. The Company also made safe harbor contribution of 100% of the first 1%, and 50% of participants' contributions until a maximum of 5% was reached.

The Company, at its discretion, could have made discretionary matching and profit-sharing contributions. There were no discretionary matching or profit-sharing contributions during 2022. Participants directed the investment of contributions into various investment options offered by the Plan. the Plan offered mutual funds and common collective trusts as investment options for participants. Contributions were subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's matching contributions (when made), and an allocation of (a) the Company's profit-sharing contributions, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Participants who initiated a loan or benefit payment were charged a fee for that transaction. Allocations were based on participant account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their 401(k) voluntary contributions plus actual earnings thereon and 100% vested in the Company's matching and profit-sharing contributions.

Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The resulting notes receivable were secured by the balance in the participant's account and bore interest at rates ranging from 4.25% to 6.25%, which were commensurate with local prevailing rates at the time the notes were issued, as determined quarterly by the Plan Administrator. Principal and interest was collected ratably through payroll deductions. As noted above, the Plan was terminated and all notes receivable were settled.

Payment of Benefits

Upon termination of service, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installment payments, as defined by the Plan agreement. If the participant's account balance was \$1,000 or less, payment was made in an immediate lump-sum without the participant's consent. If the account balance was greater than \$1,000 but less than \$5,000, payment was made to an individual retirement account at the trustee, or such other provider as the Company designated in accordance with Department of Labor ("DOL") guidelines, unless the participant requests a different disposition of his or her account balance within the applicable election period.

In-service withdrawals of vested balances could have been elected by participants who had reached 59 ½ years of age. The Plan also permitted withdrawals of active participants' elective contributions, rollover contributions, and fully vested employer contributions, only in amounts necessary to satisfy financial hardship as defined by the Plan agreement.

As part of the Plan termination, Plan participants received a lump sum payment, net of any outstanding notes receivable balances, as applicable. The Plan was fully liquidated on August 31, 2022.

Forfeited Accounts

Forfeited nonvested accounts were used to reduce Plan expenses or to reduce future employer cash contributions. During 2022, employer cash contributions were reduced by \$517 from forfeited nonvested accounts. There were no forfeited nonvested accounts at August 31, 2022 (date of liquidation). At December 31, 2021, forfeited nonvested accounts totaled \$934.

Administrative Expenses

The Plan's administrative expenses were paid either by the Plan or the Company, as provided by the Plan document. Certain administrative expenses, including an allocation of salaries, accounting, audit and legal costs, were paid by the Company and qualified as party-in-interest transactions, which were exempt from prohibited transaction rules. Expenses that were paid directly by the Company were excluded from these financial statements. Fees for trustee and recordkeeping services were paid by the Plan. Participants were charged directly for notes receivable fees and fees related to certain distribution types.

Summary of Significant Accounting Policies

Basis of Accounting

Due to Plan termination, the accompanying financial statements are presented on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States. This basis of accounting does not differ significantly from the ongoing basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principals generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in aggregate fair value included the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds and exchange traded funds were deducted from income earned on a daily basis and were not separately reflected. Consequently, certain management fees and operating expenses were reflected as an addition to net depreciation in the aggregate fair value of such investments.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and are expensed when they were incurred. No allowance for credit losses was recorded as of December 31, 2021. If a participant ceased to make loan repayments and the Plan Administrator deemed the note receivable to be in default, the participant note receivable was reduced and a benefit payment was recorded.

Contributions

Participant contributions were recorded when withheld from compensation. Employer contributions were recorded in the period in which they become obligations of the Company.

Benefits Paid to Participants

Benefit payments to participants were recorded when paid.

Subsequent Events

In preparing the accompanying financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to August 31, 2022, the date of the most recent statement of net assets available for benefits presented herein, through August 8, 2023, the date these financial statements were available to be issued. No such significant events or transactions were identified.

3. INVESTMENTS

The Plan Administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("Reliance"), as trustee, certified the completeness and accuracy of the investment information reflected in (1) the accompanying statements of net assets available for benefits as of August 31, 2022 (date of liquidation) and December 31, 2021, and (3) the related investment activity reflected in the statement of changes in net assets available for benefits the period ended August 31, 2022 (date of liquidation). Reliance also certified the completeness and accuracy of notes receivable from participants and the related interest income as of and for the period ended August 31, 2022 (date of liquidation).

4. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. For financial assets recorded at fair value, the description includes an indication of the level of the fair value hierarchy in which the assets are classified. There have been no changes in the methodologies used at August 31, 2022 (date of liquidation) and December 31, 2021.

Mutual funds: Shares held in mutual funds are valued at quoted market prices that represent the net asset value ("NAV") of shares held by the Plan at year end and are classified as Level 1. The NAV is based on the value of the underlying assets owned by the fund, less its liabilities, then divided by the number of shares outstanding. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities & Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and, therefore, are deemed to be actively traded.

Common collective trust: Valued at the NAV of units held by each collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value and, as a result, such investments are not assigned a level in the fair value hierarchy. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(1) Certain investments are measured at NAV per share (or its equivalent) on a non-active market and have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the 2021 statement of net assets available for benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers of assets into or out of Level 3 in 2022 and 2021.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Automatic Data Processing ("ADP") was the recordkeeper and Reliance was the trustee of the Plan and therefore, transactions with ADP and Reliance qualify as party-in-interest. Fees paid by the Plan for custodial and recordkeeping services, amounted to \$35,868 for 2022. Fees paid by the Plan for certain additional investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

6. TAX STATUS

The Company's Board of Directors adopted the Automatic Data Processing Non-Standardized Defined Contribution Pre-Approved Plan. The Plan document has received an opinion letter from the IRS dated October 10, 2018, stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Code and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore, believes the Plan is qualified and the related trust is tax exempt.

The Plan Administrator has considered the tax positions taken by the Plan, and has concluded that as of August 31, 2022 (date of liquidation), there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.
