Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of C.H. Briggs Company Employees' Salary Reduction Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of April 30, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period then ended (in liquidation), and the statement of net assets available for benefits as of December 31, 2022 (ongoing) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of C.H. Briggs Company Employees' Salary Reduction Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 30, 2023 (in liquidation) and December 31, 2022 (ongoing), and for the period ended April 30, 2023 (in liquidation), stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of C.H. Briggs Company Employees' Salary Reduction Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of C.H. Briggs Company Employees' Salary Reduction Savings Plan approved a plan of liquidation on January 27, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about C.H. Briggs Company Employees' Salary Reduction Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of C.H. Briggs Company Employees' Salary Reduction Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the C.H. Briggs Company Employees' Salary Reduction Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan that covered all employees of C.H. Briggs Company (the "Company") who had completed at least two months of service from the date of hire, that were not a leased employee or considered seasonal or temporary. The plan administrator was responsible for oversight of the Plan. The Plan Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the plan administrator. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Termination

Effective January 27, 2023, the Plan Administrator and Management of the C.H. Briggs Company Employees Salary Reduction Savings Plan unanimously approved the termination of the Plan. As a result, all Plan participants became fully vested in their account balances. All balances were distributed to the participants pursuant to their instructions. Accordingly, the Statements of Net Assets Available for Benefits for the C.H. Briggs Company Employees' Salary Reduction Savings Plan reflect zero balances as of April 30, 2023.

Participation

An employee became a participant in the Plan on the first day of the calendar month coinciding with or next following the date eligibility requirements were met. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan.

Contributions

Each year, participants could contribute up to 100% of pretax annual compensation or after-tax basis in accordance with the Roth provision, as defined by the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participant contributions to the Plan were recorded in the period that payroll deductions were made from participants. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic contribution increased 1% annually until it reached a maximum of 6%.

Contributions - continued

The Company made a QACA (Matching) Safe Harbor contribution equal to 100% of elective deferrals up to 1% of compensation plus 50% of the amount the participant contributed between 1% and 6% of plan compensation. During the period ended April 30, 2023 and year ended December 31, 2022, the Company made matching safe harbor contributions of \$0 and \$209,668, respectively. In addition, the Company could make additional discretionary contributions, as determined by the Company. There were no discretionary contributions made by the Company for the period ended April 30, 2023 and year ended December 31, 2022. Contributions were subject to certain IRS limitations.

Participants directed the investment of all contributions into various investment options offered by the Plan. If the participant failed to provide such direction, including those participants automatically enrolled in the Plan, contributions were invested in a designated fund.

Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account was based on years of continuous service. A participant was 100% vested after two years of credited service.

Notes Receivable from Participants

Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates (4.25% - 7.25% at December 31, 2022). Principal and interest was paid ratably through bi-weekly payroll deductions. Terms ranged from one to five years or greater for the purchase of a primary residence. These notes receivable were satisfied under the plan provisions due to the plan termination and were \$0 as of April 30, 2023.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant would receive a lump-sum amount equal to the value of the participant's vested interest in their account. In addition, the Plan allowed for hardship distributions if certain criteria were met.

Forfeited Accounts

At April 30, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$51,615, respectively. These accounts were allocated to eligible participants, used to pay plan administrative expenses, or used to reduce Employer contributions as specified in the plan document. During the period ended April 30, 2023, \$51,685 of forfeited amounts were used to pay plan administrative expenses from the forfeiture account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting used to determine the amounts at which investments were stated, from the ongoing basis used in presenting the 2022 financial statements to the liquidation basis used to presenting the 2023 financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments purchased and sold as well as held during the year.

The Plan held certain investments that represented 10% or more of the Plan's total investments at December 31, 2022:

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses were recorded as of April 30, 2023 or December 31, 2022. Delinquent participant loans were recorded as distributions on the basis of the terms of the plan document.

Payment of Benefits

Benefits were recorded when paid or when distributions were made.

Administrative Expenses

Certain expenses incurred maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of the Plan including processing of benefit payments and notes receivable from participants were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common collective trust fund: The CCT was comprised primarily of fully benefit-responsive investment contracts, which included conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions, designed to provide principal stability and a competitive yield. The CCT was valued at the net asset value (NAV) of units of the T. Rowe Price Trust Company (T. Rowe Price) collective trust. The net asset value was used as a practical expedient to estimate fair value. The practical expedient would not have been used if it was determined to be probable that the fund would sell the investment for an amount different from the reported net asset value.

NOTE 4 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualified as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment manager services were included in net appreciation in the fair value of the investment.

NOTE 5 - PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. As a result of the Plan termination (see Note 1) the participants became 100% vested in their accounts. Newport Trust Company was removed as the Plan's Trustee following the final distribution of Plan assets.

NOTE 6 - TAX STATUS

The Company had a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by Newport Group Inc. The pre-approved profit sharing plan had received an opinion letter from the Internal Revenue Code (IRC) dated November 30, 2020, as to the pre-approved profit sharing plan's qualified status. Although the Plan had been amended since receiving the determination letter, the plan administrator believed that the Plan was designed and was currently being operated in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified and that the related trust was tax exempt.

Accounting principles generally accepted in the United States of America required plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

On June 1, 2023, the Plan received a notice from the U.S. Department of Labor that their office was conducting an investigation under ERISA. At this time, the inquiry is not construed as an indication that any violation of law has occurred or as a reflection upon any person involved in this matter. The Plan is cooperating with the investigation and has no knowledge of any instances of noncompliance or suspected noncompliance with laws and regulations.

NOTE 8 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at April 30, 2023 and December 31, 2022, and net appreciation in the fair value of investments, interest and dividends, and interest income on notes receivable from participants was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Newport Trust Company, the trustee of the Plan.
