## NOTES TO FINANCIAL STATEMENTS NOVEMBER 14, 2022 AND DECEMBER 31, 2021

---

### 1. DESCRIPTION OF PLAN

The following description of the DiCicco, Gulman & Co. LLP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a contributory defined contribution 401(k) plan covering all eligible employees of DiCicco, Gulman & Co. LLP (the Company). Effective February 18, 2017, service for purposes of eligibility in this Plan shall include service with the following predecessor employers: Troy Orleans & Wexler and Forman, Itzkowitz, Berenson & LaGreca, P.C. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On December 13, 2021, the Board approved a resolution to merge the Company with PKF O'Connor Davies (PKFOD) effective January 1, 2022. The Board also approved a merger of the Plan with the PKF O'Connor Davies LLP 401(k) Savings & Retirement Plan (PKFOD Plan) effective January 1, 2022. As a result, all assets of the DiCicco, Gulman & Co. LLP 401(k) Profit Sharing Plan were transferred on November 14, 2022.

#### **Administration**

The Company is the sponsor and administrator of the Plan. Fidelity Management Trust Company (Fidelity) is the trustee and recordkeeper of the Plan.

#### **Eligibility**

Individuals become eligible to participate in the Plan after attainment of age 21.

#### **Contributions**

Participants may contribute up to 75% of their eligible salaries or wages, as defined in the Plan's literature. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The employer may make a discretionary non-elective contribution to the Plan on behalf of plan participants. The amount contributed on behalf of the participants will be allocated pro rata as a uniform percentage of participant's eligible compensation. Discretionary non-elective contributions were made in 2021 in the amount of \$953,153. There were no employer contributions made in 2022. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with (a) the participant's contribution, (b) the Company's discretionary contribution, (c) the Plan's earnings (losses), (d) administrative expenses, and (e) payments of benefits. Allocations are based on compensation and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investment Options**

Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. Participants may change their allocation on a daily basis.

## 1. DESCRIPTION OF PLAN (Continued)

### Vesting

Participants are immediately vested in their contributions, qualified rollovers, and net earnings (losses) thereon. Participants who receive employer contributions are not fully vested in those contributions until 6 years of service are completed. The schedule is as follows:

Employees become fully vested by retirement (defined as age 65), death, or disability.

### Forfeitures

Forfeitures of terminated participants' non-vested accounts are used to offset future employer contributions or to pay for administrative expenses of the plan. As of December 31, 2021, the unallocated forfeiture balance was \$197,291. The amount of forfeitures used to offset employer contributions in 2021 were \$223,681. Approximately \$46,824 of forfeited non-vested accounts were transferred to the PKFOD Plan upon merger, therefore there were no forfeited non-vested accounts remaining at November 14, 2022.

### Payment of Benefits

Benefits are payable to plan participants in the event of death, retirement, or disability. Upon one of these occurrences, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum or may elect installment payments on a quarterly or annual basis. A participant whose vested account balance is \$5,000 or less and has not commenced receiving installment payments will have their account balance rolled over into an IRA if the balance exceeds \$1,000 or will automatically receive an immediate lump-sum distribution equal to their vested account balance if the balance is \$1,000 or less.

In-service withdrawals are available in certain circumstances, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

### Administrative Expenses

Certain plan administrative costs have been paid by the Company and are excluded from these financial statements.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in their account during the prior 12-month period, whichever is less. Participants may only have one loan outstanding at any given time and all loans must be repaid in level payments on at least a quarterly basis over a 5-year period or a 10-year period if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through semi-monthly payroll deductions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All Plan assets were transferred to the PKFOD Plan effective November 14, 2022.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. All notes receivable from participants were transferred to the PKFOD Plan effective November 14, 2022.

### **Fair Value Measurement - Definition and Hierarchy**

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820 (ASC 820)* establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available.

Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances.

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

The Plan's investments in mutual funds and money market funds are valued using Level 1 inputs.

- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly, or indirectly.

The Plan has no investments valued at Level 2 inputs.

- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The Plan has no investments valued at Level 3 inputs.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value Measurement - Definition and Hierarchy (Continued)**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit risks and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 3. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information was certified as accurate and complete by Fidelity Management Trust Company, the trustee of the Plan, as of and for the period ended November 14, 2022 and as of and for the year ended December 31, 2021, and is included in the accompanying financial statements:

### 5. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. At December 31, 2021, the Plan invested in mutual funds managed by Fidelity Management Trust Company, the trustee of the Plan, and as such, these investments qualify as party-in-interest investments.

In addition, the plan allowed participants to receive participant loans under specific circumstances. As such, transactions between the participants that have notes receivable with the Plan qualify as party-in-interest transactions.

## 6. PLAN TERMINATION

The Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participant accounts would become fully vested.

## 7. TAX STATUS

The Plan adopted a volume submitter plan sponsored by Fidelity Management Trust Company. The volume submitter plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since the date of the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and has no income subject to unrelated business income tax. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

**9. PLAN TRANSFER**

On December 13, 2021, the Board approved a resolution to merge the Company with PKF O'Connor Davies (PKFOD) effective January 1, 2022. The Board also approved a merger of the Plan with the PKF O'Connor Davies LLP 401(k) Savings & Retirement Plan (PKFOD Plan) effective January 1, 2022. As a result, all assets of the DiCicco, Gulman & Co. LLP 401(k) Profit Sharing Plan were transferred on November 14, 2022. The total transferred net assets amounted to \$20,318,823.
