## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
JH Associate Management, LLC 401(k) Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of JH Associate Management, LLC 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statement of net assets in liquidation available for benefits – modified cash basis as of April 19, 2022 and December 31, 2021, and the related statement of changes in net assets in liquidation available for benefits– modified cash basis for the period then ended April 19, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting**

As discussed in Note 1 to the financial statements, the governing body of JH Associate Management, LLC 401(k) Plan and Trust approved a plan of liquidation on March 22, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statement.

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is **not modified with respect to this matter.**

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Supplemental Schedule Required by ERISA***

The supplemental schedule, schedule of delinquent participant contributions for the period ended April 19, 2022, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO THE FINANCIAL STATEMENTS

## NOTE 1 – DESCRIPTION OF PLAN

The following description of the JH Associate Management, LLC 401(k) Plan and Trust, (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan with a 401(k) provision covering all employees of JH Associate Management, LLC (the “Employer” and “Company”). Employees become eligible to participate upon attaining the age of 21, as defined in the Plan. Employees become eligible for matching contributions upon attaining the age of 21 and completing 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**Plan Termination.** On March 22, 2022, the Company expressed intent to terminate the Plan subject to the provisions of ERISA and management determined liquidation is imminent. As a result of the plan termination, all participant account balances became fully vested. Effective April 19, 2022, management approved Plan provisions to terminate the Plan and the remaining assets of \$1,702,451, were transferred to another qualified plan as shown as a transfer out on the Statement of Changes in Net Assets in Liquidation Available for the period ended April 19, 2022.

**Contributions.** Participants could elect to contribute a percentage of their pretax earnings and/or a percentage of their post-tax net earnings to the Plan, which were limited and subject to amounts established by the Internal Revenue Code (the “Code”). Participant contribution elections could be changed upon notice to the Plan’s administrator (“Plan Administrator”). A participant’s pretax earnings consisted of total compensation including bonuses during the Plan year. A participant’s post-tax earnings were comprised of earnings less all taxes and other deductions from gross earnings. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

At its discretion, the Company makes an Employer matching contribution each payroll period to those Plan participants who were active employees, as defined; however, participant contributions designated as catch-up contributions were not matched. The Company matched 100% of the first 3% of eligible compensation, as defined by the Plan, which a participant contributed to the Plan. The percentage of eligible compensation the Company matched was determined at the discretion of the Company. Effective November 1, 2020, the Company suspended matching contributions until further notice. Additional Employer discretionary nonmatching contributions, if any, could be contributed annually at the discretion of the Company to eligible participants who were employed as of the last day of the Plan year. The Company did not elect any additional Employer discretionary contributions for the period ended April 19, 2022. Contributions were subject to certain limitations.

**Participants’ Accounts.** Each participant’s account was credited with the participant’s contributions and Employer matching contributions, as well as allocations of Employer nonmatching contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

**Investment Options.** Participants could direct their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions were permitted pursuant to Plan provisions.

**Vesting.** Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts plus actual earnings thereon was based on years of credited service. A participant became 33% vested in Employer contributions after one year of service, increasing by 33% for each additional year of service until year 3 when the participant was 100% vested. However, if an active participant died or became disabled prior to attaining the normal retirement age, the participant’s account became 100% vested.

**Notes Receivable from Participants.** Participants could borrow from their accounts a minimum of \$1,000 and up to 50% of their vested account balance, provided that such loan did not exceed \$50,000. The loans were secured by the balance in the participant's account and bore interest at the local prevailing rates as determined periodically by the Plan Administrator. Principal and interest was paid ratably through payroll deductions.

**Forfeited Accounts.** Forfeited balances of terminated participants' non-vested accounts were used to reduce Plan administrative expenses or future Employer contributions. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. As of April 19, 2022 and December 31, 2021, there were no forfeited non-vested accounts.

**Party-In-Interest Transactions.** Substantially all expenses pertaining to the operation were paid out of Plan assets which were allocated among the accounts of all participants in the Plan, unless paid by the Employer. Additionally, various administrative, legal, and accounting services were performed by Employer personnel on behalf of the Plan for which no charges were made to the Plan, and for which the Employer did not intend to obtain reimbursement. Investment expenses were charged against the Plan's investment income. Certain Plan investments were shares of mutual funds managed by a related party to Mid Atlantic Trust Company, the trustee of the Plan ("Mid Atlantic" or the "Trustee"), and therefore these transactions qualified as party-in-interest transactions.

**Payment of Benefits.** Benefit payments were generally made in a lump-sum upon termination, disability, or normal retirement, as defined in the Plan agreement. Early voluntary withdrawals were paid based on financial hardship with approval of the Plan Administrator.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting.** The accompanying financial statements are presented on the liquidation modified cash basis of accounting, which is other comprehensive basis of accounting ("OCBOA") other than accounting principles generally accepted in the United States of America. Under this method, contributions and interest and dividend income are recorded when cash is received by the Plan and benefits and administrative expenses are recorded when cash is disbursed by the Plan.

**Estimates and Assumptions.** The preparation of financial statements presented on the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

**Concentration of Credit Risk.** Substantially all of the Plan's investments were held by the Trustee. The Trustee is a qualified institution pursuant to ERISA.

**Investment Valuation and Income Recognition.** Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits.** Benefits were recorded when paid.

**Administrative Expenses.** Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that were prepared by the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Trustee that such information is complete and accurate:

- Investments as shown in the statement of net assets in liquidation available for benefits as of April 19, 2022 and December 31, 2021.
- Investment income, as shown in the statement of changes in net assets in liquidation available for benefits for the period ended April 19, 2022.
- Note 4: All investment balances.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2.** Inputs to the valuation methodology include the following:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of April 19, 2022 and December 31, 2021.

**Mutual Funds and Money Market Accounts.** Valued at quoted market price.

**Common Collective Trust ("CCT").** A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at NAV. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement:

**NOTE 5 – TAX STATUS**

The Plan uses a prototype plan document sponsored by Mid Atlantic. Mid Atlantic received a favorable determination letter from the Internal Revenue Service (“IRS”) dated March 31, 2014, which states that the prototype document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the financial statement.

**NOTE 7 – DELINQUENT REMITTANCES**

During the period ended April 19, 2022, the Employer inadvertently failed to deposit participant contributions totaling \$16,006 to the Plan timely. Before period end management elected to use the self-correction program to remit lost earnings to the Plan and file Form 5330 with the IRS to pay applicable excise taxes, which has been paid from Employer funds and not Plan assets.
