## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
HBO Latin America 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of HBO Latin America 401(k) Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of November 14, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to November 14, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HBO Latin America 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 14, 2022 and December 31, 2021, and for the period from January 1, 2022 to November 14, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of HBO Latin America 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about HBO Latin America 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about HBO Latin America 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Emphasis of Matter – Plan Merger**

As discussed in Note 1A to the financial statements, effective November 14, 2022, the Plan was formally amended and approved for merger into the WarnerMedia 401(k) Savings Plan. As a result, all Plan assets were transferred out of the Plan on said date. Our opinion is not modified with respect to that matter.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the HBO Latin America 401(k) Plan (the “Plan”) provides only general information about the Plan prior to its merger with and into the WarnerMedia 401(k) Savings Plan (“WarnerMedia Plan”). Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

(A) GENERAL

The Plan was a defined contribution 401(k) and profit sharing plan covering certain employees of HBO Latin America Production Services, L.C. (the “Company”) who were at least eighteen years old. Eligible employees were automatically enrolled in the Plan. The Plan was established in 1998 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 14, 2022, plan management formally amended the Plan and approved the merger of the Plan with and into the WarnerMedia Plan. As a result, all assets were transferred from the Plan into the WarnerMedia Plan on that date.

(B) CONTRIBUTIONS

Effective December 31, 2021, the Plan was frozen and all contributions to the Plan were suspended. As a result, there were no contributions to the Plan during the period ended November 14, 2022.

(C) VESTING

Participants were immediately fully vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. Vesting on the employer’s contributions was as follows:

Participants were 100% vested, regardless of years of service, when they reach normal retirement age, were totally and permanently disabled, or death occurred.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

(D) PAYMENT OF BENEFITS

Benefits were payable on termination of service due to retirement, termination, disability or death. Participants or their beneficiaries could elect to receive a lump-sum distribution as defined in the Plan document. Qualifying participants could also request a hardship distribution from the Plan, as defined by the Plan document.

(E) PARTICIPANT ACCOUNTS

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account. Forfeitures of terminated participants' non-vested accounts could be applied to reduce the employer's contribution obligation, if any.

(F) INVESTMENT OPTIONS

Upon enrollment in the Plan, a participant could direct employee and employer matching contributions to various investment options offered by the Plan. Participants could change their allocations on a daily basis. Fidelity Management Trust Company ("Fidelity"), a qualified institution, was the appointed trustee of the Plan's assets during the period from January 1, 2022 to November 14, 2022 and as of December 31, 2021. Effective November 14, 2022, the Plan was merged into the WarnerMedia Plan and approximately \$26,000,000 in Plan assets were transferred to the WarnerMedia Plan.

(G) NOTES RECEIVABLE FROM PARTICIPANTS

Participants could borrow from their fund accounts a minimum of \$1,000 and a maximum amount of the lesser of; 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participants' account during the prior twelve-month period. The loans were secured by the balance in the participant's account and bore interest at a fixed rate through maturity. Principal and interest was paid ratably through periodic payroll deductions. Effective November 14, 2022, the Plan was merged into the WarnerMedia Plan and approximately \$372,000 in notes receivable from participants were transferred to the WarnerMedia Plan.

(H) FORFEITED ACCOUNTS

Forfeited non-vested accounts were used to pay Plan expenses or to reduce the Company's discretionary contributions. During the period from January 1, 2022 to November 14, 2022, approximately \$1,000 in forfeitures were utilized to pay Plan expenses. As of December 31, 2021, forfeited non-vested accounts totaled approximately \$14,000. Effective November 14, 2022, the Plan was merged into the WarnerMedia Plan and approximately \$28,000 in forfeitures were transferred to the WarnerMedia Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(A) BASIS OF ACCOUNTING

The Plan's financial statements have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America ("GAAP").

(B) INVESTMENT VALUATION AND INCOME RECOGNITION

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments were valued at market value based on published quotations.

Purchases and sales of securities were recorded on a trade date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded in the period earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(C) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans were reclassified as deemed distributions based upon the terms of the Plan document.

(D) USE OF ESTIMATES

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

(E) PAYMENT OF BENEFITS

Benefits were recorded when paid.

(F) PLAN ADMINISTRATION EXPENSES

Certain administrative costs, which primarily included fees related to recordkeeping, were charged to the Plan as permitted under the Plan and ERISA. During the period ended November 14, 2022, approximately \$27,000 in administrative expenses were incurred by the Plan.

(G) SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 5, 2023, the date when the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments were reported at fair value in the accompanying statement of net assets available for benefits.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds – The fair value of mutual funds was based on quoted net asset values in active markets.

Self-Directed Brokerage Accounts – Included a variety of cash and cash equivalents, mutual funds and common stock, which were valued at the closing price reported on the active market on which the individual securities were traded.

Due to the Plan merger, there were no investments held as of November 14, 2022. The following table sets forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2021:

NOTE 4 – PLAN TERMINATION AND MERGER

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balance, including employer contributions.

Effective November 14, 2022, the Plan was merged into the WarnerMedia Plan and all assets were transferred from the Plan into the WarnerMedia Plan.

NOTE 5 – TAX STATUS

The Plan adopted a standardized plan, which has obtained an opinion letter from Internal Revenue Service (“IRS”) dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan’s design and operation comply with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 6 – INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee, has certified that the following information included in the accompanying financial statements is complete and accurate as of November 14, 2022 and December 31, 2021 and for the period from January 1, 2022 to November 14, 2022.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

NOTE 7 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments were shares of mutual funds and money market funds managed by Fidelity. Fidelity is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Effective November 14, 2022, the Plan was merged into the WarnerMedia Plan and all assets were transferred from the Plan into the WarnerMedia Plan. Fees paid by the Plan for the investment management services are included in net appreciation or depreciation in fair value of investments as they are paid through revenue sharing, rather than direct payment. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – FIDELITY BONDING

The Company maintains a fidelity bond of \$30,000,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.
