## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Pioneer Balloon Company 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### **Responsibilities of Management for the Financial Statements**

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. DESCRIPTION OF PLAN**

The following description of the Pioneer Balloon Company 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions. The Fiduciary Committee is responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investments offerings, monitors investment performance and reports to the Plan's Fiduciary Committee.

Eligibility - The Plan is a defined contribution savings and retirement plan allowing employee deferral and matching contributions for employees of Continental American Corporation d/b/a Pioneer Balloon Company and participating affiliates (Company) who have been employed for 90 days, have completed 300 hours of credited service in those 90 days and are age 18 or older. To be eligible to participate in any discretionary profit sharing contributions, an employee must have been employed for one year, completed 1,000 hours of credited service and be age 21 or older. The Plan entrance dates for eligible employees are January 1, April 1, July 1, or October 1 of the Plan year. The Plan excludes from participation hourly employees of Pioneer - RAM Incorporated, "Finish Packaging" employees, and "Dallas Utility" employees along with union employees and non-residential employees, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Plan provides that active participants may make voluntary contributions to the Plan up to 75% of their compensation for the year up to the maximum allowed by the Internal Revenue Code (\$20,500 for 2022) as adjusted for applicable percentages of compensation. Eligible compensation includes W-2 wages; and excludes fringe benefits, bonuses, and commissions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$6,500 for 2022). The Company provides for discretionary matching contributions equal to 50% of the first 6% of each participant's contribution. No profit sharing contributions were made in 2022. Participants direct the investment of their contributions as well as the Company's matching and additional contribution into various investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contribution, Company's contribution, Plan earnings and allocations of Plan expenses. Participants who request services may also be charged an administrative fee. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Early and Normal Retirement - Normal retirement age is the later of age 65 or the fifth anniversary of participation. Early retirement age is the later of age 55 or seven years of service.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants become fully vested in employer contributions after three years of credited service.

Notes Receivable from Participants - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at prime plus 1%.

Principal and interest is paid ratably through payroll deductions. Notes receivable may not exceed five years unless the note is for the purpose of purchasing a personal residence, in which case the term may be up to ten years.

Forfeitures - Forfeitures of nonvested amounts can be used to pay Plan expenses, reduce the employer's contribution to the Plan, reinstate previously forfeited account balances of former participants who have been reinstated to the Plan, or included as additional employer contributions to participants in the year of the forfeiture. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$4,035 and \$837, respectively. In 2022, \$10,597 was used to offset Plan expenses.

Payment of Benefits - Payment options for the vested portion of the participant's account at retirement, death, disability, or termination are made in the form of a lump-sum payment or installments for required minimum distributions only. Participants may also make in-service withdrawals, including for financial hardships as defined by the Plan.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared under the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Valuation of Investment and Income Recognition - Investments are valued at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. The purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance has been recorded as of December 31, 2022 and 2021 for these notes receivable. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Benefits Paid to Participants - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of the Plan may be paid directly by the Company and are therefore excluded from these financial statements. Fees related to the administration

of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Some investment related expenses may be included in net change in fair value of investments.

Subsequent Events - These financial statements considered subsequent events through August 25, 2023, the date the financial statements were available to be issued.

The Plan Administrator has obtained certifications from Empower and Great-West that information provided to the Plan Administrator by Empower and Great-West related to the following is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information below, the values in Notes 4 and 5, and the values in the supplemental schedule related to the following assets:

The following describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* - These investments are valued using a quoted price in an active market.

*Collective Investment Trusts* - These investments are valued at the net asset value (NAV). The NAV, as provided by Empower, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

**5. GUARANTEED INVESTMENT CONTRACT**

The Plan invests in a guaranteed investment contract (GIC) which invests solely in the Empower Key Guaranteed Portfolio Fund. The Group Fixed Deferred Annuity Contract, also known as the GIC, meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Contract value at December 31, 2022 and 2021 was \$2,861,093 (unaudited) and \$3,401,390 (unaudited), respectively.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The fund also has no unfunded commitment, a daily redemption frequency and no redemption notice period required from participants. New money interest crediting rate is reset quarterly and shall never be less than 0%. The contract may terminate with at least 60 days advance written notice to the other party.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments

Either party to the Group Fixed Deferred Annuity Contract may terminate the contract with at least 60 days advance written notice to the other party for any reason.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletions of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a

significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are managed by Empower (party-in-interest), and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower for certain investment management fees were deducted from the net asset values of the registered investment companies held by the Plan. The various funds' operating expense ratios ranged from 0.02% to 1.15%, as of December 31, 2022. Fees incurred and paid by the Plan for the investment management and other services were \$103,201.

**7. TAX STATUS**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan designed to qualify under Section 401(a) of the Internal Revenue Code. The Plan has obtained a copy of a favorable determination letter for the non-standardized pre-approved profit sharing plan dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan is relying on this letter. Although the Plan may have been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

**8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the interest of the participants in the Plan shall be fully vested at the time of termination, and Empower shall liquidate all assets of the trust and continue to administer the trust in accordance with its provisions until all obligations have been satisfied.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
