Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of Novinium 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits in liquidation as of September 6, 2022 (date of Plan liquidation) and the related statement of changes in net assets available for benefits (in liquidation) for the period from January 1, 2022 through September 6, 2022, and the statement of net assets available for benefits (ongoing) as of December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Novinium 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 22, 2022 and December 31, 2021, and for the period from January 1, 2022 to August 22, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Novinium 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of Novinium 401(k) Plan approved a plan of liquidation on March 24, 2022 and the Plan was liquidated as of September 6, 2022. As a result, the Plan is presenting the 2022 financial statements on the liquidation basis of accounting and the 2021 financial statements on an ongoing basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Novinium 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

Liquidation and Termination - Novinium Inc., (the Company or plan sponsor) was acquired by Southwire Company, LLC on March 28, 2022. The Plan’s sponsor directed by resolution that the Plan should be to terminated effective March 24, 2022 (termination date). On June 15, 2022, participants were informed of the Plan’s intent to distribute all account balances as soon as administratively feasible, in the form of a single sum payment, within 12 months of the termination date. All participants were fully vested in their accounts within the Plan on the termination date. All Plan investments and notes receivable from participants were distributed by August 22, 2022 and September 6, 2022, respectively.

The following Plan provisions were in effect prior to the Plan termination.

General - The Plan is a participant-directed defined-contribution plan covering all employees of Novinium Inc. (the Company) who are eligible and who have completed thirty days of entry service. A participant joins on the first day of the month on or after meeting the requirements. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan, with deferral rate set at 3% of eligible compensation unless another deferral rate is specified. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year participants may contribute up to the maximum amount allowed by the Internal Revenue Code of annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may designate all or a portion of their elective deferrals as Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans. Participants who are eligible to make salary deferrals to the Plan are generally eligible for the safe harbor employer contribution equal to 100% of a participant’s elective deferral contributions which are not over 3% of compensation plus 50% of elective deferral contributions between 3%-5% of compensation. All contributions are invested in accordance with fund allocations specified by plan participants. In 2022, contributions were received and invested up to the pay period ended March 20, 2022.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contributions and (b) Plan earnings and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1 - Continued

Vesting - Participants are immediately vested in their contributions and the Company's safe harbor contributions plus actual earnings thereon.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in mutual funds, common/collective trusts and pooled separate accounts. The mutual funds are held under contract with registered investment companies. The common/collective trust and pooled separate accounts are held under contract with Principal Trust Company, a member of the Principal Financial Group (Principal). Participants may change their investment options daily, except for certain Principal fund options which can only be changed on a monthly basis.

The pooled separate accounts are held under contract with Principal to invest in the group annuity contract and Principal agrees to pay benefits to the plan participants from the proceeds of the group annuity contract investment.

The Plan administrator periodically reviews the investment fund options available to participants and drops or adds investment funds as warranted.

Notes Receivable from Participants - Participants may borrow from their accounts a maximum of \$50,000 or 50% of their vested account balance, subject to a minimum of at least \$1,000. Loan transactions are treated as a transfer between investment funds and the Participant Loan Fund. Loan terms range from 1 to 5 years, or more if for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at commercially reasonable rates commensurate with similar types of loans by other lenders. Interest rates on loans at the plan termination date were 5.25% to 7.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - Upon termination of service, a participant may elect to receive either in a lump-sum or in partial withdrawals, an amount equal to the value of the participant's vested interest in his or her account. Upon reaching 59 ½, and under certain hardship circumstances, participants may request a lump-sum distribution of their vested account balances prior to retirement.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting and on liquidation basis for the period January 1, 2022 to September 6, 2022 and on an ongoing basis for the year ended December 31, 2021.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments, other than fully benefit-responsive investment contracts, are required to be reported at fair value. The Plan Administrator determines the Plan's valuation policies utilizing information provided by Principal. See Note 4 for discussion on fair value measurements.

Note 2 - Continued

For fully benefit-responsive contracts, contract value is the relevant measurement attributable to that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of September 6, 2022 or December 31, 2021.

Payment of Benefits - Benefits are recorded when paid.

Operating Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration, participant requested services and loan fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation of fair value of investments.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN

The Plan's management elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, certain information certified by a qualified trustee or custodian need not be subject to independent audit.

Plan's management has obtained certification from the custodian that the following information included in the Plan's financial statements is complete and accurate:

1. Fair value and contract value of investments as of December 31, 2021,
2. The balance of notes receivable from participants as of December 31, 2021,
3. Investment income earned for the period from January 1, 2022 through August 22, 2022, and
4. Investment transactions for the period from January 1, 2022 through August 22, 2022.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest

priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and for the period from January 1, 2022 to September 6, 2022

Mutual funds: valued at the publicly quoted net asset value of each fund. The total value is calculated by multiplying the net asset value per share by the number of shares held as of the measurement date.

Collective trust funds: valued using the NAV as a practical expedient, which is based on the quoted market prices of the underlying securities of the funds. The unit price is based on the value of the underlying investments assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The collective trust funds provide for daily redemptions by the Plan at reported NAV with no advance notice requirements.

Pooled separate accounts: Valued at the net asset value (NAV) of units held by the plan as reported by Principal, which is based on the fair value of the underlying investments. The use of NAV is deemed appropriate as these types of investments do not have finite lives or significant restrictions on redemptions.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY IN INTEREST

Principal acts as custodian and trustee for certain investments of the Plan and provides record keeping services; therefore, transactions with Principal qualify as party-in-interest transactions. Fees paid by the Plan for contract administration were \$55,346 for the period January 1, 2022 to September 6, 2022, and \$82,588 for the year ended December 31, 2021.

NOTE 6 - PLAN TERMINATION

Under the Plan, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. See Note 1.

NOTE 7 - PRINCIPAL FIXED INCOME GUARANTEE OPTION

The Plan invested in the Principal Fixed Income Guarantee Option (the "Contract"), a benefit-responsive group annuity contract issued by the Principal Life Insurance Company. The Contract is not a portfolio of contracts whose yields are based on changes in the fair value of underlying assets,

but is rather a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned, or the interest credited, on the group annuity contract. The underlying assets consisted primarily of treasuries, commercial real estate mortgages, mortgage-backed securities and short-term cash equivalents.

The interest crediting rate is determined on a semiannual basis and is calculated based upon many factors, including current economic and market conditions, the general interest rate environment, and purchases and redemptions by unit holders. An employer-level surrender of the Plan's interest in the Principal Fixed Income Option or employer-initiated transfer will be subject to either a 12-month irrevocable advance notice or a 5% surrender charge, whichever the employer chooses.

The average market yield earned by the Contract, which is also the actual interest credited to participants in the Contract, for the period January 1, 2022 to September 6, 2022 was 1.55% through May 2022 and 3.6% through September 6, 2022.

NOTE 8 - TAX STATUS

Effective January 1, 2017, the Company adopted a standard Principal Life Insurance Company (PLIC) prototype plan and related trust that the Internal Revenue Service (IRS) has determined, in an opinion letter dated June 30, 2020, to be designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the financial statements.

Generally accepted accounting principles require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of September 6, 2022, the Plan has not taken any uncertain positions that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, years prior to 2019 are no longer subject to examination.

NOTE 9 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through September 1, 2023, the date which the financial statements were available to be issued.

We have audited the financial statements of Novinium 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the period January 1, 2022 to September 6, 2022 (liquidation basis), and we will issue our report thereon dated September 1, 2023. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Principal Trust Company, the custodian, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated May 15, 2023. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

You are responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Novinium 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2022. The 2022 financial statements have been prepared on the liquidation basis of accounting because plan obligations were settled directly with participants during the period January 1, 2022 to September 6, 2022. We noted no transactions entered into by the Plan during the period up to the date of liquidation for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements and are based on your knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was valuation of the Plan's investments. Because the investments are excluded from audit procedures under an ERISA Section 103(a)(3)(C) audit, we did not test the valuation at the Plan or participant level.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements identified (corrected or uncorrected) during the audit.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated September 1, 2023.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

The System and Organization Controls 1 (SOC 1) Report for Principal Life Insurance Company is widely used and relied on in the audit of the Plan's financial statements. Management is responsible for reading this report and ensuring that the required complementary user controls are in place and effective, in order for Principal's controls to be effective.

Other Matters

This information is intended solely for the use of the Trustees and Management of the Novinium 401(k) Plan and is not intended to be, and should not be, used by anyone other than these specified parties.
