INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
USA Healthcare, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of USA Healthcare, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits in liquidation as of June 30, 2023, and December 31, 2022, and the related statement of changes in net assets available for benefits in liquidation for the period ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of USA Healthcare, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2023, and December 31, 2022, and for the period ended June 30, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of USA Healthcare, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter-Basis of Accounting

As discussed in Note 3 to the financial statements, the Plan Administrator of the USA Healthcare, Inc. 401(k) Plan approved a plan liquidation on December 5, 2022, and management determined liquidation was imminent. As a result, the Plan has presented the financial statements using the liquidation basis of accounting as of and for the period ended June 30, 2023, and as of December 31, 2022. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1: DESCRIPTION OF THE PLAN

The following description of USA Healthcare, Inc. 401(k) Plan (the “Plan”) provides only general information. Refer to the Plan documents for a more complete description of Plan provisions.

General

The Plan was a defined contribution plan covering substantially all employees of USA Healthcare, Inc. (the “Company”, “Sponsor”, “Employer”, or “Plan Administrator”) and its affiliates. The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

Some administrative functions were performed by employees of the Company. No compensation was remitted to the Company for these services. The Plan’s management determined the appropriateness of the Plan’s investment offerings and monitors investment performance.

Plan assets were held by Mid Atlantic Trust Company, the custodian and qualified institution for the Plan, which processed trades as directed by the Plan management or third party administrator, and provided asset pricing. AT Retirement Services, LLC served as third party administrator for the Plan. Their duties include performing certain plan administration, providing recordkeeping services and annual ERISA compliance testing.

Eligibility

The Plan covered substantially all full-time employees excluding non-resident aliens who have no earned income from sources within the United States, union employees, leased employees, independent contractors and illegal aliens. The employees were required to meet other requirements such as reaching twenty-one years old with the completion of a year of eligibility service, during which they complete 1,000 hours of service. They then became eligible for participation in the Plan on the first entry date following the required eligibility. Entry dates are the 1st day of the 1st month or 7th month coincident with the date the requirements are satisfied.

USA Healthcare, Inc. 401(k) Plan Notes to Financial Statements

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

Contributions

The Plan permitted participants to contribute from 2% to 20% of pretax annual compensation up to the Internal Revenue Service maximum allowable amount (\$22,500 for 2023 and \$20,500 for 2022), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (up to \$6,500). Participants also could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Company could, in its sole discretion, make employer matching contributions. The Company elected to make employer matching contributions to the Plan each year equal to 12% of the first 20% of participant deferrals, not to exceed 2.4% of the participant's compensation. Contributions are subject to certain limitations.

During the period ended June 30, 2023, the Company contributed \$7,700 in employer matching contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after three years of credited service. All participants' accounts became full vested upon Plan termination.

Contributions Receivable

Contributions receivable include those pursuant to formal commitments based on the Plan's adoption agreement. Evidence that a formal commitment existed was based on criteria that (a) the contribution is based on participant compensation that existed for the current plan year and (b) the plan terms require a contribution to be made for the current plan year.

Notes Receivable from Participants

Participant loans are not allowed under the Plan provisions.

The accompanying notes are an integral part of these financial statements.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Benefit Payments

The Plan provided retirement benefits for participants who reach normal retirement age of sixty-five. Early retirement age is the later of age fifty-five or five years of vesting service. The amount of a retiree's benefit is limited to the individual's account balance, which is composed of the participant's contributions to the Plan, employer contributions, and allocated income of the Plan. The Plan also provided for complete distribution of the participant's account balance to the participant or designated beneficiary upon disability or death. On termination of service due to separation, retirement, death, or disability, a participant may elect to receive a lump-sum amount equal to the value of his or her account or receive installment payments if the account balance exceeds \$5,000. If the participant's account balance was less than \$5,000 but greater than \$1,000, participant would receive information to rollover account to an individual retirement account (IRA). If the balance is less than \$1,000, the participant would automatically receive a lump-sum payment.

Forfeitures

Forfeitures were created when participants terminated employment before becoming entitled to their full benefits under the Plan. These forfeited amounts were invested in the stable value fund until utilized to pay Plan expenses or offset employer contributions. There were no accumulated forfeited nonvested accounts at June 30, 2023, and December 31, 2022.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the Plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Plan Amendments

The Plan was amended effective, February 28, 2023, to terminate the Plan and stop salary deferrals. At this time, all participant accounts became 100% vested and participants were required to select their desired account distribution method.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Plan Termination

During the 2023 Plan year, the Company and Plan Sponsor was sold to a third party. The management of the Plan approved a plan of liquidation on December 5, 2022, and management determined liquidation is imminent. Final distributions were determined based on all participants being 100% vested, and were made as soon as possible after the termination date. As part of this sale, the Company terminated substantially all employees in March of 2023, with no additional contributions into the Plan effective February 28, 2023. As included in Note 3, all contributions were accrued for pay periods prior to February 28, 2023. The Plan was terminated effective February 28, 2023, and all Plan assets were distributed by June 30, 2023.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Due to the sale of the Company and the effective termination of the Plan during the Plan year as described in Note 1 to the financial statements, the financial statements have been prepared using the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

The financial statements have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

USA Healthcare, Inc. 401(k) Plan Notes to Financial Statements

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements and NAV.

The Plan's management and third party administrator determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability and are included in benefits paid to participants. The Plan distributed the December 31, 2022 excess contributions in the amount of \$21,662 to the applicable participants prior to March 15, 2023.

Payments of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances.

Risk and Uncertainties

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that these changes could materially affect the amounts reported in the Plan's financial statements.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Subsequent Events

Management has evaluated subsequent events through September 5, 2023, the date the financial statements were available to be issued, and determined there were no events that occurred that required disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

NOTE 3: PLAN TERMINATION

As described in Note 1, the decision to terminate the Plan was made on December 5, 2022, due to the sale of the Plan Sponsor. Contributions were made to the Plan after this date, accrued as discussed below, and all participants were made 100% vested in Plan benefits due to the termination. In accordance with U.S. GAAP, the Plan has changed its basis of accounting used from the ongoing basis of accounting to the liquidation basis of accounting as of and for the year ended December 31, 2022 and as of and for the period ended June 30, 2023.

As of December 31, 2022, the Plan accrued for expected costs and losses related to the termination of the Plan. Based on actual results, the Plan accrued \$71,865 in additional contributions, \$13,304 in interest and dividends, \$91,341 of investment gains and \$19,454 of expected expenses for the year ended December 31, 2022. There were no revisions to these amounts as of and for the period ended June 30, 2023.

All benefits were paid out to participants prior to June 30, 2023.

NOTE 4: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified to be complete and accurate by the qualified institution:

- a) Total investments, at fair value, included in the Statement of Net Assets Available for Benefits in Liquidation as of June 30, 2023 and December 31, 2022.
- b) All amounts included in Note 5, *Fair Value measurements*.

NOTE 5: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and December 31, 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund: The stable value fund is a form of common collective trust funds, which is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value ("NAV") of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The stable value fund generally permits redemptions daily. If the fund experiences periods of insufficient liquidity then the stable value fund may defer honoring any payment request until liquidity is sufficient. The Plan is permitted to redeem investment units at NAV daily.

Assets measured at NAV as a practical expedient are exempt from classification within the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

NOTE 6: TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

For the period ended June 30, 2023, and December 31, 2022, Mid Atlantic Trust Company served as the custodian for the Plan. The custodian of the Plan provided asset pricing and processes trades in accordance with instructions from Plan management or AT Retirement Services, LLC. Investments of the Plan were invested in mutual funds and a stable value fund at the custodian. AT Retirement Services, LLC was the third party administrator for the Plan for period ended June 30, 2023, and for the year ended December 31, 2022.

The Plan paid certain expenses related to Plan operations and investment activity to various service providers, as described in Note 1 and 2. These transactions qualify as party-in-interest transactions under ERISA.
