## **Independent Auditors' Report**

### **To the Plan Administrator and Trustees of the New York Flower LLC 401(k) Plan**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of New York Flower, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

**Note 1      Description of Plan**

The following description of New York Flower LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. See Note 9.

**General**

The Plan is a participant-directed defined contribution plan under the provision of Section 401(k) of the Internal Revenue Code covering the eligible employees of 5<sup>th</sup> Avenue LLC, Allen Street Hospitality LLC, Brook LLC, Connecticut Properties LLC, ELK 123 Bonck LLC, ELK 220 East 23<sup>rd</sup> LLC, ELK 300 Bleeker LLC, ELK 33 East 33<sup>rd</sup> LLC, ELK 577 Second LLC, ELK Colonial Hill LLC, ELK Fairway LLC, ELK Flower Gardens LLC, ELK Harbor View LLC, ELK La Triumphe LLC, ELK Mas 229 East 53<sup>rd</sup> LLC, ELK North Hill LLC, ELK Southwinds LLC, ELK Thamesview LLC, ELK The Terraces LLC, East 37<sup>th</sup> St LLC, Mossanen Group LLC, Normandy Heights LLC, Orchard Street Hospitality LLC, Roslyn LLC and Sandy Brook LLC (collectively, the "Company" or "Plan Sponsors"). The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA"), as amended. Effective January 23, 2020, a new volume submitter plan document was adopted and became effective. Certain employees of the Company are eligible to participate upon one month of employment, provided they are at least twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

**Plan Contributions**

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Eligible employees can contribute up to 100% of their eligible compensation as defined by the Plan, subject to certain limitations under the IRC. Eligible employees are permitted to make both pre-tax and after-tax (ROTH) contributions provided the total of such elective contributions does not exceed the limits stated in the Plan. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may also contribute additional amounts as an employer matching contribution at the discretion of the Company's board of directors. Employer contributions totaled \$37,357 in 2022. Participants direct the investment of their contributions as well as Company contributions, if any, into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of the Company's matching contribution, and an allocation of the Plan's earnings and charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balance, as provided in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Note 1 Description of Plan (Continued)**

**Vesting**

Participants are fully vested in their contributions and rollover amounts, plus earnings thereon. Vesting in employer matching and profit sharing contributions and the earnings thereon is based on years of continuous service. A participant vests according to the following schedule:

**Participant Notes Receivable**

A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the vested account balance. The maximum loan term is five years unless the loan is taken to purchase a principal residence. Notes are secured by the balance in the participant's account and bear interest at a rate of prime plus one percent, determined as of the date of the loan origination. Interest rates on the notes receivable ranged from 3.25%-5.50% during the year ended December 31, 2022. Notes are repaid through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Hardship Benefits**

The Plan allows for "hardship withdrawals" of employee benefits from participant's pre-tax elective deferral and ROTH elective deferral accounts based the provisions of the Plan document.

**Forfeitures**

At December 31, 2022 and 2021 forfeited non-vested accounts totaled \$2,434 and \$1,673, respectively. These accounts will be available to reduce future employer matching contributions. Forfeitures used to reduce employer matching contributions during the years ended December 31, 2022 and 2021 totaled \$1,597 and \$1,111, respectively.

**Note 2      Summary of Significant Accounting Policies**

**Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company (See Note 3).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

Management has evaluated subsequent events and transactions for potential recognition or disclosure through the date of the auditors' report, which is the date the financial statements were available to be issued. See Note 9.

**Note 3 Fair Value Measurements**

Generally accepted accounting principles ("GAAP") establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The Plan did not hold any level 2 or level 3 investments at December 31, 2022 and 2021.

Level 1 investments in the fair value hierarchy under GAAP are described below:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 4      Related Party and Party-In-Interest Transactions**

Certain Plan investments are shares in mutual funds, managed by Fidelity Investments Institutional Operations Company, Inc., a subsidiary of Fidelity Management Trust Company ("Fidelity"). Therefore, these transactions qualify as party-in-interest transactions. Fees paid to Fidelity by the Plan for administrative services were \$4,882, for the year ended December 31, 2022.

Certain expenses of the Plan are paid directly by the Plan Sponsor and are therefore not included in the accompanying financial statements. Alternatively, investment fund operating expenses are deducted from the fund's assets and are reflected in share/unit prices.

**Note 5      Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, participants will become fully vested, and net assets will be distributed to participants and beneficiaries in proportion to their respective account balances.

**Note 6      Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan will be open for examination for three years.

**Note 7      Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits and participant account balances.

**Note 7 Risk and Uncertainties (Continued)**

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across a variety of participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.
