Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Safe Haven Security 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2022 and 2021

1. DESCRIPTION OF THE PLAN

The following description of the Safe Haven Security 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all eligible employees of Safe Haven Security Services, Inc. (the “Company” or “Plan Sponsor”).

The Plan was established January 1, 2018. Effective January 1, 2022, the Plan was amended and restated to adopt the Third Cycle Restatement to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37. There were no significant changes to the primary provisions of the Plan. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”).

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (collectively “Principal”) serve as the custodians of the Plan. Principal also serves as the Plan’s recordkeeper. An employee serves as the Plan’s trustee.

CARES Act – In March 2020, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was enacted to provide expanded access to retirement plan accounts during the COVID-19 pandemic. The CARES Act contained several provisions that temporarily impacted 401(k) plans, such as, the waiver of required minimum distributions, a new COVID-19-related hardship withdrawal option, increased loan limits, and a loan repayment deferral option. The Company incorporated these provisions into the Plan. These temporary CARES Act provisions expired at the end of 2020. The Plan is in the process of being amended to reflect these changes.

Eligibility – Employees who are at least 21 years of age and have worked for six months may enter the Plan on the first day of month after meeting the eligibility requirements. The Plan excludes union employees, leased employees, employed students and non-resident aliens.

Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan Document, as a pretax contribution, subject to certain Internal Revenue Code (“IRC”) limitations. Participants may also elect to make Roth contributions. In addition, participants meeting certain age requirements may also make catch-up contributions. Employees are automatically enrolled at 3% unless they elect otherwise in writing. In addition, employees subject to automatic enrollment provisions will have their deferral increased by 1% annually starting after the second Plan year, to a maximum of 12%.

The Company may make a matching contribution equal to a discretionary percentage of the participant’s salary deferral. For 2022, the Company did not declare a matching contribution.

Participant Accounts – Each participant’s account is credited with the participant’s and the Company’s contributions, if any, an allocation of the investments’ earnings/(losses), and is charged with the participant’s withdrawals and distributions, and Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants direct their investments into a variety of mutual funds, pooled separate accounts, or a guaranteed investment contract.

Vesting – Participants' contributions are fully vested at all times. The Employer matching contributions vest in 25% increments, with 25% vesting after 1 year of service, 50% vesting after 2 years of service, and so forth. Employer matching contributions are fully vested after 4 years of service. Employer contributions also become fully vested in the event of death or disability of the participant.

Forfeitures – Forfeited balances of terminated participants' non-vested accounts may be used to reduce future employer discretionary contributions, or may be re-allocated to participants' accounts. There were no forfeitures in 2022.

Payment of Benefits – Upon termination of service, the participant, or in the case of death, the participant's beneficiary, may elect to receive the vested value of the participant's account in a lump-sum. If the vested portion of the account balance is less than \$5,000, the participant's vested account balance will be automatically distributed if the participant does not elect to roll-over the balance to another qualified plan. Balances between \$1,000 and \$5,000 will be automatically rolled over to an IRA account.

Notes Receivable from Participant's – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans may be made from the participant's vested account balance. The maximum loan term is 5 years, unless the loan is for the purchase of the participant's principal residence in which case the maximum term is 30 years. The loans are secured by the balance in the participant's account, and bear a reasonable interest, which is currently the Prime rate plus 2%. A participant may have one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions, and must be made at least quarterly.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants for purposes as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance that is 100% vested.

Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of the vested account balance in a single lump sum payment. Roth contributions, if withdrawn prior to 5 years after the first Roth contribution is made, will lose their qualified status and the earnings become taxable.

Administrative Expenses – Administrative expenses are paid by the Plan or the Company, as defined in the Plan. During 2022, the Plan paid administrative expenses of \$53,128 for recordkeeping, custodial and investment management services.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan is terminated, participants' accounts would become fully vested at that time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in mutual funds and pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction on investment return for such investments.

Contributions – Contributions are recorded in the year that services are rendered.

Payment of Benefits – Benefit payments are reported in the year of payment.

Excess Refundable Contributions – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Date of Management's Review – Subsequent events have been evaluated through August 9, 2023, which is the date the financial statements were available to be issued, and there were no material events requiring additional recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021:

Mutual Funds – Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled Separate Accounts – Principal calculates a unit value (similar to a net asset value “NAV”) of a separate account. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any. The NAV is available to current investors via the Principal employer website, or when Plan participants access their account values. The NAV is the basis for current transactions and these investments can be redeemed at NAV as of the measurement date. Therefore, management believes that these investments have a readily determinable fair value. The majority of the underlying securities held in these investments have observable Level 1 inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides the Principal Fixed Income Guaranteed Option, a fully benefit-responsive group annuity contract with a fixed rate of interest issued by Principal Life Insurance Company as an investment option for participants. The objective of this investment option is to guarantee principal and provide a stated interest crediting rate backed by Principal Life Insurance Company. The contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Under the existing contract, the net crediting rate on participant accounts was 1.75% and 1.55% at December 31, 2022 and 2021, respectively. The rates reset semi-annually, on June 1 and December 1. The investment contract has a 5% early withdrawal charge should the Plan discontinue the contract without proper notifications, as prescribed in the contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events that may limit the ability of the Plan to transact at contract value are not probable of occurring.

On May 3, 2022, the Plan sponsor provided notice to Principal of the intent to terminate the Fixed Income Guaranteed Option group annuity contract. Liquidation will occur on May 3, 2023, which allows the Plan to avoid the 5% early surrender charge.

6. INFORMATION CERTIFIED BY CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2022 and 2021, and for the year ended December 31, 2022:

- Investments, at fair value
- Net depreciation in fair value of investments
- Interest and dividend income
- Notes receivable from participants, and related interest
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. TAX STATUS

The Company adopted a Prototype Non-standardized Pre-Approved Profit Sharing Plan with cash or deferral arrangement which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2022. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are a pooled separate account, and a guaranteed interest contract managed by Principal. Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. The Plan pays certain fees to Principal to administer the Plan. These transactions qualify as party-in-interest. Notes receivable to participants are party-in-interest transactions.

9. PROHIBITED TRANSACTIONS

During the year ended December 31, 2022, employee deferrals of \$810 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust, and will file and pay the appropriate excise tax, and contribute lost earnings to the affected participants. These transactions are prohibited according to the provisions of the DOL.

During the year ended December 31, 2021, employee deferrals of \$112,086 and loan payments of \$1,743 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust, and has filed and paid the appropriate excise tax, and contributed lost earnings to the affected participants. These transactions are prohibited according to the provisions of the DOL.
