### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Marrinson Group 401(k) Profit Sharing Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 24, 2023 (in liquidation) and June 30, 2022 (ongoing), the related statement of changes in net assets available for benefits for the period from July 1, 2022 to April 24, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of April 24, 2023 and June 30, 2022 and for the period from July 1, 2022 to April 24, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter—Plan Termination and Liquidation Basis**

As discussed in Note 8 to the financial statements, the Board of Directors of the Company voted on December 31, 2022, to terminate the Plan effective the same date, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description

The following description of The Marrinson Group 401(k) Profit Sharing Retirement Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all full-time employees of Marrinson Group, Inc., Manor Pines Convalescent Center, LLC, 1601 Management, LLC, Manor Oaks, Inc. and Margate Manor, Inc. (collectively, the Company, Employer or Sponsor) who are not subject to a collective bargaining agreement, have completed at least one hour of service within the first 90 days of service and are age 21 or older. The Plan provides for contributions made under salary deferral agreements pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance. Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively Empower) serve as the trustees of the Plan.

**Plan termination:** Effective December 31, 2022, the Plan was terminated. See Note 8 for further information.

**Contributions:** Participants may make salary deferral contributions in any percentage from 1%-100% of gross wages up to limits according to the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company matches 100% of the amount deferred by each participant, up to 3% of each participant's eligible compensation for each pay period, as defined by the Plan document. In addition, the Company may make discretionary contributions to the Plan. There were no discretionary contributions made during the period from July 1, 2022 to April 24, 2023. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions and allocations of the Company's matching contribution, discretionary contribution, if any, and Plan earnings, and charged with allocations of investment losses and administrative fees paid by the Plan. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments:** Participants may direct the investment of their account balances in any of the funds offered by the Plan. Participants may change their investment options daily.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Company contributions vest on the basis of years of credited service. A participant must work a minimum of 1,000 hours to earn a year of credited service. A participant is 20% vested after two years of credited service and becomes 100% vested after six years, based on a six-year graded vesting schedule as defined by the Plan. Regardless of years of service, participants are 100% vested upon reaching retirement, becoming disabled or upon death. The nonvested portion of a participant's account is forfeited upon the earlier of the distribution of the participant's vested account balance or after the participant incurs five consecutive breaks in service. As a result of the Plan termination, participants became 100% vested in their matching and discretionary contribution balances effective December 31, 2022.

#### Note 1. Plan Description (Continued)

**Payment of benefits:** On termination of service for any reason, a participant may elect to receive a lump-sum amount equal to all or some of the value of the participant's vested interest in his or her account. If the vested balance in a participant's account is less than or equal to \$1,000, the Plan may distribute the entire vested balance in a single lump-sum payment without the election of the participant. In service withdrawals are permitted after a participant reaches normal retirement age.

In connection with the Plan termination, participants were requested to take a total distribution. Participants were able to elect a cash out or a rollover to an eligible retirement Plan or Individual Retirement Account (IRA). For participants that did not make an election by March 31, 2023, any account balances remaining were rolled into an IRA.

**Forfeited accounts:** Amounts forfeited by terminated participants are used to offset future Company contributions. Forfeited nonvested accounts totaled \$0 and \$2 at April 24, 2023 and June 30, 2022, respectively. During the year ended June 30, 2023, Company contributions were reduced by \$5,026 from forfeited nonvested accounts.

**Notes receivable from participants:** Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or up to a term determined by the Plan Administrator for the purchase of a primary residence. The notes are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through regular payroll deductions. Outstanding notes receivable balances were netted against participant account balances in distributions taken as a result of the Plan termination.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** Due to the decision to terminate the Plan effective December 31, 2022, management determined that liquidation of the Plan is imminent and the financial statements for the period from July 1, 2022 to April 24, 2023 have been prepared using the liquidation basis of accounting. The financial statements for the year ended June 30, 2022 were prepared as a going concern on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments at June 30, 2022, are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There were no investments remaining in the Plan as of April 24, 2023. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully-benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a settlement date basis. Interest income and dividends are recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement. No allowance for credit losses has been recorded as of April 24, 2023 and June 30, 2022.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent events:** The Plan Administrator has evaluated subsequent events (events occurring after April 24, 2023) through September 11, 2023, the date the financial statements were available to be issued.

#### Note 3. Investment Information Certified and Provided by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (Trustees)

The following is a summary of the asset information as of April 24, 2023 and June 30, 2022, and for the period from July 1, 2022 to April 24, 2023, included throughout the Plan's financial statements, obtained by management and agreed to or derived from information certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustees of the Plan. The Plan Administrator has obtained certifications from the trustees that information provided to the Plan Administrator by the trustees related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements related to the following assets:

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at April 24, 2023 and June 30, 2022.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### **Note 5. Fully Benefit-Responsive Investment Contract**

Effective April 16, 2021, the Sponsor, on behalf of the Plan, entered into a group unallocated fixed deferred annuity contract (contract) with Empower Trust (formerly, Great-West Trust). The contract is a traditional, fully benefit-responsive investment contract that is reported at contract value. Empower maintains the contributions in a general account. The account is credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0.1%. Such interest rates are reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The contract was redeemed in 2023 and an early withdrawal penalty was not applicable.

#### **Note 6. Tax Status**

Effective February 12, 2021, the Plan adopted a non-standardized form of a pre-approved plan sponsored by Empower (formerly, Great-West). The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan was designed and operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7. Related Party and Party-in-Interest Transactions**

Empower is the recordkeeper of the Plan and Resource Investment Advisors, LLC (RIA) and Raymond James & Associates, Inc. (Raymond James) are the investment advisors to the Plan. Therefore, transactions with Empower, RIA and Raymond James qualify as party-in-interest transactions. Fees paid by the Plan to Empower, RIA and Raymond James totaled \$64,914, \$4,038 and \$15,139, respectively, for the period from July 1, 2022 to April 24, 2023. The Sponsor also paid certain administrative expenses of the Plan.

#### **Note 8. Plan Termination**

The Company was acquired on December 29, 2022. The Board of Directors of the Company voted on December 31, 2022, to terminate the Plan effective the same date. After that date, no further contributions were made to the Plan. Participants became 100% vested in their employer contributions. All of the Plan assets were distributed, as elected by each participant, by April 24, 2023.
