### **Independent Auditor's Report**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of OSW Equipment and Repair, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of May 31, 2022 (date of merger) and the related statement of changes in net assets available for benefits for the five months then ended, and the statement of net assets available for benefits as of December 31, 2021 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of OSW Equipment and Repair, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2022 and December 31, 2021, and for the five months ended May 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

As discussed in Note 1 to the financial statements, the governing body of OSW Equipment and Repair, LLC 401(k) Plan approved a plan of merger effective May 31, 2022, and the Plan was terminated as of May 31, 2022. Our opinion is not modified with respect to that matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 - ORGANIZATION AND DESCRIPTION OF THE PLAN**

The following description of the OSW Equipment and Repair, LLC 401(k) Plan (OSW Plan or the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Effective January 1, 1994, Northend Truck Equipment Inc. ("NTE") adopted the Northend Truck Equipment Employee Retirement Plan (the Plan) which covered only NTE employees. OSW Equipment and Repair, LLC ("OSW") became the Sponsor in 2020 and OSW employees became eligible. The Plan has been amended and restated to comply with current legislation, with the last such amendment effective August 1, 2020. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**Plan of Merger** - On February 17, 2021, Federal Signal Corporation ("FSC") acquired the Company. On January 1, 2022, OSW and NTE employees became eligible for FSC's 401k Plan and contributions to the Plan ceased (except for loan repayments). On May 31, 2022, all Plan assets were transferred/merged into FSC's plan; participants became fully vested in their accounts and the Plan terminated. The financial statements have been prepared on the ongoing basis of accounting because plan obligations were not settled with participants, but rather the Plan's assets and liabilities were transferred to another plan.

**General** - The Plan is a defined contribution plan covering the employees of OSW and its affiliate NTE (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration** - The Plan is sponsored by the Company and administered by the Company's Finance Officer with guidance by Automatic Data Processing (ADP, the payroll provider and 401k recordkeeper).

The following plan provisions were in effect prior to the Plan merger.

**Contributions** - Participants may elect to contribute a minimum of 1% and maximum of 90% of their eligible compensation, with the Plan through salary deferrals. Participants have the option to contribute pre-tax contributions, Roth 401 (k) contributions or a combination of both. Employee deferrals are paid to the Plan with each pay period. Participants may also contribute amounts representing distributions from other qualified Plans upon employment with the Company and if the participant is at least age 50 catchup contributions may be made.

The employer matching formula is a flexible discretionary amount based upon a discretionary percentage of the participant's elective deferrals or compensation. The employer match for the year 2021 was equivalent to 50% of total deferrals up to 3% of the compensation of an eligible participant and there were no nonelective contributions in 2021. The Company may also make a discretionary matching contribution and/or nonelective contributions (including profit sharing contributions).

**Note 1 – continued:**

**Eligibility** - Employees are eligible to participate in the Plan after reaching 18 years of age and after completion of one year of eligible service. The entry date is the first day of the month after a 12 consecutive month period in which they complete 1,000 hours of service.

Compensation for the first year of eligible Plan participation is based upon eligible compensation for the portion of the year in which the employee is eligible to participate. For such employees, compensation for the purpose of matching contributions and non-elective contributions shall be determined as of the first day of the Plan year.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Each participant whose employment terminates for reasons other than death, disability, or attainment of normal retirement age, is entitled to a nonforfeitable right to his employer contribution as follows:

Notwithstanding the aforementioned, upon reaching normal retirement age or upon death or disability, participants become 100% vested.

**Participant Accounts** - Individual participant accounts are maintained by ADP Retirement Services. Each participant's account is credited or charged with the participant's contributions and allocations of employer matching and nonelective contributions and investment earnings and losses. Allocations are based on participant compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the vested balance in the participant's account.

**Investment Options** - The Plan's assets are held by Reliance Trust Company. Participants direct employee and employer contributions and account balances among various investment options comprised of mutual funds and a stable value fund.

**Notes Receivable from Participants** - Participants may borrow from their vested contributions a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loans are required to be repaid within five years, with the exception that a loan which is used to acquire a principal residence may be repaid within thirty years. The loans are secured by the balance in the participant's account and bear interest at a rate of prime in effect at the loan's inception plus two percent. Principal and interest are paid ratably through payroll deductions. Upon distribution of a participant's balance before a loan is repaid in full, the unpaid loan balance, together with the loan interest, shall become due and payable, and the trustee will

first satisfy the indebtedness of the participant's account before making any distribution to the participant. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan.

***Payment of Benefits*** - Participants are entitled to receive a distribution of their vested accounts upon the occurrence of retirement, death, total and permanent disability, financial hardship (as defined by the Plan), after attaining age 59 ½ while still employed, or termination of employment for any other reason. The methods of distribution include lump-sum distribution, substantially equal installments, or partial withdrawals, provided the minimum withdrawal is \$500. Participants who terminate employment are cashed out if their Plan balance vested is \$5,000 or less.

***Expenses*** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

***Forfeitures*** - Forfeited nonvested accounts may be used to pay Plan administrative expenses or reduce employer contributions. During the five-month period ended May 31, 2022, employer contributions were reduced by \$4,385 from forfeited nonvested accounts. At May 31, 2022 and December 31, 2021, the balance of forfeited nonvested accounts was \$0 and \$4,211, respectively.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies used by the Plan:

***Basis of Accounting*** - The financial statements of the Plan are prepared using the accrual method of accounting and on the ongoing basis.

***Investments*** - Plan investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee.

***Income Recognition*** - Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments represents the net decrease in the fair value of investments sold during the year or held at year-end over (1) the fair value of investments held at the prior year-end, which approximates liquidation basis, or (2) the cost of investments acquired during the current year.

**Note 2 – continued:**

Certain administrative costs of the Plan are borne by the Company. In addition, the Company may provide services to the Plan for which the Company receives no compensation. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on an accrual basis. No allowance for credit losses was recorded as of May 31, 2022 and December 31, 2021.

*Payment of Benefits* - Benefits are recorded when paid.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:**

The Plan's management elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, certain information certified by a qualified trustee or custodian need not be subject to independent audit.

Plan's management has obtained certification from the custodian that the following information included in the Plan's financial statements and supplemental schedule is complete and accurate:

1. Fair value and contract value of investments as of December 31, 2021,
2. The balance of notes receivable from participants as of December 31, 2021,
3. Investment income earned for the period from January 1, 2022 through May 31, 2022,
4. Investment transactions for the period from January 1, 2022 through May 31, 2022.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability. There are three levels, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

**Note 4 – continued:**

- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

*Mutual funds:* Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within level 1 of the valuation hierarchy.

**NOTE 5 - STABLE VALUE FUND**

The Plan invests in Invesco Stable Asset Fund – ADPZ Class Stable Value through a separate account, the Stable Value Fund. The Stable Value Fund’s primary investment objectives of the Fund are to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain daily liquidity at contract value for Participant withdrawals and transfers. To accomplish these objectives, the Stable Value Fund invests primarily in investment contracts also known as synthetic GICs. In a synthetic GIC, the underlying investments are owned by the Stable Value Fund.

Invesco Stable Asset Fund – ADPZ Class Stable Value (Invesco SAF) is a traditional, fully benefit-responsive guaranteed investment contract, which is recorded at contract value. Contract value

represents contributions made under the fund, plus earnings, less withdrawals and administrative expenses. The contract crediting rate is established at the end of each quarter and is guaranteed for

the subsequent quarter, with a minimum crediting rate of 1%. There are no reserves against contract value for the credit risk of the Invesco SAF issuer or otherwise.

The underlying investments of the Invesco SAF’s synthetic GICs primarily consist of collective trust funds of the Invesco Group Trust for Retirement Savings, a collective trust managed by Invesco Trust Company. These funds invest in fixed income securities of the highest credit quality, generally AAA.

**NOTE 6 - FEDERAL INCOME TAXES:**

The Plan operates under provisions of a prototype plan which received an opinion letter from the Internal Revenue Service (IRS), dated October 6, 2020, which stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Administrator believes that the Plan and related trust are designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Generally accepted accounting principles (GAAP) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has concluded that as of May 31, 2022, the Plan has not taken any uncertain tax positions that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress and tax years prior to 2019 are no longer subject to audit.

Therefore, no provision for income taxes has been included in the Plan’s financial statements.
