NOTE A - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Texas MedClinic 401(k) Profit Sharing Plan (“Plan”) are prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

Recognition of Income: The basis of investments held by the Plan is adjusted annually to closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using this adjusted basis. Security transaction expenses are considered in computing realized gains and losses on investments.

Investment Valuation and Income Recognition: Investments in mutual funds (registered investment companies) are carried at fair market value (net asset value), as determined by quoted prices in an active market. Dividends are considered in the fair market value determination. Gains and losses (realized and unrealized) included in changes in net assets are reported in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits.

Investments in guaranteed interest contracts are carried at contract value. The contracts are fully benefit-responsive.

Benefit Payments: Benefits are recorded when paid.

Concentration of Credit Risks: Concentration of credit risk with respect to mutual funds is reduced as a result of the diversity of the underlying investments.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor’s report.

Use of Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B – PLAN MERGER

The Plan Sponsor was purchased in August 2022 and the trustee responsibility was transferred to the purchaser. On December 30, 2022, the Plan’s mutual fund assets were transferred to the purchaser’s plan. The guaranteed interest contracts will be retained by the Plan until the notification period is met, at which time they will be transferred to the purchaser. See Note H.

For the year ended December 31, 2022, the Plan Sponsor identified that deferrals were not withheld on participant bonuses. Management is currently calculating the difference and plans to make QNEC and QMAC contributions into the merged plan for these participants. Management estimates this amount to be approximately \$42,000 and it has not been accrued in these financial statements.

NOTE C - DESCRIPTION OF THE PLAN

The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Texas MedClinic 401(k) Profit Sharing Plan is a defined contribution plan, established January 1, 1999, covering virtually all employees of TMC Medical Management, Ltd. and TMC Provider Group, LLC (the Plan Sponsor) who are age twenty-one or older, have six consecutive months of service and have worked at least 83 hours each month. Employees who do not meet the eligibility requirement in the first consecutive period of months revert to 1,000 hours of service. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated effective January 1, 2022. The Plan restatement incorporated the Plan amendments made prior to the restatement, and the hardship distributions would no longer have a suspension of contributions for six months.

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any participant who is not 100% vested will, by law, become 100% vested in their accounts.

Contributions: Each year participants may elect to contribute pretax compensation, as well as post-tax (Roth) compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan sponsor contributes 100% of the first 3% and 50% of the remaining up to 5% of compensation that a participant contributes to the Plan in accordance with its safe harbor provision. Additional profit sharing amounts may be contributed at the option of the Plan sponsor's Board of Trustees. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of the Plan sponsor's contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are 100% vested at all times in their voluntary contributions, employer safe harbor contributions, and actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service (20% per year starting in year two).

Forfeitures: Unallocated forfeitures totaled \$0 at December 31, 2022 and \$5,641 at December 31, 2021. The Plan allows available forfeiture balances to reduce future employer contributions and pay the expenses of the Plan.

Payment of Benefits: On termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Any balance under \$5,000 is automatically paid out as soon as administratively possible. Hardship withdrawals are also available subject to certain limitations.

Administrative Expenses: Administrative expenses are paid either by the Plan or the Plan Sponsor as allowed in the Plan document.

NOTE D – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor 29 CFR 2520.103-8, Plan investments at December 31, 2022 and 2021 and the related investment earnings in 2022 and 2021 were certified and held by Reliance Trust Company, the Custodian, and were not audited by the independent auditor.

NOTE E – TRANSACTIONS WITH PARTIES IN INTEREST

The Plan includes certain investments managed by Mass Mutual Life Insurance Company, the Plan's Contract Administrator. Therefore, these transactions qualify as party-in-interest transactions. Fees paid for legal, accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed for in the Plan document. Fees paid by the Plan for administrative expenses totaled \$95,489 in 2022 and \$96,167 in 2021.

NOTE F - INCOME TAX STATUS

The Plan has received a favorable determination that it qualifies under applicable sections of the Internal Revenue Code. The Plan has not been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal returns for the last four years remain subject to examination.

NOTE G - FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used to determine fair value, nor transfers between levels. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the net asset value (NAV).

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE H – GUARANTEED INTEREST CONTRACT

The Plan has a benefit-responsive guaranteed interest contract, MassMutual SF Guaranteed, with a balance of \$345,327 at December 31, 2022 and \$342,081 at December 31, 2021. Mass Mutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, it is stated at contract value, the amount the participant would receive if they were to initiate permitted transactions under the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business. Such events also include: (1) removal from the plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) plan disqualification. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE I – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – SUBSEQUENT EVENTS

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later.
