## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements**

We have performed an audit of the financial statements of Medbio Parent, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes (collectively referred to as the “financial statements”).

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



## **Other Matter**

### *Report of Other Auditors on 2021 Financial Statements*

Another auditor performed an audit on the financial statements of the Plan as of and for the year ended December 31, 2021. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, their audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. In their report dated November 30, 2022, they indicated that in their opinion (a) the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the financial statements related to assets held by and certified to by a qualified institution agreed to, or was derived from, in all material respects, the information prepared and certified by an institution that management determined met the requirements of ERISA Section 103(a)(3)(C).

## Notes to the Financial Statements

December 31, 2022

### **1. Description of Plan**

The following description of Medbio Parent, LLC Plan (the Plan) provides only general information. The Plan sponsor is Medbio Parent, LLC (the Company). Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Company.

#### **General**

The Plan is a defined contribution plan, which covers substantially all of the employees of the Company who have completed 2 months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

On November 18, 2021, Protective Industries, Inc. acquired the Company. In connection with this acquisition, the Plan was merged into the Protective Industries Savings & Retirement Plan (Protective Plan) effective January 1, 2023. As a result of the merger, the Plan's investments were liquidated on December 30, 2022 and net assets of \$23,822,196 were transferred to the trustee of the Protective Plan on January 3, 2023.

#### **Contributions**

Each year, participants may contribute a combination of pretax and after-tax (Roth) contributions up to the Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution equal to 100% of the first 3% of the participant's eligible compensation, plus 50% of the next 2% of the participant's eligible compensation. Additional profit sharing amounts may be contributed at the discretion of the Company. There were no profit sharing contributions in the current Plan year.

All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Participants direct their elective and Company contributions into various investment options offered by the Plan and can change their investment options on a daily basis.

### Notes to the Financial Statements (continued)

#### 1. Description of Plan (continued)

##### Participant Accounts

Each participant's account is credited with the participant's contribution and the Company contributions and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting and forfeitures

All participants are immediately 100% vested in employee contributions and safe harbor Company matching contributions, plus actual earnings thereon. Profit sharing contributions are subject to the following vesting schedule:

Participants who terminate their employment and are less than 100% vested in their profit sharing contributions forfeit the non-vested portion. Forfeitures are used to pay Plan expenses or reduce Company contributions.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the participant's highest outstanding note receivable amount during the prior 12 months or 50% of their vested account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear a reasonable interest rate as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

### Notes to the Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Payment of Benefits**

Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in her or her account. Benefit amounts under \$5,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum.

In-service withdrawals are available in certain circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the IRS.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Payment of Benefits**

Benefits are recorded when paid.

#### **2. Summary of Significant Accounting Policies**

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit date). See Note 4, disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses on investments purchased and sold as well as held during the year are included in net depreciation in fair value of investments in the statement of changes in net assets available for benefits.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **Administrative Expenses**

All expenses of maintaining the Plan are paid by the Company or by the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### **3. Investments**

All investment information disclosed in the accompanying financial statements including investments held and notes receivable from participants at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividend income for the year ended December 31, 2022, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company.

#### 4. Fair Value Measurements

The FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### 4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2021. The Plan did not hold any investments as of December 31, 2022.

##### *Mutual Funds*

The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges.

##### *Money Market Deposit Account*

The fair value is based upon the liquidity of the account and the credit quality of the issuer.

#### 5. Party-in-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Transactions during the year with parties-in-interest include administrative and recordkeeping services. The Company directly pays any other fees related to the Plan's operations.

#### 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 7. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there were no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
