Nolan Transportation Group (“NTG”), the Plan Administrator of the Nolan Transportation Group 401(k) Plan (the “Nolan Plan”), is responding the Notice of Rejection of the Form 5500 Annual Report of Nolan Transportation Group 401(k) Plan, regarding the 2022 Form 5500.

The Nolan Plan was merged into the Transportation Insight Retirement Plan (the “Transportation Insight Plan”) effective January 1, 2022, pursuant to an amendment and restatement of the Transportation Insight Plan, which set forth the merger effective date. The Nolan Plan assets were transferred from Vanguard to the Transportation Insight Plan at Principal on January 14, 2022, after the final 2021 employer and employee contributions were received and reconciled with individual accounts.

In reviewing this matter, NTG has determined that some of its service providers misunderstood that the merger was effective January 1, 2022, and that some filing errors occurred as a result. The 2021 Form 5500 for the Nolan Plan should have included a reconciliation to Form 5500 footnote zeroing out the plan and should have been marked “final.” No 2022 Form 5500 should have been filed for the 2022 plan year, because there was no such plan year.

The 2022 Form 5500 is marked amended and final, with zero assets and zero participants as of the first day and last day of the year.
