## ***INDEPENDENT AUDITOR'S REPORT***

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Therm-All Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation as of November 15, 2022, and the related statement of changes in net assets in liquidation for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Therm-All Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter***

As discussed in Note 5 to the financial statements, the stockholders of Therm-All, Inc. approved a plan of liquidation on March 25, 2022, and the Company determined liquidation is imminent. As a result, the Company changed its basis of accounting on March 25, 2022 from the ongoing basis to the liquidation basis. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Therm-All Profit Sharing Plan's ability to continue as a going concern.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to

issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Therm-All Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Therm-All Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Therm-All Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** – The Plan was a defined contribution plan covering all full-time employees of Therm-All, Inc., PDL Building Products, Ltd., LNM Transportation, Inc., Syndicated Building Components, Inc., and Retro Design Contracting, Inc. (together, the Company) who had completed at least three months of continuous employment. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. **Contributions** – Each year, participants were able to contribute eligible earnings as defined in the Plan up to the maximum amount allowable under the law. Participants were also able to contribute amounts representing distributions from other qualified defined-benefit or contribution plans and voluntary non-deductible contributions, with the exception of designated Roth contributions. The Company could contribute 50 percent of the first 6 percent of eligible earnings that a participant contributed to the Plan. Additional amounts could have been contributed at the option of the Company's board of directors. Contributions were subject to certain limitations. The Company elected to contribute a discretionary profit sharing contribution of \$147,862 for the year ended December 31, 2021. The Company used \$5,602 and \$51,195, respectively, of forfeitures to fund a portion of the matching contributions during the years ended November 15, 2022 and December 31, 2021. The Company used \$9,157 and \$50,426, respectively, of forfeitures to fund a portion of the prior year profit sharing contribution during the years ended November 15, 2022 and December 31, 2021.

The Plan operated with an automatic enrollment feature. Eligible participants would automatically have three percent of their eligible compensation deferred into the Plan unless they elected otherwise.

3. **Participant accounts** – Each participant's account was credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations were based on participant earnings or account balances, as defined. Loan fees were allocated directly to the borrowing participant's account. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.
4. **Vesting** – Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. A participant was 100 percent vested in his employer contribution account after six years of credited service. Due to the Plan's termination, all participants became fully vested as of March 25, 2022. See Note 5.
5. **Investment options** – Upon enrollment in the Plan, participants were able to direct contributions to their account in one percent increments in any of the available investment options. Participants were able to change their investment options daily.

6. Notes receivable from participants – Participants were able to borrow from their vested account balance a maximum amount equal to the lesser of \$50,000 reduced by the excess of the participant's highest outstanding note balance during the 12 months preceding the date on which the note was made over the outstanding note balance on the date the new note is made, or 50 percent of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates in effect ranged from 4.25% to 6.50%. Principal and interest were paid ratably through payroll deductions. Upon termination of the Plan, all notes receivable from participants were either repaid or deemed to be distributed to the applicable participant.
7. Payment of benefits – On termination of service due to death, disability, or retirement, a participant was able to elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments or a combination of the above. For termination of service due to other reasons, a participant was able to receive the value of the vested interest in his or her account as a lump-sum distribution. During 2022, the Plan was liquidated and all accounts were disbursed or transferred to the respective participants.
8. Forfeited accounts – At December 31, 2021, unallocated forfeited accounts totaled \$12,994. These accounts were used to pay the administrative costs of the plan, to reduce amounts otherwise required to be contributed into the Plan or reallocated to participants' accounts as though they were additional employer contributions. At November 15, 2022, there were no unallocated forfeited accounts.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements of the Plan are prepared under the liquidation method of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation and income recognition**

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

**Investment valuation and income recognition (continued)**

The Plan's investments were stated at fair value, except for fully benefit-responsive investment contracts which were reported at contract value. Contract value was the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies were determined by utilizing information provided by the investment advisers, custodians, and insurance company.

**Notes receivable from participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were recorded as a distribution based upon the terms of the plan document.

**Payment of benefits**

Benefits were recorded when paid.

**Administrative costs**

The Company absorbed significant administrative costs of the Plan. The Plan assessed against an individual participant's account certain Plan expenses that were incurred by, or were attributable to, a particular participant based on use of a particular Plan service.

**Party-in-interest transactions**

Certain Plan assets were investment funds managed and held by Reliance Trust Company and Standard Retirement Services, Inc. Standard Retirement Services, Inc. is the trustee and Reliance Trust Company was the custodian, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE AND CUSTODIAN – UNAUDITED**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 4 – FEDERAL INCOME TAX STATUS**

The form of the Plan has received an advisory letter from the Internal Revenue Service stating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and that any employer adopting the form of this Plan will be considered to have a plan qualified under Section 401 of the IRC. Therefore, the Plan is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 – PLAN TERMINATION**

The Company entered into an agreement providing for the sale of all assets of Therm-All, Inc. effective March 25, 2022. As a result, Therm-All, Inc., the plan sponsor, voted in March 2022 to terminate the Plan. All participants became fully vested in their account balances upon approval of termination and had the option of transferring their account balance to a qualified individual retirement account or receiving a taxable distribution. During 2022, all funds were disbursed or transferred into qualified individual retirement accounts.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks.

**NOTE 7 – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Company had entered into a fully benefit-responsive investment contract with Standard Insurance Company (Standard). Standard maintained the contributions in a stable value account. The account is credited with earnings at the guaranteed crediting rates and charged with participant withdrawals and administrative expenses. The contract was included in the financial statements at contract value. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants were ordinarily able to direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may have limited the ability of the Plan to transact at contract value. Such events included termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawals or transfer rules. The fully benefit-responsive investment contract was affected by the Plan termination. Because the contract was terminated with the Plan termination, the participants invested in this fund were charged a penalty.

**NOTE 8 – FAIR VALUE MEASUREMENTS**

The Fair Value Measurement Topic of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB codification guidance are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 15, 2022.

*Mutual funds* – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts* (not fully benefit-responsive) – valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different instruments could result in a different fair value measurement at the reporting date.
