NOTES TO FINANCIAL STATEMENTS NOVEMBER 7, 2022 AND DECEMBER 31, 2021

1. DESCRIPTION OF PLAN

The following brief description of the Thrift Plan for Employees of The Arc of Monroe County (the Plan) is for general information purposes only. Participants should refer to the Plan document for more information and a complete description of the Plan's provisions.

General

The Plan was a defined contribution 403(b) Tax Sheltered Annuity Plan covering all employees of The Arc of Monroe County (the Arc) who met certain eligibility requirements. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

In July 2020, The Arc New York Board of Governors approved a resolution to create a single retirement plan for all NYSARC Chapters called The Arc New York Affiliated Employers 401(k) Plan (the Affiliated Plan). On May 2, 2022, the Plan Sponsor adopted an amendment to the Plan that merged the Plan into the Affiliated Plan. The plan merger date was August 4, 2022 and all assets of the Plan were transferred to the Affiliated Plan by November 7, 2022.

Administration

The Plan was administered by management who were appointed by authorized officers of The Arc of Monroe County. Management administered the Plan in accordance with its terms and applicable laws and had all necessary and appropriate powers to carry out the provisions of the Plan. Fidelity Investments Institutional Operations Company, Inc. (Fidelity) was the custodian of the Plan's assets. The Newport Group (Newport) was the third-party administrator, which provided recordkeeping services to the Plan.

Eligibility

All employees were eligible to participate in the Plan. Employees were eligible to begin salary deferrals upon entry to the Plan, which was as soon as administratively feasible. Deferrals started the first day of the first payroll period pursuant to a properly completed and valid salary deferral agreement entered into by the employee. Participants were eligible to share in matching and discretionary contributions for the Plan year upon completing 1,000 hours of service and one year of employment.

Participant Accounts

Participants directed the investment in their accounts among the investment options in the Plan. Each participant's account was credited with the participant contributions, employer contributions, an allocation of investment earnings or losses, and an allocation of administrative expenses. Allocation of investment earnings or losses and administrative expenses was based on the participant's account balance. The benefit to which a participant was entitled was the benefit that can be provided from the participant's account.

Participant Contributions

Active participants made voluntary pre-tax contributions in the form of salary reductions or any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the IRC under Section 403(b). Eligible participants, who attained the age of 50 before the end of the Plan year, were eligible to make catch-up contributions, subject to certain limitations of the IRC.

1. DESCRIPTION OF PLAN (Continued)

Employer Contributions

The Plan agreement provided that the Arc would make matching contributions, net of forfeitures, on behalf of each participant who is eligible, equal to 25% of each participant's deferred compensation up to 2% of compensation, plus 50% of each participant's deferred compensation on the next 1% of compensation. In addition, the Arc contributed a discretionary amount of 3% of eligible participants' compensation.

Vesting

Participants were immediately fully vested in their voluntary contributions and actual earnings (losses) thereon. Participants were vested in employer contributions based on years of credited service. A participant was 100% vested after three years of credited service.

Benefit Payments

Vested benefits were paid to participants when they retired or terminated employment with the Arc, upon attaining early retirement age of 55, or normal retirement age of 65. Payments to beneficiaries were made in a single lump sum distribution.

Forfeitures

Forfeitures of non-vested account balances were used to reduce the Arc's contributions. There were no unallocated forfeitures at November 7, 2022 and December 31, 2021. There were forfeitures of \$2,542 and \$51,226 in 2022 and 2021, respectively.

Participant Rollovers

Participants were allowed to transfer or rollover funds into the Plan subject to approval by the Plan Administrator.

Hardship Withdrawals

Hardship withdrawals from the Plan were permitted from a participant's account. All hardship withdrawals must comply with the rules relating to hardships, which were uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

All investments are participant directed. Purchases and sales of investments are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or one-half of the participant's vested account balances of all Arc plans, subject to a \$1,000 minimum. The \$50,000 maximum amount is reduced by the participant's highest outstanding note receivable balance in the previous twelve months, even if the amount has been repaid. Notes receivable terms range from one to five years, but the Plan Administrator may permit a longer term if the note is for the purchase of a principal residence. The notes are secured by the participant's account. Interest rates on the notes receivable range from 4.25% to 6.50% and are based on prevailing commercial rates for loans of similar types at the date of issuance, as determined by the Plan Administrator.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan documents.

Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is possible that changes in their values could occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Code 820 (ASC 820) establishes a hierarchy for information and valuations used in measuring fair value that is broken down into three levels based on reliability. Level 1 valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan Administrator has the ability to access. Level 2 valuations are based on inputs, other than quoted prices included within Level 1, that are observable, either directly or indirectly. Level 3 valuations are based on information that is unobservable and significant to the overall fair value measurement.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by plan participants as a reduction of investment income.

Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. FAIR VALUE MEASUREMENTS

The Plan's investments are measured at fair value on a recurring basis as follows at December 31, 2021:

4. PARTY-IN-INTEREST TRANSACTIONS

Fidelity is the trustee and custodian of the Plan's assets. Newport provides administration and recordkeeping services to the Plan. As such transactions involving Fidelity and Newport qualify as party-in-interest transactions. Additionally, notes receivable from participants qualify as party-in-interest transactions.

5. INCOME TAX STATUS

The Plan is exempt from federal income tax under Section 403(b) of the Internal Revenue Code. The Plan is required to operate in accordance with the Code in order to maintain its tax-exempt status for Plan participants. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

6. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the period from January 1, 2022 to November 7, 2022 and the year ended December 31, 2021.

7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 7, 2023, which is the date the financial statements were available to be issued.
