**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We were engaged to perform audits of the financial statements of Bethesda Health, Inc. 403(b) Employee Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through December 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 30, 2022 and December 31, 2021, and for the period from January 1, 2022 through December 30, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Disclaimer of opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

**Basis for disclaimer of opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

Further, as described in Note 9 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits, certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the financial

#### **Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### **Auditor's responsibilities for the audit of the financial statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

The supplemental schedule of delinquent participant contributions for the period from January 1, 2022 through December 30, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Bethesda Health, Inc. 403(b) Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering eligible employees of Bethesda Hospital, Inc. (the "Employer" or the "Plan Sponsor"). The purpose of the Plan is to permit contributions to be used to purchase an unallocated annuity contract and invest in mutual funds for the benefit of the participants, as provided for in Section 403(b) of the Internal Revenue Code (the "Code") of 1986, as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective December 30, 2022, the Plan was merged into the Baptist Health South Florida, Inc. 403(b) Employee Retirement Plan, and total assets of \$35,791,185 were transferred out of the Plan. Participants received credit for their service in the Plan for purposes of eligibility and vesting in the Baptist Health South Florida, Inc. 403(b) Employee Retirement Plan.

***Plan Administration***

Transamerica Retirement Solutions (Transamerica or the Recordkeeper) is the recordkeeper for the Plan's assets, and State Street Bank and Trust Company is the Plan's custodian (the Custodian). Transamerica Life Insurance Company (TLIC) is the custodian of the Transamerica Guaranteed Investment Option investment (GIO).

***Contributions***

Effective December 31, 2018, no further contributions to the Plan shall be made and no employees who were not participating in the Plan on or immediately prior to December 31, 2018, are eligible to participate in the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and an allocation of Plan earnings (losses), net of administrative expenses and is charged with his or her withdrawals. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

***Vesting***

Participants are fully vested in their contributions and the earnings thereon.

***Notes Receivable from Participants***

Subject to approval, participants can secure a loan from the Plan against their account balance. Participants can borrow up to a maximum of \$50,000 or 50% of their vested account balances, whichever is less. Loans must normally be repaid within such period as agreed upon between the participant and Employer, up to a maximum of five years unless the loan is for the purpose of purchasing a primary residence which allows a maximum repayment term of 30 years. New loans used to purchase a primary residence allow a maximum repayment term of 15 years. The minimum amount to be borrowed for a loan is \$1,000. Loans must be repaid through automatic payroll deductions, unless otherwise provided by the Employer. Loans are subject

to an interest rate equal to the prime rate. For the period ending December 30, 2022, interest rates ranged from 3.25% to 6.25% on outstanding participant loans.

***Payment of Benefits***

Upon death, retirement, or disability, a participant is entitled to 100% of his or her vested account balance and may elect to receive payment as a lump-sum amount or annuity payment, or a participant may have the vested interest directly rolled over into an eligible retirement plan. If upon termination the value of the participant's vested account balance is less than \$1,000, the Plan will provide a mandatory cash-out distribution. Upon termination of employment, if the value of the participant's vested account balance is greater than \$1,000, the participant may elect a lump-sum amount or annuity payment. Participants may take distributions from the Plan upon attainment of age 59 ½ and also may take distributions before attaining this age for financial hardship.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Plan recordkeeping and custodial fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Certain administrative fees may be paid directly by the Plan through forfeitures or revenue sharing that the Plan receives either directly or indirectly from certain mutual fund investment options held by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

***Payment of Benefits***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value except for the Guaranteed Investment contract, a fully benefit-responsive investment contract, which is stated at contract value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

***Risks and Uncertainties***

The Plan holds various investments which are exposed to risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**NOTE 4 - CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants for the period ended December 30, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company and Transamerica Life Insurance Company. The Custodian certified the money market fund, mutual funds and notes receivable from participants held as of December 31, 2021, and the related net depreciation in fair value of investments, interest and dividends, and interest income on notes receivables for the period from January 1, 2022 through December 30, 2022. TLIC certified the GIO as of December 31, 2022 and the interest income for the period from January 1, 2022 through December 30, 2022.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds and Money Market Fund* - Valued at the net asset value (NAV) of shares held by the Plan at year end as traded in an active market.

As of December 31, 2021, the Plan's investments consisted of money market and mutual funds which were considered Level 1 assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

**NOTE 6 - GROUP ANNUITY CONTRACT**

During 2021, the Plan entered into a fully benefit-responsive investment contract with TLIC. TLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. TLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus applicable interest credited, less previous withdrawals or transfers and administrative charges. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. There are no unfunded commitments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

**NOTE 7 - INCOME TAX STATUS**

The Plan has not received a determination letter from the Internal Revenue Service, but Plan management believes the Plan and related trust is designed and operated in accordance with applicable sections and requirements of the Internal Revenue Code (IRC). Therefore, management believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 30, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by the Custodian and affiliates; therefore, transactions in these investments qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions because they are transacted with plan participants.

**NOTE 9 - PARTICIPANT ANNUITY AND CUSTODIAL ACCOUNTS EXCLUDED FROM THE FINANCIAL STATEMENTS**

The plan administrator has elected to exclude from investments, in the accompanying statements of net assets available for benefits, certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits.

Historical records for accounts issued prior January 1, 2009 were not maintained or are not available at a Plan level. Accordingly, in addition to the excluded accounts noted in the previous paragraph, the Plan may have also excluded from the accompanying financial statements additional annuity and custodial accounts, and related activity, issued to current and former employees prior to January 1, 2009 that should be included in the Plan's financial statements under accounting principles generally accepted in the United States of America. The Plan administrator has determined that the effects of this matter on the Plan's financial statements, if any, is not reasonably determinable.

**NOTE 10 - NONEXEMPT TRANSACTIONS**

Plan contributions from prior years totaling approximately \$29,000 were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 (CFR 2510-102), thus constituting nonexempt transactions between the Plan and the Employer. Management corrected the delinquent participant contributions during 2022.
